1.6	Section 1. Minnesota Statutes 2022, section 10A.01, subdivision 5, is amended to read:
1.7	Subd. 5. Associated business. "Associated business" means an association, corporation,
1.8	partnership, limited liability company, limited liability partnership, or other organized legal
1.9	entity from which the individual or the individual's spouse receives compensation in excess
1.10	of \$250, except for actual and reasonable expenses, in any month during the reporting period
1.11	as a director, officer, owner, member, partner, employer or employee, or whose securities
1.12	the individual or the individual's spouse holds worth more than \$10,000 at fair market value.

(b) The business or professional categories for purposes of paragraph (a), clauses (6)
and (7), must be the general topic headings used by the federal Internal Revenue Service
for purposes of reporting self-employment income on Schedule C. This paragraph does not
require an individual to report any specific code number from that schedule. Any additional
