1.7 designated by the chair of the political party in an annual certification of party units provided
1.8 to the board."

1.9 Page 5, delete section 7 and insert:

1.10 "Sec. 7. Minnesota Statutes 2022, section 10A.275, subdivision 1, is amended to read:

1.11 Subdivision 1. **Exceptions.** Notwithstanding other provisions of this chapter, the
1.12 following expenditures by a party unit, or two or more party units acting together, ~~with at~~
1.13 ~~least one party unit being either: the state committee or the party organization within a~~
1.14 ~~congressional district, county, or legislative district,~~ are not considered contributions to or
1.15 expenditures on behalf of a candidate for the purposes of section 10A.25 or 10A.27 and
1.16 must not be allocated to candidates under section 10A.20, subdivision 3, paragraph (h):

1.17 (1) expenditures on behalf of candidates of that party generally without referring to any
1.18 of them specifically in a published, posted, or broadcast advertisement;

1.19 (2) expenditures for the preparation, display, mailing, or other distribution of an official
1.20 party sample ballot listing the names of three or more individuals whose names are to appear
1.21 on the ballot;

1.22 (3) expenditures for a telephone call, voice mail, text message, multimedia message,
1.23 internet chat message, or email when the communication includes the names of three or
1.24 more individuals whose names are to appear on the ballot;

1.25 (4) expenditures for a political party fundraising effort on behalf of three or more
1.26 candidates; or

1.27 (5) expenditures for party committee staff services that benefit three or more candidates.
