

1.1 Senator moves to amend S.F. No. 2732 as follows:

1.2 Page 2, after line 1, insert:

1.3 "Sec. 2. Minnesota Statutes 2022, section 10A.20, subdivision 5, is amended to read:

1.4 Subd. 5. **Pre-election reports.** (a) Any loan, contribution, or contributions:

1.5 (1) to a political committee or political fund from any one source totaling more than
1.6 \$1,000;

1.7 (2) to the principal campaign committee of a candidate for an appellate court judicial
1.8 office totaling more than \$2,000;

1.9 (3) to the principal campaign committee of a candidate for district court judge totaling
1.10 more than \$400; or

1.11 (4) to the principal campaign committee of a candidate for constitutional office or for
1.12 the legislature totaling more than 50 percent of the election segment contribution limit for
1.13 the office,

1.14 received between the last day covered in the last report before an election and the election
1.15 must be reported to the board in the manner provided in paragraph (b).

1.16 (b) A loan, contribution, or contributions required to be reported to the board under
1.17 paragraph (a) must be reported to the board either:

1.18 (1) in person by the end of the next business day after its receipt; or

1.19 (2) by electronic means sent ~~within 24 hours after its receipt~~ by the end of the next
1.20 business day after its receipt.

1.21 (c) These loans and contributions must also be reported in the next required report.

1.22 (d) This notice requirement does not apply in a primary election to a candidate who is
1.23 unopposed in the primary, in a primary election to a ballot question political committee or
1.24 fund, or in a general election to a candidate whose name is not on the general election ballot.
1.25 The board must post the report on its website by the end of the next business day after it is
1.26 received.

1.27 (e) This subdivision does not apply to a ballot question or independent expenditure
1.28 political committee or fund that has not met the registration threshold of section 10A.14,
1.29 subdivision 1a. However, if a contribution that would be subject to this section triggers the
1.30 registration requirement in section 10A.14, subdivision 1a, then both registration under that
1.31 section and reporting under this section are required."
