1.3	"Section 1. [216C.391] SUPPLEMENTAL ENERGY ASSISTANCE GRANT
1.4	PROGRAM.
1.5	Subdivision 1. Definition. For the purposes of this section, "LIHEAP" means the federal
1.6	Low Income Home Energy Assistance Program, United States Code, title 42, sections 8621
1.7	to 8630, administered by the department.
1.8	Subd. 2. Establishment. A supplemental energy assistance grant program is established
1.9	in the Department of Commerce to award grants to eligible applicants.
1.10	Subd. 3. Applications; procedures. (a) The commissioner must develop policies and
1.11	procedures governing the grant application and award process.
1.12	(b) Eligible applicants must file an application with the commissioner on a form
1.13	developed by the commissioner.
1.14	(c) The commissioner must accept grant applications under this section throughout the
1.15	year.
1.16	Subd. 4. Eligibility. All Minnesota residents whose household income is less than 60
1.17	percent of the state median household income are eligible for a grant awarded under this
1.18	section.
1.19	Subd. 5. Grant awards. (a) When awarding grants under this section, the commissioner
1.20	must give priority to expanding the number of households receiving energy assistance over
1.21	increasing grant amounts to households that already received assistance under LIHEAP
1.22	during the year.
1.23	(b) To the extent practicable, LIHEAP funds must be used, when available, for all primary
1.24	heat and crisis grants to eligible households before grants are awarded for those purposes
1.25	under this section.
1.26	Subd. 6. Account established. A supplemental energy assistance fund account is created
1.27	in the special revenue fund in the state treasury. The commissioner shall credit to the account
1.28	appropriations and transfers to the account. Earnings, such as interest, dividends, and any
1.29	other earnings arising from assets of the account, must be credited to the account. Funds
1.30	remaining in the account at the end of a fiscal year are not canceled to the general fund, but
1.31	remain in the account until expended. The commissioner shall manage the account. Money
1.32	in the account is appropriated to the commissioner to award grants under this section.

3.2	(a) \$100,000,000 in fiscal year 2024 is appropriated from the general fund to the
3.3	commissioner of commerce for deposit in the supplemental energy assistance fund account
3.4	in the special revenue fund. This is a onetime appropriation and is available until June 30,
3.5	<u>2029.</u>
3.6	(b) Of the amount appropriated in paragraph (a):
3.7	(1) up to ten percent may be used to administer the supplemental program under this
3.8	section, of which up to 2.5 percent may be used by the Department of Commerce. The
3.9	remaining amount allocated under this clause may be used to reimburse reasonable
