1.3 "Section 1. Minnesota Statutes 2022, section 84.66, subdivision 7, is amended to read:

1.4 Subd. 7. **Landowner responsibilities.** The commissioner may enroll eligible land in
1.5 the program by signing an easement in recordable form with a landowner in which the
1.6 landowner agrees to:

1.7 (1) convey to the state a permanent easement that is not subject to any prior title, lien,
1.8 or encumbrance, except for preexisting easements that are acceptable to the commissioner;
1.9 and

1.10 (2) manage the land in a manner consistent with the purposes for which the land was
1.11 selected for the program and not convert the land to other uses.

1.12 Sec. 2. **ADDITIONS TO STATE PARKS.**

1.13 Subdivision 1. [85.012] [Subd. 21.] Frontenac State Park, Goodhue County. The
1.14 following area is added to Frontenac State Park, Goodhue County:

1.15 That part of the Southeast Quarter of Section 10, Township 112 North, Range 13 West,
1.16 and that part of the Southwest Quarter of Section 11, Township 112 North, Range 13
1.17 West, Goodhue County, Minnesota, described as follows: Commencing at the northeast

2.11 Township 32, Range 20.

2.12 **Sec. 3. ADDITION TO STATE FOREST.**

2.13 **[89.021] [Subd. 42a.] Riverlands State Forest.** Those parts of St. Louis County described
2.14 as follows are added to Riverlands State Forest:
