Bill Description

Under current statute, Physical Education standards are to be revised beginning in the 2022-23 school year. This bill would delay the review and revision process until the 2026-27 school year.

Assumptions

Delaying the physical education standards review until 2026-27 will provide a potential savings to the department of \$40,000 in FY23, but the cost to review physical education standards will be incurred in FY27 of \$45,000.

20 educators * \$200/day for substitutes * 10 meetings = \$40,000 during FY23

20 educators * \$225/day for substitutes * 10 meetings = \$45,000 during FY27; this assumes an increase in substitute costs consistent with inflation and increases the past 4 years. Since inflation assumptions are not allowed in fiscal notes, \$40,000 is tracked for FY27.
