1.2 **S.F. No. 1955:** A bill for an act relating to state government; establishing a budget for
1.3 the Department of Agriculture, the Board of Animal Health, the Agricultural Utilization
1.4 Research Institute, and the Office of Broadband Development; making policy and technical
1.5 changes to agriculture provisions; making policy and technical changes to broadband
1.6 provisions; providing civil penalties; appropriating money; requiring reports; transferring
1.7 money to the border-to-border broadband fund account; creating the grain indemnity account;
1.8 transferring money to the grain indemnity account; amending Minnesota Statutes 2022,
1.9 sections 17.1016, subdivision 2; 17.133, subdivision 2; 41A.14, subdivision 2; 41A.19;
1.10 116J.395, subdivision 7; 116J.396, subdivision 2; 223.16, by adding a subdivision; 223.17,

1.13 article 2, section 29, subdivision 6; proposing coding for new law in Minnesota Statutes,
1.14 chapters 17; 116J; 223; repealing Minnesota Statutes 2022, sections 17.055, subdivision 2;
1.15 41A.12, subdivision 4; 41A.21; 223.17, subdivisions 4, 8; 232.22, subdivisions 4, 6, 6a, 7.

2.1 "Sec. 4. Minnesota Statutes 2022, section 28A.152, subdivision 2, is amended to read:

2.2 Subd. 2. **Direct sales to consumers.** (a) An individual qualifying for an exemption under
2.3 subdivision 1 may sell the exempt food:

2.4 (1) directly to the ultimate consumer, including but not limited to at a community event
2.5 or farmers' market;

2.6 (2) directly from the individual's home to the ultimate consumer, to the extent allowed
2.7 by local ordinance; or

2.8 (3) through donation to a community event with the purpose of fundraising for an
2.9 individual, or fundraising for an educational, charitable, or religious organization.

2.10 (b) If an exempt food product will be delivered to the ultimate consumer upon sale of
2.11 the food product, the individual who prepared the food product ~~must be the person who~~
2.12 ~~delivers the food product to the ultimate consumer~~ may deliver the food, and the food product
2.13 may be delivered by mail or commercial delivery.

2.14 (c) Food products exempt under subdivision 1, paragraph (a), clause (2), may not be
2.15 sold outside of Minnesota.

2.16 (d) Food products exempt under subdivision 1 may be sold over the Internet ~~but must~~
2.17 ~~be delivered directly to the ultimate consumer by the individual who prepared the food~~
2.18 ~~product.~~ The statement "These products are homemade and not subject to state inspection."
2.19 must be displayed on the website that offers the exempt foods for purchase."
