Bill Description

The bill increases the state aid amount paid from \$5.82 to \$7.00 times the greater of the population of the district or 1,335, and a changes in the equalization factor from .094 to .0498.

The change is effective starting in FY2024.

Assumptions

Minnesota Department of Education (MDE) used the November Forecast to provide breakdown by fiscal year. The November Forecast numbers used the 2020 Census populations from the 2022 levy cycle (FY24 revenue) with the approved changes from districts by the State Demographer's Office. For FY25-FY27 It is predicted the census numbers will increase by .81% annually.

November forecasted data used the 2021 certified ANTC values and projections for 2022 at 15.1%, 2023 at 12.70%, 2024 at 5.80% and 2025-2026 at 4.94%.
