relating to education finance; increasing local optional revenue; linking future 1 2 increases in local optional revenue to the growth in the general education basic 1.3 formula allowance; appropriating money; amending Minnesota Statutes 2022, 1.4 section 126C.10, subdivision 2e. 1.5

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2022, section 126C.10, subdivision 2e, is amended to read:

- Subd. 2e. Local optional revenue. (a) For fiscal year 2021 and later 2023, local optional revenue for a school district equals the sum of the district's first tier local optional revenue and second tier local optional revenue. A district's first tier local optional revenue equals \$300 times the adjusted pupil units of the district for that school year. A district's second tier local optional revenue equals \$424 times the adjusted pupil units of the district for that school year. For fiscal year 2024 and later, a district's local optional revenue equals the local optional allowance times the district's adjusted pupil units for that school year.
- (b) For fiscal year 2021 and later years 2023 and 2024, a district's local optional levy equals the sum of the first tier local optional levy and the second tier local optional levy.
- (c) For fiscal years 2023 and 2024, a district's first tier local optional levy equals the product of \$300, the district's first tier local optional revenue times pupil units for the respective year, and the lesser of one or the ratio of the district's referendum market value per resident pupil unit for that year to \$880,000.
- (d) For fiscal year 2022, a district's second tier local optional levy equals the district's second tier local optional revenue times the lesser of one or the ratio of the district's referendum market value per resident pupil unit to \$510,000. For fiscal year 2023, a district's

- (f) (g) A district's local optional aid equals its local optional revenue minus its local optional levy. If a district's actual levy for first or second tier its local optional revenue is less than its maximum levy limit for that tier, its aid must be proportionately reduced.
- 2.14 (h) The local optional allowance for fiscal year 2024 equals \$840. The local optional
 2.15 revenue for fiscal year 2025 and later equals the local optional revenue allowance for the
 2.16 previous year times the ratio of the general education basic formula allowance for the current
 2.17 year to the general education basic formula allowance for the previous year.
 - **EFFECTIVE DATE.** This section is effective for fiscal year 2024 and later.
