Enabling Statue

Minn. Stat. § 15.0145

Subdv. 6. Duties of council.

"(a) A council must work for the implementation of economic, social, legal, and political equality for its constituency."

Key Provisions:

- > 15-member board
 - > 11 voting members: appointed by Governor, of the community
 - > 4 voting members appointed by legislative leadership, of the legislative body
- ➤ Advise the Governor and the Legislature on issues confronting the constituency of the Council.
- ➤ **Advocate** for administrative and legislative changes needed to improve the economic and social condition of the constituency of the Council.
- > Serve as a liaison between state government and organizations that serve the constituency of the Council.



- > Provides logistical support to Asian-led community-based organizations



The Council's Impact

As a result of the Council's work, Minnesota's Asian Pacific communities are better off for the following:

- > Ensured a more thorough count of APMs during the 2020 Census by creating the API Complete Count Committee
- > Connected APM businesses and individuals to pandemic and civil unrest assistance
- Advocated for legislation to provide funding for gender-based violence prevention, increase teachers of color, support workforce development and small businesses, and address anti-Asian hate
- Led the Afghan Evacuee Community Roundtable to assist with Afghan resettlement
