1.11	(b) Statements by individuals that are provided to the board are private data on
1.12	individuals, as defined by section 13.02, subdivision 12, prior to being admitted into evidence
1.13	at a hearing conducted pursuant to section 179A.13, and become public once admitted into
1.14	evidence.
1.15	(c) The following data are public at all times:
1.16	(1) the filing date of unfair labor practice charges;
1.17	(2) the status of unfair labor practice charges as an original or amended charge;
1.18	(3) the names and job classifications of charging parties and charged parties;
1.19	(4) the provisions of law alleged to have been violated in unfair labor practice charges;
1.20	(5) the complaint issued by the board; and
1.21	(6) unless subject to a protective order:
1.22	(i) the full and complete record of an evidentiary hearing before a hearing officer,
1.23	including the hearing transcript, exhibits admitted into evidence, and posthearing briefs;
1.24	(ii) recommended decisions and orders of hearing officers pursuant to section 179A.13,
1.25	subdivision 1, paragraph (i);
1.26	(iii) exceptions to the hearing officer's recommended decision and order filed with the
