Dear Administrator:

The Minnesota Department of Health, State Rapid Response Team completed a complaint evaluation on October 12, 2022 for the purpose of evaluating and assessing compliance with Minnesota Department of Health Boarding Care Home Rules. At the time of the evaluation the Minnesota Department of Health, State Rapid Response Team, noted one or more violations of these rules that are issued in accordance with Minnesota Statute § 144.653 and/or Minnesota Statute § 144A.10 and/or Minnesota Statute 626.5572.

If, upon a follow-up evaluation, it is found that the violation(s) cited herein are not corrected, a monetary penalty for each violation shall be assessed in accordance with a schedule of fines promulgated by rule of the Minnesota Department of Health.

The State licensing orders are delineated on the attached Minnesota Department of Health state form. The Minnesota Department of Health is documenting the State Licensing Correction Orders using federal software. Tag numbers have been assigned to Minnesota state statutes/rules for Boarding Care Homes.

The assigned tag number appears in the far left column entitled "ID Prefix Tag." The state statute/rule number and the corresponding text of the state statute/rule out of compliance is listed in the "Summary Statement of Deficiencies" column and replaces the "To Comply" portion of the correction order. This column also includes the findings that are in violation of the state statute after the statement, "This Rule is not met as evidenced by." Following the surveyors findings is Time Period For Correction.


