What is an Outdoor AED Smart Monitored Cabinet?



Outdoor: Our vision is that AEDs are accessible to the public 24/7. Oftentimes AEDs are located inside buildings. Placing an AED outdoors and available to the public is key to helping during a Sudden Cardiac Arrest (SCA).

The red box on this cabinet stores and monitors the functionality of the AED and also regulates the temperature.



AED: An Automated External Defibrillator can be used by anyone and can help save a life during SCA. The AED will deliver a shock to a person in SCA only if it detects that it is needed. An AED will not shock a person that does not need it.



Smart: If the door to the red box is opened or the AED is removed, a call center will be alerted of an emergency.



Monitored: Since we want the AED to be available in an outdoor space, it is important to control the temperature of where the AED is stored. Heat and cold could cause an AED not be working properly. Our team is alerted if the temperature is too low or high or loses power.



Cabinet: The stainless steel cabinet that houses the AED is weather-resistant to withstand the elements of all seasons.

What Advocates For Health Does

- Advocates For Health, a certified 501(c)(3) nonprofit organization, believes in making AEDs more accessible to the public 24/7. One of our goals is to identify areas where outdoor public access to an AED would be beneficial. Oftentimes AEDs are locked or not available to the public. Our solution to making AEDs more accessible to the public is to place them in "Outdoor AED Smart Monitored Cabinets." With public access, an AED can be available in the event of an emergency by a bystander until medical help arrives. Statistics show that early intervention with CPR and the use of an AED during a Sudden Cardiac Arrest is critical in survival rates. Our mission is to provide public access to AEDs and also to inform communities of their importance.
- Public access to AEDs is a driving part of our organization. It is also of importance that all AEDS are registered. We register with State and National Registries and Pulse Point for tracking of AED Pad and battery expiration dates. Per AED manufacturers AED pads expire after 2 years and batteries expire after 4 years.
- Our team will work together to collaborate with community leaders to develop an action plan that is unique to the community. Our vision is that when we install "Outdoor AED Smart Monitored cabinets," it benefits the community in multiple ways. These benefits include
 - 1. An AED is available to the public 24/7.
 - 2. The AED is stored in a temperature-controlled, monitored cabinet to ensure the AED is functional when needed.
 - 3. Community members receive training on how to perform CPR and use an AED. One of the goals of this training is to empower someone to take action in their community during an SCA.
 Bystander intervention until emergency services arrive has been proven to help increase the odds of survival.



What Evidence Supports States Laws to Enhance Public Access Defibrillation?

- Over 350,000 people die from Sudden Cardiac Arrest (SCA) each year. (https://www.sca-aware.org/about-sudden-cardiac-arrest/latest-statistics)
- Heart Disease is the leading cause of death in the U.S.A. (https://www.cdc.gov/nchs/fastats/leading-causes-of-death.htm)
- 95% of SCA victims die before they reach the hospital or other source of emergency help.

- The chance of survival without AED is less than 5%.

- Using an AED on a patient in SCA increases the survival rate up to 66.5%.

- Every minute a victim is down due to SCA chance of survival goes down 10% (after 10 minutes survival rate diminishes rapidly).

- Making AEDs available 24/7 increases the chance of obtaining an AED quick enough to save the victim in 4 minutes.
- The cost per SCA death in the U.S. is roughly \$600,000 of economic burden.

- The recommended attributes of a comprehensive PAD program include:
 - Targeted automated external defibrillator (AED) site placement
 - Training anticipated responders
 - Emergency medical services (EMS) coordination
 - Emergency response plans
 - Routine maintenance and testing of AEDs
 - Continuous quality improvement
 - Limited civil liability or qualified immunity

Cardiac Arrest:

An Important Public Health Issue



Cardiac arrest is a public health issue with **widespread incidence** and **severe impact** on human health and well-being. There are several recommended **strategies for prevention** and control.





In 2015, approximately 357,000 people experienced out-of-hospital cardiac arrest (OHCA) in the United States.



Approximately 209,000 people are treated for inhospital cardiac arrest (IHCA) each year.



Mortality: **70%-90%**



Approximately 70%-90% of individuals with OHCA die before reaching the hospital.



Morbidity: Those who survive cardiac arrest are likely to suffer from injury to the brain and nervous system and other physical ailments. Additionally, nearly half of OHCA survivors suffer psychological distress such as anxiety, post traumatic stress disorder, and depression.

Economic Impact



Societal Cost: The estimated burden to society of death from cardiac arrest is 2 million years of life lost for men and 1.3 million years for women, greater than estimates for all individual cancers and most leading causes of death.

Prevention



Early intervention by CPR and defibrillation: Early, high-quality CPR, including compression only CPR, and use of automated external defibrillators (AEDs) immediately following cardiac arrest can reduce morbidity and save lives.



Clinical prevention: For patients at high risk, implantable cardioverter defibrillators and pharmacologic therapies can prevent cardiac arrest.



Other early interventions: Depending on the cause of the cardiac arrest, other interventions such as cold therapy and administering antidote to toxin-related cardiac arrest can reduce mortality and long-term side effects.



What Is Public Health's Role in Cardiac Arrest?

The public health community can implement strategies to prevent and control cardiac arrest. Making progress will require engagement and collaboration between CDC and key partners, including national partners, state programs, researchers, and many others.

Public Health Strategies:




Improved Surveillance

Directing effective cardiac arrest programs requires monitoring of trends over time and across environmental conditions. Improved surveillance could enhance our ability to identify and compare incidence rates, effective treatments, and groups at elevated risk.

Proposed or promising approaches include the following:

- ✓ Develop and implement unique diagnostic codes for out-of-hospital cardiac arrest (OHCA) and in-hospital cardiac arrest (IHCA).
- Support a national registry.



Increasing Public Awareness of Cardiac Arrest, CPR, and AED

Advocacy groups have called for a "culture of action" surrounding cardiac arrest that would require widespread public awareness.

Proposed or promising approaches include the following:

- Raise awareness about the difference between cardiac arrest and heart attack.
- ◆ Educate the community on CPR and AED use.
- → Dispell common myths that cause bystanders to delay intervening in sudden cardiac arrest.



Encouraging Public Access Defibrillation (PAD) Policies that Promote Effective Use of AEDs

Efforts are needed to improve the availability of AEDs, public awareness of their locations, and access to them.

Minnesota Bill Proposal

- 1 Outdoor AED Smart Monitored Cabinet to be placed at all 74 Wayside rests in MN = **74 Total** (See Attachment 1)
- 3 Outdoor AED Smart Monitored Cabinets to be placed at each 76 State parks = **228 total** (See attachment 2)
- 10 Outdoor AED Smart Monitored Cabinets per 87 Counties to be placed at Public Boat Landings in MN = **870 total**
- 2 Outdoor AED Smart Monitored Cabinets per MN school district =
 1,106 total (See attachment 3)
- Total placement **2,278** Outdoor AED Smart Monitored Cabinets
- Asking \$23,795,146 to implement 8-year plan (assumes accessible electrical)

- Stainless Steel cabinet with AED Smart Monitoring system
- AED (Automated External Defibrillator)
- Apple AirTag GPS Tracking
- Installation of cabinet
- Hands-Only CPR/AED Group Instructional Training
- Planning, Mapping, and Site Selection Help
- 8 Years of AED Smart Monitoring, including multi carrier SIM via cell network and connection into emergency response center
- AED/CPR Instructional Poster
- AED Maintenance of Batteries and Pads
- AED Registration with National/State Registries
- Inclusion in County 911 Mapping if available
- 2 Directional Road Signs
- Vinyl Graphics on the front/back of the unit
- Replacement of Pads covered for 8 years
- Replacement of Batteries covered for 8 years

What Advocates For Health has done already

- Advocates For Health has placed 105+ Outdoor AED Monitored Cabinets in Minnesota since the early installations of 2019.
- Success is demonstrated by continuing to install Outdoor AED Smart
 Monitored Cabinets in communities and conducting AED/CPR training.
 Every installation and training continues to raise awareness.
- Every new community we impact feels like a success. One of the greatest success stories came the first time a bystander ran to the outdoor cabinet in their community and grabbed an AED after finding a man unconscious showing signs of SCA. Community members having access to an AED and taking action was a source of pride and inspiration to the team at Advocates For Health. We continue to build a list of success stories and hope to continue to do so!
