Dear Chair Wiklund and Committee Members,

Thank you for the opportunity to share **Lutheran Social Service of Minnesota's support of SF388**. Increased investment in the Homeless Youth Act will strengthen programs that effectively and holistically support the needs of youth experiencing homelessness.

LSS is a provider of essential services across all 87 counties with more than 2,500 employees who serve one in 65 Minnesotans every year. We are committed to innovative, person-centered service delivery that promotes resilience and long-term stability for people in all stages of life. This includes more than 40 years serving youth experiencing homelessness. Currently, LSS supports youth statewide with programs rooted in 41 counties in the following communities and their surrounding areas: Duluth, Brainerd, Willmar, St. Cloud, Mankato, Rochester, and the seven-county metro area.

We are thankful for continued investments in supporting youth statewide. Unfortunately, due to several factors, Minnesota youth who are homeless on their own has continued to increase. Additionally, youth are under-represented in the data as they are often not found inside the shelter system. Young people experiencing homelessness are also disproportionately Black, Indigenous and People of Color (BIPOC) at 73% and youth who identify as LGBTQIA+ at 23%.<sup>1</sup>

The need is much greater than currently available resources. Increasing investment in the continuum of services funded by the Homeless Youth Act will help more youth feel a sense of belonging and have opportunities to confront and cope with past traumas. LSS and other service providers would be able to strengthen a seamless continuum of services for youth that build on their assets and strengths, connect them with supportive adults to ensure stability, and create a future that fulfills their potential.

These programs have demonstrated success and merit further investment. In 2021, 970 youth experiencing homelessness received LSS' services and support across the state. More than 90% of youth leaving a homeless youth shelter or transitional living program exited to a stable living environment.

We believe youth are resilient, full of hope, dreams and potential. They're able to succeed in life despite their histories of abuse, exploitation, neglect or abandonment. **Please support SF388 and increase investment in the Homeless Youth Act.** This is critical to improve access to service, build community connection, and remove barriers to health and well-being for our neighbors. It is also a strong solution
