1.2	Page 20, after line 30, insert:
1.3	"(f) The office shall conduct a study and provide a report on the use and sale of
1.4	cannabinoid products on reservations. For the purposes of this paragraph, "reservation" has
1.5	the meaning given in section 260.755, subdivision 18. At a minimum, the report shall include
1.6	the following information:
1.7	(1) the number of cannabis retailers licensed under section 342.26 present on reservations
1.8	and the number of cannabis retailer licenses applied for on reservations;
1.9	(2) statistics on whether crime rates increased on reservations with cannabis retailers
1.10	licensed under section 342.26, broken down into categories based on type of crime and the
1.11	age of the individual who committed the crime;
1.12	(3) statistics on whether emergency room visits, hospitalizations, and homelessness
1.13	increased on reservations with cannabis retailers licensed under section 342.26;
1.14	(4) statistics on whether the death rate, suicide rate, and attempted suicide rate increased
1.15	on reservations with cannabis retailers licensed under section 342.26;
1.16	(5) the number of murders committed on reservations with cannabis retailers licensed
1.17	under section 342.26;
1.18	(6) the number of American Indians admitted to emergency rooms for symptoms related
1.19	to poisoning from cannabinoid products;
1.20	(7) the number of occurrences where two or more substances are present when American
1.21	Indians are admitted to an emergency room;
1.22	(8) the number of overdoses experienced by American Indians from cannabinoid products;
1.23	(9) the amount of cannabinoid products sold on reservations; and
1.24	(10) the amount of revenue generated by the sale of cannabinoid products on reservations.
1.25	In addition to the office conducting its own study, the office shall contract with an
1.26	independent entity to conduct the study under this paragraph and the independent entity
1.27	shall submit an annual report on its findings to the office. The office shall produce an
1.28	additional report that compares its findings from the study conducted under this paragraph
1.29	to the report produced by the independent entity. The office shall submit three reports to
1.30	the legislature: an annual report on the information the office gathered under this paragraph;
1.31	the annual report produced by the independent entity; and an annual comparison report.

The reports shall be submitted by January 15, 2024, and each January 15 thereafter. The 1.32
