Bill Description

This bill proposes to adopt the 2022 edition of the Facility Guideline Institute (FGI) *Guidelines for Design and Construction of Hospitals* as the physical environment requirements for all licensed hospitals in the state. If MDH decides to update future guidelines, MDH must notify the legislature by January 15 of the year in which the new edition will become effective Following the notice, the new edition must become effective beginning August 1 of that year.

MDH must publish in the State Register the date by which facilities must comply with the updated edition which must not be sooner than six months after publication of the notice in the State Register.

This proposal will also rescind specific physical environment requirements in Minnesota Rules, chapters 4640 and 4645.

Assumptions

As an industry standard, virtually all hospitals and design architects are following the FGI Guidelines for new construction. This bill would standardize the process and allow the department to make these standards affirmative.Implementing the 2022 edition of the Facility Guideline Institute (FGI) *Guidelines for Design and Construction of Hospitals* will create no fiscal burden for MDH.
