

## **S.F. No. 2212 – Department of Health and Department of Human Services Health Policy Provisions (As amended by the A3 amendment)**

**Section 1** is from S.F. 2210 (Wiklund). This bill amends the notification requirements for major spending commitment reviews.

**Section 2** is from S.F. 2105 (Boldon). This bill requires health plans to cover hearing aids for all individuals regardless of age.

**Section 3** is from S.F. 2153 (Mann). This bill amends the use of the all-payer claims database.

**Section 4** is from S.F. 2800 (Kupec), as amended by the A1 and A3 amendments adopted by the committee on March 15. This bill amends the membership of the Rural Health Advisory Committee Expansion.

**Sections 5 and 6** are from S.F. 2112 (Wiklund), as amended by the A1 amendment adopted by the committee on March 15. This bill amends provisions relating to fetal death records and certificate of birth resulting in stillbirth.

**Sections 7-15** are from S.F. 2338 (Morrison), as amended by the A1 amendment adopted by the committee on March 15. This bill includes definitions related to lead service lines and classification of lead status of service lines.

**Sections 16-19, and 100, paragraph (c)**, are from S.F. 2122 (Boldon), as amended by the A2 amendment adopted by the committee on March 15. This bill adopts the Facility Guidelines Institute *Guidelines for Design and Construction of Hospitals* and makes related changes.

**Sections 20-28, and 100, paragraph (a)**, are from S.F. 2340 (Morrison), as amended by the A1 amendment adopted by the committee on March 15. This bill includes provisions relating to renovations and lead hazard reductions.

**Sections 29-39, 42-72, and 100, paragraph (b)**, are from S.F. 2108 (Boldon), as amended by the A1 amendment adopted by the committee on March 15. This bill modifies state laws regulating hearing aids to conform to the federal rule that allows for over-the counter hearing aids.

**Section 40** is from S.F. 2339 (Morrison), as amended by the A1 amendment adopted by the committee on March 15. This bill clarifies the administration of opiate antagonists in schools.

**Section 41** is from S.F. 2048 (Wiklund), as amended by the A1 amendment adopted by the committee on March 15. This bill amends third-party and MDH transport of medical cannabis.

**Sections 73-99 and 100, paragraph (d)**, are from S.F. 2213 (Boldon), as amended by the A1 amendment adopted by the committee on March 2. The grant provisions have been rewritten. This bill establishes grant programs and modifies definitions and application requirements.
