This bill would appropriate \$800,000 in FY24 and FY25 for the purposes of administering grant funding to Minnesota's eight regional EMS programs in accordance with the provisions outlined in the bill.

### **Expenditure and/or Revenue Formula**

Pursuant to 144E.50 5% of these grant funds totaling \$40,000, \$28,000 in salary and \$12,000 in fringe would be retained by the EMSRB for the purposes of administering the grant fund. The remaining \$760,000 would be distributed as grants to the regional EMS programs \$95,000 each.
