Bill Description

This bill would provide grant funding to be disbursed by the EMSRB to Medical Resource Communication Centers (MRCC's) as defined by a new definition in newly created section 144E.53. For FY2024 grants would total \$1,683,000 and for FY2025 \$970,000 would be appropriated for grants.

Administrative expenses of \$50,000 are authorized for FY24 and \$30,000 authorized in FY25. These funds would be used to offset salary and fringe of either existing staff, or potentially a new staff member to oversee the administration of the grants in accordance with state law and Office of Grant Management policies.

Assumptions

This analysis assumes appropriations as outlined in the bill as proposed.

Expenditure and/or Revenue Formula

FY24 Grants: \$1,683,000

FY25 Grants \$970,000

FY24 Administrative Costs: \$50,000 (70% \$35,000 Salary 30% \$15,000 Fringe) to be applied to salaries of individuals administering program

FY25 Administrative Costs: \$30,000 (100% Salary \$30,000) to be applied to salaries of individuals administering the program.

Long-Term Fiscal Considerations

Grant funding is specifically identified with no projected adjustments. No long-term considerations identified at this time.
