#### **Bill Description**

The bill includes a \$500,000 general fund appropriation in fiscal year 2024 and \$500,000 in fiscal year 2025 for the fetal alcohol spectrum disorders prevention grants in Minnesota Statutes, section 145.267.

#### Assumptions

MDH assumes that this \$500,000 appropriation will be added to existing Fetal Alcohol Spectrum Prevention Grants (Minnesota Statutes, section 145.267) in the amount of \$750,000, currently administered by DHS and transferring to MDH on July 1, 2023. Per statute, these funds must be provided to a statewide organization that focuses solely on prevention of and intervention with fetal alcohol spectrum disorders. The grantee must make subgrants to eligible regional collaboratives in rural and urban areas of the state to reduce the incidence of fetal alcohol spectrum disorders and other prenatal drug-related effects in children in Minnesota by identifying and serving pregnant women suspected of or known to use or abuse alcohol or other drugs.

With the additional appropriation, the Fetal Alcohol Spectrum Prevention grant will be amended to include additional funding and scope. Workplans will need to be revised to outline the additional grantee responsibilities and added subgrantee expectations. Budgets will need to be revised describing how the additional \$500,000 will be used.

Based on the department's current experience administering these grants, the department requires staffing of a 0.20 FTE Grants Specialist Sr. to administer the additional funding to the existing grant programs. The Grants Specialist Sr. will execute the amended grant agreements, and work with the grantee to revise and then approve workplans and budgets of the grantee and subgrantees. The Grants Specialist Sr. will monitor expenditures of the grantee and subgrantees and fiscal compliance with grant terms.
