

1.1 Senator moves to amend S.F. No. 1969 as follows:

1.2 Page 2, line 28, after the semicolon, insert "and"

1.3 Page 2, line 29, strike everything after "(13)"

1.4 Page 2, strike lines 30 and 31

1.5 Page 3, lines 1 to 31, delete the new language and strike the old language

1.6 Page 4, delete lines 1 to 4

1.7 Page 4, line 5, strike "(14)"

1.8 Page 4, after line 6, insert:

1.9 "Sec. 3. Minnesota Statutes 2022, section 144G.41, is amended by adding a subdivision
1.10 to read:

1.11 Subd. 1a. **Minimum requirements; required food services.** (a) All assisted living
1.12 facilities must offer to provide or make available at least three nutritious meals daily with
1.13 snacks available seven days per week, according to the recommended dietary allowances
1.14 in the United States Department of Agriculture (USDA) guidelines, including seasonal fresh
1.15 fruit and fresh vegetables. The menus must be prepared at least one week in advance, and
1.16 made available to all residents. The facility must encourage residents' involvement in menu
1.17 planning. Meal substitutions must be of similar nutritional value if a resident refuses a food
1.18 that is served. Residents must be informed in advance of menu changes. Except as provided
1.19 in paragraph (b), food must be prepared and served according to the Minnesota Food Code,
1.20 Minnesota Rules, chapter 4626.

1.21 (b) For an assisted living facility with a licensed capacity of ten or fewer residents:

1.22 (1) notwithstanding Minnesota Rules, part 4626.0033, item A, the facility may share a
1.23 certified food protection manager (CFPM) with another facility or may employ a CFPM on
1.24 a part-time basis;

1.25 (2) Minnesota Rules, parts 4626.0545 and 4626.1375, do not apply;

1.26 (3) notwithstanding Minnesota Rules, part 4626.1070, item A, the facility is not required
1.27 to install a dedicated handwashing sink but may instead elect to designate one well of a
1.28 two-compartment sink as the designated handwashing sink; and

1.29 (4) notwithstanding Minnesota Rules, parts 426.1325, item A, subitem 1, and 4626.1335,
1.30 item A, the facility may have a textured ceiling so long as it is clean and in good repair.

2.1 Sec. 4. Minnesota Statutes 2022, section 144G.41, is amended by adding a subdivision to
2.2 read:

2.3 Subd. 1b. **Minimum requirements; other required services.** All assisted living facilities
2.4 must offer to provide or make available the following services to residents:

2.5 (1) weekly housekeeping;

2.6 (2) weekly laundry service;

2.7 (3) upon the request of the resident, provide direct or reasonable assistance with arranging
2.8 for transportation to medical and social services appointments, shopping, and other recreation,
2.9 and provide the name of or other identifying information about the persons responsible for
2.10 providing this assistance;

2.11 (4) upon the request of the resident, provide reasonable assistance with accessing
2.12 community resources and social services available in the community, and provide the name
2.13 of or other identifying information about persons responsible for providing this assistance;

2.14 (5) provide culturally sensitive programs; and

2.15 (6) have a daily program of social and recreational activities that are based upon individual
2.16 and group interests, physical, mental, and psychosocial needs, and that creates opportunities
2.17 for active participation in the community at large."
