

1.1 **Senator Hoffman from the Committee on Human Services, to which was referred**

1.2 **S.F. No. 1900:** A bill for an act relating to human services; establishing a home and
 1.3 community-based services systemic critical incident review team; clarifying adult foster
 1.4 care and community residential setting licensing provisions; modifying substance use
 1.5 disorder treatment requirements; extending certain councils and committees; clarifying
 1.6 provider-controlled and own-home settings; making technical and conforming changes;
 1.7 clarifying effective dates; repealing obsolete language related to chemical health pilot
 1.8 program; amending Minnesota Statutes 2022, sections 245.462, subdivisions 3, 12; 245.4711,
 1.9 subdivisions 3, 4; 245.477; 245.4835, subdivision 2; 245.4871, subdivisions 3, 19; 245.4873,

 1.15 1; 524.5-104; 524.5-313; Laws 2021, First Special Session chapter 7, article 2, section 17;
 1.16 article 6, section 12; article 11, section 18; article 13, section 43; Laws 2022, chapter 98,
 1.17 article 4, section 37; repealing Minnesota Statutes 2022, sections 254B.13, subdivisions 1,

1.19 Reports the same back with the recommendation that the bill be amended as follows:

1.20 Page 13, line 24, after "and" insert "family" and after the second "of" insert "family"

1.21 Page 13, line 25, after the first "and" insert "family" and delete "or a" and insert ", dual
 1.22 licensure of child foster residence setting and" and before the second "adult" insert "family"

1.23 Page 18, delete section 18

1.24 Page 25, line 16, delete "coordinated service and" and insert "community"

1.25 Page 25, line 29, after "Disabilities" insert "and the Office of the Ombudsman for
 1.26 Long-Term Care"

1.27 Page 41, delete section 38 and insert:

1.28 "Sec. 37. **REPEALER.**

1.29 Minnesota Statutes 2022, sections 254B.13, subdivisions 1, 2, 2a, 4, 5, 6, 7, and 8;
 1.30 254B.16; 256.041, subdivision 10; 256B.49, subdivision 23; and 260.835, subdivision 2,
 1.31 are repealed.

1.32 **EFFECTIVE DATE.** This section is effective the day following final enactment."

1.33 Renumber the sections in sequence

1.34 Amend the title numbers accordingly

1.35 And when so amended the bill do pass and be re-referred to the Committee on Judiciary
 1.36 and Public Safety. Amendments adopted. Report adopted.


