

1.1 **Senator Hoffman from the Committee on Human Services, to which was referred**

1.2 **S.F. No. 2413:** A bill for an act relating to health; aligning home care survey with assisted
1.3 living licensure survey; amending Minnesota Statutes 2022, sections 144A.474, subdivisions
1.4 3, 9, 12; 144A.4791, subdivision 10.

1.5 Reports the same back with the recommendation that the bill be amended as follows:

1.6 Page 1, delete section 1 and insert:

1.7 "Section 1. Minnesota Statutes 2022, section 144A.474, subdivision 3, is amended to read:

1.8 Subd. 3. **Survey process.** The survey process for core surveys shall include the following
1.9 as applicable to the particular licensee and setting surveyed:

1.10 (1) presurvey review of pertinent documents and notification to the ombudsman for
1.11 long-term care;

1.12 (2) an entrance conference with available staff;

1.13 (3) communication with managerial officials or the registered nurse in charge, if available,
1.14 and ongoing communication with key staff throughout the survey regarding information
1.15 needed by the surveyor, clarifications regarding home care requirements, and applicable
1.16 standards of practice;

1.17 (4) presentation of written contact information to the provider about the survey staff
1.18 conducting the survey, the supervisor, and the process for requesting a reconsideration of
1.19 the survey results;

1.20 (5) a brief tour of ~~a sample of the housing with services establishments~~ establishment
1.21 in which the provider is providing home care services;

1.22 (6) a sample selection of home care clients;

1.23 (7) information-gathering through client and staff observations, client and staff interviews,
1.24 and reviews of records, policies, procedures, practices, and other agency information;

1.25 (8) interviews of clients' family members, if available, with clients' consent when the
1.26 client can legally give consent;

1.27 (9) except for complaint surveys conducted by the Office of Health Facilities Complaints,
1.28 an ~~on-site~~ exit conference; with preliminary findings ~~shared and~~ discussed with the provider
1.29 within one business day after completion of survey activities, ~~documentation that an exit~~
1.30 ~~conference occurred~~, and with written information provided on the process for requesting
1.31 a reconsideration of the survey results; and


2.1 (10) postsurvey analysis of findings and formulation of survey results, including
2.2 correction orders when applicable.

2.3 **EFFECTIVE DATE.** This section is effective August 1, 2023."

2.4 Page 4, line 12, strike "the housing with services contract with a housing" and insert
2.5 "any housing contract"

2.6 Page 4, line 13, strike "with services establishment"

2.7 And when so amended the bill do pass. Amendments adopted. Report adopted.
