

1.1 Senator moves to amend S.F. No. 2488 as follows:

1.2 Page 1, delete section 1 and insert:

1.3 "Section 1. **[254B.121] RATE METHODOLOGY; SUBSTANCE USE DISORDER**
1.4 **TREATMENT SERVICES WITH MEDICATIONS FOR OPIOID USE DISORDER.**

1.5 Subdivision 1. **Definition.** For the purposes of this section, "weekly rate" means a single
1.6 payment rate for any contiguous seven-day period during which a service reimbursed under
1.7 this section was provided.

1.8 Subd. 2. **Rates established.** Notwithstanding sections 254B.03, subdivision 9, paragraph
1.9 (a), clause (2); 254B.05, subdivision 5, paragraph (a); and 254B.12, subdivision 1, the
1.10 commissioner shall use the rates in this section for substance use disorder treatment services
1.11 with medications for opioid use disorder under section 254B.05, subdivision 5, paragraph
1.12 (b), clause (6).

1.13 Subd. 3. **Rate updates.** Effective each January 1, the commissioner must update the
1.14 rates for the services specified in this section to equal the corresponding Minnesota specific
1.15 locality adjusted Medicare rates for the same or comparable services.

1.16 Subd. 4. **Nondrug episode of care.** The weekly rate for a nondrug episode of care bundle
1.17 that includes medical assessments; substance use counseling; individual and group therapy;
1.18 and toxicology testing, if performed, is \$194.21.

1.19 Subd. 5. **Methadone component.** The rate for a take-home supply of methadone,
1.20 including up to an additional seven-day supply, is \$39.29.

1.21 Subd. 6. **Methadone bundle.** The weekly rate for the methadone bundle that includes
1.22 dispensing methadone, administering methadone, or both; medical assessments; substance
1.23 use counseling; individual and group therapy; and toxicology testing, if performed, is
1.24 \$244.56.

1.25 Subd. 7. **Naltrexone injectable bundle.** The weekly rate for the naltrexone injectable
1.26 bundle that includes dispensing naltrexone, administering naltrexone, or both; substance
1.27 use counseling; individual and group therapy; and toxicology testing, if performed, is
1.28 \$1,552.69.

1.29 Subd. 8. **Buprenorphine oral component.** The rate for a take-home supply of
1.30 buprenorphine, including up to an additional seven-day supply, is \$80.53.

1.31 Subd. 9. **Buprenorphine oral bundle.** The weekly rate for the buprenorphine oral bundle
1.32 that includes dispensing oral buprenorphine, administering oral buprenorphine, or both;

2.1 medical assessments; substance use counseling; individual and group therapy; and toxicology
2.2 testing, if performed, is \$285.80.

2.3 Subd. 10. **Buprenorphine injectable bundle.** The weekly rate for a buprenorphine
2.4 injectable bundle that includes dispensing injectable buprenorphine, administering injectable
2.5 buprenorphine, or both; substance use counseling; individual and group therapy; and
2.6 toxicology testing, if performed, is \$1,948.22.

2.7 Subd. 11. **Buprenorphine implant insertion bundle.** For a week in which a
2.8 buprenorphine implant is inserted, the bundled weekly rate for the buprenorphine implantation
2.9 and a nondrug episode of care is \$5,403.44.

2.10 Subd. 12. **Buprenorphine implant removal bundle.** For a week in which a
2.11 buprenorphine implant is removed, the bundled weekly rate for the buprenorphine implant
2.12 removal and a nondrug episode of care is \$473.94.

2.13 Subd. 13. **Buprenorphine implantation and removal bundle.** For a week in which a
2.14 buprenorphine implant is both inserted and removed, the bundled weekly rate for the
2.15 buprenorphine implantation, implant removal, and a nondrug episode of care is \$5,634.20.

2.16 Subd. 14. **Intake activity add-on.** For a week in which both substance use disorder
2.17 treatment services with medications for opioid use disorder are provided and intake activities
2.18 occur, the weekly rate add-on for the intake activities is \$188.99.

2.19 Subd. 15. **Periodic assessment add-on.** For a week in which both substance use disorder
2.20 treatment services with medications for opioid use disorder are provided and a periodic
2.21 assessment is conducted, the weekly rate add-on for the periodic assessment is \$116.14.

2.22 Subd. 16. **Additional counseling add-on.** For a week in which both substance use
2.23 disorder treatment services with medications for opioid use disorder are provided and
2.24 additional counseling exceeding the minimum number of minutes required under a bundled
2.25 rate are provided, the weekly rate add-on for each additional 30 minutes of counseling is
2.26 \$32.59.

2.27 **EFFECTIVE DATE.** This section is effective July 1, 2023, and applies to services
2.28 rendered on or after that date."
