HealthForce Minnesota at Winona State University must 1.6 develop a pilot project establishing the Minnesota Direct Care Service Corps. The pilot 1.7 program must utilize financial incentives to attract postsecondary students to work as personal 1.8 1.9 care assistants or direct support professionals.
