




# A useful metaphor







# Joint timeline




#### Incident command team

- DCT has contracted with the Minnesota Hospital Association to consult on development of DCT board language and other health care issues. First draft is near completion.
- DCT has completed three listening sessions with unions, counties, and other stakeholders with good participation, feedback and proposed suggestions.
- DCT has begun dialog with tribes and has an additional meeting set on 11/16/23.
- The majority of DCT's 46 workgroups have begun meeting. One workgroup has completed action items. Eight workgroups have approved task lists, which are being worked on and included in the overall project planning.
