 1.2 **which was referred**

1.3 **S.F. No. 2:** A bill for an act relating to economic development; providing for paid family  
 1.4 and medical leave; appropriating money; amending Minnesota Statutes 2022, sections  
 1.5 13.719, by adding a subdivision; 177.27, subdivision 4; 181.032; 256J.561, by adding a  
 1.6 subdivision; 256J.95, subdivisions 3, 11; 256P.01, subdivision 3; 268.19, subdivision 1;  
 1.7 proposing coding for new law as Minnesota Statutes, chapter 268B.

1.8 Reports the same back with the recommendation that the bill be amended as follows:

1.9 Delete everything after the enacting clause and insert:

1.10 **"ARTICLE 1**

1.11 **FAMILY AND MEDICAL BENEFITS**

1.12 Section 1. Minnesota Statutes 2022, section 13.719, is amended by adding a subdivision  
 1.13 to read:

1.14 Subd. 7. **Family and medical insurance data.** (a) For the purposes of this subdivision,  
 1.15 the terms used have the meanings given them in section 268B.01.

1.16 (b) Data on applicants, family members, or employers under chapter 268B are private  
 1.17 or nonpublic data, provided that the department may share data collected from applicants  
 1.18 with employers or health care providers to the extent necessary to meet the requirements  
 1.19 of chapter 268B or other applicable law.

1.20 (c) The department and the Department of Labor and Industry may share data classified  
 1.21 under paragraph (b) to the extent necessary to meet the requirements of chapter 268B or  
 1.22 the Department of Labor and Industry's enforcement authority over chapter 268B, as provided  
 1.23 in section 177.27.

1.24 **EFFECTIVE DATE.** This section is effective July 1, 2023.

1.25 Sec. 2. Minnesota Statutes 2022, section 177.27, subdivision 4, is amended to read:

1.26 Subd. 4. **Compliance orders.** The commissioner may issue an order requiring an  
 1.27 employer to comply with sections 177.21 to 177.435, 181.02, 181.03, 181.031, 181.032,  
 1.28 181.101, 181.11, 181.13, 181.14, 181.145, 181.15, 181.172, paragraph (a) or (d), 181.275,  
 1.29 subdivision 2a, 181.722, 181.79, ~~and~~ 181.939 to 181.943, 268B.09, subdivisions 1 to 6, and  
 1.30 268B.14, subdivision 3, or with any rule promulgated under section 177.28. The  
 1.31 commissioner shall issue an order requiring an employer to comply with sections 177.41  
 1.32 to 177.435 if the violation is repeated. For purposes of this subdivision only, a violation is  
 1.33 repeated if at any time during the two years that preceded the date of violation, the

2.1 commissioner issued an order to the employer for violation of sections 177.41 to 177.435  
2.2 and the order is final or the commissioner and the employer have entered into a settlement  
2.3 agreement that required the employer to pay back wages that were required by sections  
2.4 177.41 to 177.435. The department shall serve the order upon the employer or the employer's  
2.5 authorized representative in person or by certified mail at the employer's place of business.  
2.6 An employer who wishes to contest the order must file written notice of objection to the  
2.7 order with the commissioner within 15 calendar days after being served with the order. A  
2.8 contested case proceeding must then be held in accordance with sections 14.57 to 14.69.  
2.9 If, within 15 calendar days after being served with the order, the employer fails to file a  
2.10 written notice of objection with the commissioner, the order becomes a final order of the  
2.11 commissioner.

2.13 Sec. 3. Minnesota Statutes 2022, section 181.032, is amended to read:

2.14 **181.032 REQUIRED STATEMENT OF EARNINGS BY EMPLOYER; NOTICE**  
2.15 **TO EMPLOYEE.**

2.16 (a) At the end of each pay period, the employer shall provide each employee an earnings  
2.17 statement, either in writing or by electronic means, covering that pay period. An employer  
2.18 who chooses to provide an earnings statement by electronic means must provide employee  
2.19 access to an employer-owned computer during an employee's regular working hours to  
2.20 review and print earnings statements, and must make statements available for review or  
2.21 printing for a period of three years.

2.22 (b) The earnings statement may be in any form determined by the employer but must  
2.23 include:

2.24 (1) the name of the employee;

2.25 (2) the rate or rates of pay and basis thereof, including whether the employee is paid by  
2.26 hour, shift, day, week, salary, piece, commission, or other method;

2.27 (3) allowances, if any, claimed pursuant to permitted meals and lodging;

2.28 (4) the total number of hours worked by the employee unless exempt from chapter 177;

2.29 (5) the total amount of gross pay earned by the employee during that period;

2.30 (6) a list of deductions made from the employee's pay;

3.1 (7) any amount deducted by the employer under section 268B.14, subdivision 3, and  
3.2 the amount paid by the employer based on the employee's wages under section 268B.14,  
3.3 subdivision 1;

3.4 ~~(7)~~ (8) the net amount of pay after all deductions are made;

3.5 ~~(8)~~ (9) the date on which the pay period ends;

3.6 ~~(9)~~ (10) the legal name of the employer and the operating name of the employer if  
3.7 different from the legal name;

3.8 ~~(10)~~ (11) the physical address of the employer's main office or principal place of business,  
3.9 and a mailing address if different; and

3.10 ~~(11)~~ (12) the telephone number of the employer.

3.11 (c) An employer must provide earnings statements to an employee in writing, rather  
3.12 than by electronic means, if the employer has received at least 24 hours notice from an  
3.13 employee that the employee would like to receive earnings statements in written form. Once  
3.14 an employer has received notice from an employee that the employee would like to receive  
3.15 earnings statements in written form, the employer must comply with that request on an  
3.16 ongoing basis.

3.17 (d) At the start of employment, an employer shall provide each employee a written notice  
3.18 containing the following information:

3.19 (1) the rate or rates of pay and basis thereof, including whether the employee is paid by  
3.20 the hour, shift, day, week, salary, piece, commission, or other method, and the specific  
3.21 application of any additional rates;

3.22 (2) allowances, if any, claimed pursuant to permitted meals and lodging;

3.23 (3) paid vacation, sick time, or other paid time-off accruals and terms of use;

3.24 (4) the employee's employment status and whether the employee is exempt from minimum  
3.25 wage, overtime, and other provisions of chapter 177, and on what basis;

3.26 (5) a list of deductions that may be made from the employee's pay;

3.27 (6) the number of days in the pay period, the regularly scheduled pay day, and the pay  
3.28 day on which the employee will receive the first payment of wages earned;

3.29 (7) the legal name of the employer and the operating name of the employer if different  
3.30 from the legal name;

4.1 (8) the physical address of the employer's main office or principal place of business, and  
4.2 a mailing address if different; and

4.3 (9) the telephone number of the employer.

4.4 (e) The employer must keep a copy of the notice under paragraph (d) signed by each  
4.5 employee acknowledging receipt of the notice. The notice must be provided to each employee  
4.6 in English. The English version of the notice must include text provided by the commissioner  
4.7 that informs employees that they may request, by indicating on the form, the notice be  
4.8 provided in a particular language. If requested, the employer shall provide the notice in the  
4.9 language requested by the employee. The commissioner shall make available to employers  
4.10 the text to be included in the English version of the notice required by this section and assist  
4.11 employers with translation of the notice in the languages requested by their employees.

4.12 (f) An employer must provide the employee any written changes to the information  
4.13 contained in the notice under paragraph (d) prior to the date the changes take effect.

4.14 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
4.15 2025.

4.16 Sec. 4. Minnesota Statutes 2022, section 268.19, subdivision 1, is amended to read:

4.17 Subdivision 1. **Use of data.** (a) Except as provided by this section, data gathered from  
4.18 any person under the administration of the Minnesota Unemployment Insurance Law are  
4.19 private data on individuals or nonpublic data not on individuals as defined in section 13.02,  
4.20 subdivisions 9 and 12, and may not be disclosed except according to a district court order  
4.21 or section 13.05. A subpoena is not considered a district court order. These data may be  
4.22 disseminated to and used by the following agencies without the consent of the subject of  
4.23 the data:

4.24 (1) state and federal agencies specifically authorized access to the data by state or federal  
4.25 law;

4.26 (2) any agency of any other state or any federal agency charged with the administration  
4.27 of an unemployment insurance program;

4.28 (3) any agency responsible for the maintenance of a system of public employment offices  
4.29 for the purpose of assisting individuals in obtaining employment;

4.30 (4) the public authority responsible for child support in Minnesota or any other state in  
4.31 accordance with section 256.978;

4.32 (5) human rights agencies within Minnesota that have enforcement powers;

5.1 (6) the Department of Revenue to the extent necessary for its duties under Minnesota  
5.2 laws;

5.3 (7) public and private agencies responsible for administering publicly financed assistance  
5.4 programs for the purpose of monitoring the eligibility of the program's recipients;

5.5 (8) the Department of Labor and Industry and the Commerce Fraud Bureau in the  
5.6 Department of Commerce for uses consistent with the administration of their duties under  
5.7 Minnesota law;

5.8 (9) the Department of Human Services and the Office of Inspector General and its agents  
5.9 within the Department of Human Services, including county fraud investigators, for  
5.10 investigations related to recipient or provider fraud and employees of providers when the  
5.11 provider is suspected of committing public assistance fraud;

5.12 (10) local and state welfare agencies for monitoring the eligibility of the data subject  
5.13 for assistance programs, or for any employment or training program administered by those  
5.14 agencies, whether alone, in combination with another welfare agency, or in conjunction  
5.15 with the department or to monitor and evaluate the statewide Minnesota family investment  
5.16 program and other cash assistance programs, the Supplemental Nutrition Assistance Program,  
5.17 and the Supplemental Nutrition Assistance Program Employment and Training program by  
5.18 providing data on recipients and former recipients of Supplemental Nutrition Assistance  
5.19 Program (SNAP) benefits, cash assistance under chapter 256, 256D, 256J, or 256K, child  
5.20 care assistance under chapter 119B, or medical programs under chapter 256B or 256L or  
5.21 formerly codified under chapter 256D;

5.22 (11) local and state welfare agencies for the purpose of identifying employment, wages,  
5.23 and other information to assist in the collection of an overpayment debt in an assistance  
5.24 program;

5.25 (12) local, state, and federal law enforcement agencies for the purpose of ascertaining  
5.26 the last known address and employment location of an individual who is the subject of a  
5.27 criminal investigation;

5.28 (13) the United States Immigration and Customs Enforcement has access to data on  
5.29 specific individuals and specific employers provided the specific individual or specific  
5.30 employer is the subject of an investigation by that agency;

5.31 (14) the Department of Health for the purposes of epidemiologic investigations;

5.32 (15) the Department of Corrections for the purposes of case planning and internal research  
5.33 for preprobation, probation, and postprobation employment tracking of offenders sentenced

6.1 to probation and preconfinement and postconfinement employment tracking of committed  
6.2 offenders;

6.3 (16) the state auditor to the extent necessary to conduct audits of job opportunity building  
6.4 zones as required under section 469.3201; ~~and~~

6.5 (17) the Office of Higher Education for purposes of supporting program improvement,  
6.6 system evaluation, and research initiatives including the Statewide Longitudinal Education  
6.7 Data System; and

6.8 (18) the Family and Medical Benefits Division of the Department of Employment and  
6.9 Economic Development to be used as necessary to administer chapter 268B..

6.10 (b) Data on individuals and employers that are collected, maintained, or used by the  
6.11 department in an investigation under section 268.182 are confidential as to data on individuals  
6.12 and protected nonpublic data not on individuals as defined in section 13.02, subdivisions 3  
6.13 and 13, and must not be disclosed except under statute or district court order or to a party  
6.14 named in a criminal proceeding, administrative or judicial, for preparation of a defense.

6.15 (c) Data gathered by the department in the administration of the Minnesota unemployment  
6.16 insurance program must not be made the subject or the basis for any suit in any civil  
6.17 proceedings, administrative or judicial, unless the action is initiated by the department.

6.18 **EFFECTIVE DATE.** This section is effective July 1, 2023.

6.19 Sec. 5. **[268B.01] DEFINITIONS.**

6.20 **Subdivision 1. Scope.** For the purposes of this chapter, the terms defined in this section  
6.21 have the meanings given.

6.22 **Subd. 2. Applicant.** "Applicant" means an individual applying for leave with benefits  
6.23 under this chapter.

6.24 **Subd. 3. Applicant's average weekly wage.** "Applicant's average weekly wage" means  
6.25 an amount equal to the applicant's high quarter wage credits divided by 13.

6.26 **Subd. 4. Base period.** (a) "Base period," unless otherwise provided in this subdivision,  
6.27 means the most recent four completed calendar quarters before the effective date of an  
6.28 applicant's application for family or medical leave benefits if the application has an effective  
6.29 date occurring after the month following the most recent completed calendar quarter. The  
6.30 base period under this paragraph is as follows:

7.1	<u>If the application for family or medical leave</u>	
7.2	<u>benefits is effective on or between these</u>	
7.3	<u>dates:</u>	<u>The base period is the prior:</u>
7.4	<u>February 1 to March 31</u>	<u>January 1 to December 31</u>

7.6	<u>August 1 to September 30</u>	<u>July 1 to June 30</u>
7.7	<u>November 1 to December 31</u>	<u>October 1 to September 30</u>

7.8 (b) If an application for family or medical leave benefits has an effective date that is  
7.9 during the month following the most recent completed calendar quarter, then the base period  
7.10 is the first four of the most recent five completed calendar quarters before the effective date  
7.11 of an applicant's application for family or medical leave benefits. The base period under  
7.12 this paragraph is as follows:

7.13	<u>If the application for family or medical leave</u>	
7.14	<u>benefits is effective on or between these</u>	
7.15	<u>dates:</u>	<u>The base period is the prior:</u>
7.16	<u>January 1 to January 31</u>	<u>October 1 to September 30</u>

7.18	<u>July 1 to July 31</u>	<u>April 1 to March 31</u>
7.19	<u>October 1 to October 31</u>	<u>July 1 to June 30</u>

7.20 (c) Regardless of paragraph (a), a base period of the first four of the most recent five  
7.21 completed calendar quarters must be used if the applicant would have more wage credits  
7.22 under that base period than under a base period of the four most recent completed calendar  
7.23 quarters.

7.24 (d) If the applicant has insufficient wage credits to establish a benefit account under a  
7.25 base period of the four most recent completed calendar quarters, or a base period of the first  
7.26 four of the most recent five completed calendar quarters, but during either base period the  
7.27 applicant received workers' compensation for temporary disability under chapter 176 or a  
7.28 similar federal law or similar law of another state, or if the applicant whose own serious  
7.29 illness caused a loss of work for which the applicant received compensation for loss of  
7.30 wages from some other source, the applicant may request a base period as follows:

7.31 (1) if an applicant was compensated for a loss of work of seven to 13 weeks during a  
7.32 base period referred to in paragraph (a) or (b), then the base period is the first four of the  
7.33 most recent six completed calendar quarters before the effective date of the application for  
7.34 family or medical leave benefits;

7.35 (2) if an applicant was compensated for a loss of work of 14 to 26 weeks during a base  
7.36 period referred to in paragraph (a) or (b), then the base period is the first four of the most

8.1 recent seven completed calendar quarters before the effective date of the application for  
8.2 family or medical leave benefits;

8.3 (3) if an applicant was compensated for a loss of work of 27 to 39 weeks during a base  
8.4 period referred to in paragraph (a) or (b), then the base period is the first four of the most  
8.5 recent eight completed calendar quarters before the effective date of the application for  
8.6 family or medical leave benefits; and

8.7 (4) if an applicant was compensated for a loss of work of 40 to 52 weeks during a base  
8.8 period referred to in paragraph (a) or (b), then the base period is the first four of the most  
8.9 recent nine completed calendar quarters before the effective date of the application for  
8.10 family or medical leave benefits.

8.11 Subd. 5. **Benefit.** "Benefit" or "benefits" means monetary payments under this chapter  
8.12 associated with qualifying bonding, family care, pregnancy, serious health condition,  
8.13 qualifying exigency, or safety leave events, unless otherwise indicated by context.

8.14 Subd. 6. **Benefit account.** "Benefit account" means a benefit account established under  
8.15 section 268B.04.

8.16 Subd. 7. **Benefit year.** "Benefit year" means the period of 52 calendar weeks beginning  
8.17 the date a benefit account under section 268B.04 is effective. For a benefit account established  
8.18 effective any January 1, April 1, July 1, or October 1, the benefit year will be a period of  
8.19 53 calendar weeks.

8.20 Subd. 8. **Bonding.** "Bonding" means time spent by an applicant who is a biological,  
8.21 adoptive, or foster parent with a biological, adopted, or foster child in conjunction with the  
8.22 child's birth, adoption, or placement.

8.23 Subd. 9. **Calendar day.** "Calendar day" or "day" means a fixed 24-hour period  
8.24 corresponding to a single calendar date.

8.25 Subd. 10. **Calendar quarter.** "Calendar quarter" means the period of three consecutive  
8.26 calendar months ending on March 31, June 30, September 30, or December 31.

8.27 Subd. 11. **Calendar week.** "Calendar week" has the same meaning as "week" under  
8.28 subdivision 46.

8.29 Subd. 12. **Commissioner.** "Commissioner" means the commissioner of employment  
8.30 and economic development, unless otherwise indicated by context.

8.31 Subd. 13. **Covered employment.** (a) "Covered employment" means performing services  
8.32 of whatever nature, unlimited by the relationship of master and servant as known to the



9.1 common law, or any other legal relationship performed for wages or under any contract  
9.2 calling for the performance of services, written or oral, express or implied.

9.3 (b) "Covered employment" includes an individual's entire service performed within or  
9.4 without or both within and without this state, if:

9.5 (1) the service is localized in this state; or

9.6 (2) the service is not localized in any state, but some of the service is performed in this  
9.7 state and:

9.8 (i) the base of operations of the employee is in the state, or if there is no base of  
9.9 operations, then the place from which such service is directed or controlled is in this state;  
9.10 or

9.11 (ii) the base of operations or place from which such service is directed or controlled is  
9.12 not in any state in which some part of the service is performed, but the individual's residence  
9.13 is in this state.

9.14 (c) "Covered employment" does not include:

9.15 (1) a self-employed individual; or

9.16 (2) an independent contractor.

9.17 Subd. 14. **Department.** "Department" means the Department of Employment and  
9.18 Economic Development, unless otherwise indicated by context.

9.19 Subd. 15. **Employee.** (a) "Employee" means an individual who performs services of  
9.20 whatever nature for an employer.

9.21 (b) Employee does not include employees of the United States of America, self-employed  
9.22 individuals, or independent contractors.

9.23 Subd. 16. **Employer.** (a) "Employer" means:

9.24 (1) any person, type of organization, or entity, including any partnership, association,  
9.25 trust, estate, joint stock company, insurance company, limited liability company, or  
9.26 corporation, whether domestic or foreign, or the receiver, trustee in bankruptcy, trustee, or  
9.27 the legal representative of a deceased person, having any individual in covered employment;

9.28 (2) the state, state agencies, Minnesota State Colleges and Universities, University of  
9.29 Minnesota, and other statewide public systems; and

9.30 (3) any municipality or local government entity, including but not limited to a county,  
9.31 city, town, school district, Metropolitan Council, Metropolitan Airports Commission, housing

10.1 and redevelopment authority, port authority, economic development authority, sports facilities  
10.2 authority, joint powers board or organization created under section 471.59, destination  
10.3 medical center corporation, municipal corporation, quasimunicipal corporation, or other  
10.4 political subdivision. An employer also includes charter schools.

10.5 (b) Employer does not include:

10.6 (1) the United States of America; or

10.7 (2) a self-employed individual who has elected and been approved for coverage under  
10.8 section 268B.11 with regard to the self-employed individual's own coverage and benefits.

10.9 Subd. 17. **Estimated self-employment income.** "Estimated self-employment income"  
10.10 means a self-employed individual's average net earnings from self-employment in the two  
10.11 most recent taxable years. For a self-employed individual who had net earnings from  
10.12 self-employment in only one of the years, the individual's estimated self-employment income  
10.13 equals the individual's net earnings from self-employment in the year in which the individual  
10.14 had net earnings from self-employment.

10.15 Subd. 18. **Family and medical benefit insurance account.** "Family and medical benefit  
10.16 insurance account" means the family and medical benefit insurance account in the special  
10.17 revenue fund in the state treasury under section 268B.02.

10.18 Subd. 19. **Family and medical benefit insurance enforcement account.** "Family and  
10.19 medical benefit insurance enforcement account" means the family and medical benefit  
10.20 insurance enforcement account in the state treasury under section 268B.185.

10.21 Subd. 20. **Family benefit program.** "Family benefit program" means the program  
10.22 administered under this chapter for the collection of premiums and payment of benefits  
10.23 related to family care, bonding, safety leave, and leave related to a qualifying exigency.

10.24 Subd. 21. **Family care.** "Family care" means an applicant caring for a family member  
10.25 with a serious health condition or caring for a family member who is a covered service  
10.26 member.

10.27 Subd. 22. **Family member.** (a) "Family member" means, with respect to an applicant:

10.28 (1) a spouse, including a domestic partner in a civil union or other registered domestic  
10.29 partnership recognized by the state, and a spouse's parent;

10.30 (2) a child and a child's spouse;

10.31 (3) a parent and a parent's spouse;

10.32 (4) a sibling and a sibling's spouse;

11.1 (5) a grandparent, a grandchild, or a spouse of a grandparent or grandchild; and

11.2 (6) any other individual who is related by blood or affinity and whose association with  
 11.3 the applicant is equivalent of a family relationship. For the purposes of this clause, with  
 11.4 respect to an applicant, this includes but is not limited to:

11.5 (i) a child of a sibling of the applicant;

11.6 (ii) a sibling of the parents of the applicant; and

11.7 (iii) a child-in-law, a parent-in-law, a sibling-in-law, and a grandparent-in-law.

11.8 (b) For the purposes of this chapter, a child includes a stepchild; biological, adopted, or  
 11.9 foster child of the applicant; or a child for whom the applicant is standing or stood in loco  
 11.10 parentis.

11.11 (c) For the purposes of this chapter, a grandchild includes a stepgrandchild or biological,  
 11.12 adopted, or foster grandchild of the applicant.

11.13 (d) For purposes of this chapter, a parent includes a stepparent; biological, adoptive, or  
 11.14 foster parent of the applicant; a legal guardian; or an individual who stood in loco parentis  
 11.15 to the applicant.

11.16 (e) For purposes of this chapter, a grandparent includes a stepgrandparent or biological,  
 11.17 adoptive, or foster grandparent of the applicant.

11.18 Subd. 23. **Health care provider.** "Health care provider" means:

11.19 (1) an individual who is licensed, certified, or otherwise authorized under law to practice  
 11.20 in the individual's scope of practice as a physician, physician assistant, osteopath, surgeon,  
 11.21 or advanced practice registered nurse; or

11.22 (2) any other individual determined by the commissioner by rule, in accordance with  
 11.23 the rulemaking procedures in the Administrative Procedure Act, to be capable of providing  
 11.24 health care services.

11.25 Subd. 24. **High quarter.** "High quarter" means the calendar quarter in an applicant's  
 11.26 base period with the highest amount of wage credits.

11.27 Subd. 25. **Incapacity.** "Incapacity" means inability to perform regular work, attend  
 11.28 school, or fully perform other regular daily activities due to a serious health condition,  
 11.29 treatment therefore, or recovery therefrom.

11.30 Subd. 26. **Independent contractor.** If there is an existing specific test or definition for  
 11.31 independent contractor in Minnesota statute or rule applicable to an occupation or sector

12.1 as of the date of enactment of this chapter, that test or definition shall apply to that occupation  
12.2 or sector for purposes of this chapter. If there is not an existing test or definition as described,  
12.3 the definition for independent contractor shall be as provided in Minnesota Rules, part  
12.4 5200.0221.

12.5 Subd. 27. **Inpatient care.** "Inpatient care" means an overnight stay in a hospital, hospice,  
12.6 or residential medical care facility, including any period of incapacity, or any subsequent  
12.7 treatment in connection with such inpatient care.

12.8 Subd. 28. **Maximum weekly benefit amount.** "Maximum weekly benefit amount"  
12.9 means the state's average weekly wage as calculated under section 268.035, subdivision 23.

12.10 Subd. 29. **Medical benefit program.** "Medical benefit program" means the program  
12.11 administered under this chapter for the collection of premiums and payment of benefits  
12.12 related to an applicant's serious health condition or pregnancy.

12.13 Subd. 30. **Net earnings from self-employment.** "Net earnings from self-employment"  
12.14 has the meaning given in section 1402 of the Internal Revenue Code, as defined in section  
12.15 290.01, subdivision 31.

12.16 Subd. 31. **Pregnancy.** "Pregnancy" includes prenatal care or incapacity due to pregnancy  
12.17 or recovery from childbirth, still birth, miscarriage, or related health conditions.

12.18 Subd. 32. **Qualifying exigency.** (a) "Qualifying exigency" means a need arising out of  
12.19 a military member's active duty service or notice of an impending call or order to active  
12.20 duty in the United States armed forces, including providing for the care or other needs of  
12.21 the family member's child or other dependent, making financial or legal arrangements for  
12.22 the family member, attending counseling, attending military events or ceremonies, spending  
12.23 time with the family member during a rest and recuperation leave or following return from  
12.24 deployment, or making arrangements following the death of the military member.

12.25 (b) For the purposes of this chapter, a "military member" means a current or former  
12.26 member of the United States armed forces, including a member of the National Guard or  
12.27 reserves, who, except for a deceased military member, is a resident of the state and is a  
12.28 family member of the applicant taking leave related to the qualifying exigency.

12.29 Subd. 33. **Safety leave.** "Safety leave" means leave from work because of domestic  
12.30 abuse, sexual assault, or stalking of the applicant or applicant's family member, provided  
12.31 the leave is to:

12.32 (1) seek medical attention related to the physical or psychological injury or disability  
12.33 caused by domestic abuse, sexual assault, or stalking;

- 13.1 (2) obtain services from a victim services organization;
- 13.2 (3) obtain psychological or other counseling;
- 13.3 (4) seek relocation due to the domestic abuse, sexual assault, or stalking; or
- 13.4 (5) seek legal advice or take legal action, including preparing for or participating in any
- 13.5 civil or criminal legal proceeding related to, or resulting from, the domestic abuse, sexual
- 13.6 assault, or stalking.

13.7 Subd. 34. **Self-employed individual.** "Self-employed individual" means a resident of

13.8 the state who, in one of the two taxable years preceding the current calendar year, derived

13.9 at least 5.3 percent of the state's average annual wage in net earnings from self-employment

13.10 from an entity other than an S corporation for the performance of services in this state.

13.11 Subd. 35. **Self-employment premium base.** "Self-employment premium base" means

13.12 the lesser of:

13.13 (1) a self-employed individual's estimated self-employment income for the calendar year

13.14 plus the individual's self-employment wages in the calendar year; or

13.15 (2) the maximum earnings subject to the FICA Old-Age, Survivors, and Disability

13.16 Insurance tax in the taxable year.

13.17 Subd. 36. **Self-employment wages.** "Self-employment wages" means the amount of

13.18 wages that a self-employed individual earned in the calendar year from an entity from which

13.19 the individual also received net earnings from self-employment.

13.20 Subd. 37. **Serious health condition.** (a) "Serious health condition" means a physical or

13.21 mental illness, injury, impairment, condition, or substance use disorder that involves:

13.22 (1) at-home care or inpatient care in a hospital, hospice, or residential medical care

13.23 facility, including any period of incapacity; or

13.24 (2) continuing treatment or supervision by a health care provider which includes any

13.25 one or more of the following:

13.26 (i) a period of incapacity of more than three consecutive, full calendar days, and any

13.27 subsequent treatment or period of incapacity relating to the same condition, that also involves:

13.28 (A) treatment two or more times by a health care provider or by a provider of health

13.29 care services under orders of, or on referral by, a health care provider; or

13.30 (B) treatment by a health care provider on at least one occasion that results in a regimen

13.31 of continuing treatment under the supervision of the health care provider;

- 14.1 (ii) a period of incapacity due to pregnancy;
- 14.2 (iii) a period of incapacity or treatment for a chronic health condition that:
- 14.3 (A) requires periodic visits, defined as at least twice a year, for treatment by a health
- 14.4 care provider or under orders of, or on referral by, a health care provider;
- 14.5 (B) continues over an extended period of time, including recurring episodes of a single
- 14.6 underlying condition; and
- 14.7 (C) may cause episodic rather than continuing periods of incapacity;
- 14.8 (iv) a period of incapacity which is permanent or long term due to a condition for which
- 14.9 treatment may not be effective. The applicant or family member must be under the continuing
- 14.10 supervision of, but need not be receiving active treatment by, a health care provider; or
- 14.11 (v) a period of absence to receive multiple treatments, including any period of recovery
- 14.12 from the treatments, by a health care provider or by a provider of health care services under
- 14.13 orders of, or on referral by, a health care provider, for:
- 14.14 (A) restorative surgery after an accident or other injury; or
- 14.15 (B) a condition that would likely result in a period of incapacity of more than three
- 14.16 consecutive, full calendar days in the absence of medical intervention or treatment.
- 14.17 (b) For the purposes of paragraph (a), clauses (1) and (2), treatment by a health care
- 14.18 provider means an in-person visit or telemedicine visit with a health care provider, or by a
- 14.19 provider of health care services under orders of, or on referral by, a health care provider.
- 14.20 (c) For the purposes of paragraph (a), treatment includes but is not limited to examinations
- 14.21 to determine if a serious health condition exists and evaluations of the condition.
- 14.22 (d) Absences attributable to incapacity under paragraph (a), clause (2), item (ii) or (iii),
- 14.23 qualify for leave under this chapter even if the applicant or the family member does not
- 14.24 receive treatment from a health care provider during the absence, and even if the absence
- 14.25 does not last more than three consecutive, full calendar days.
- 14.26 Subd. 38. **State's average weekly wage.** "State's average weekly wage" means the
- 14.27 weekly wage calculated under section 268.035, subdivision 23.
- 14.28 Subd. 39. **Supplemental benefit payment.** (a) "Supplemental benefit payment" means:
- 14.29 (1) a payment made by an employer to an employee as salary continuation or as paid
- 14.30 time off. Such a payment must be in addition to any family or medical leave benefits the
- 14.31 employee is receiving under this chapter; and

15.1 (2) a payment offered by an employer to an employee who is taking leave under this  
15.2 chapter to supplement the family or medical leave benefits the employee is receiving.

15.3 (b) Employers may, but are not required to, designate certain benefits including but not  
15.4 limited to salary continuation, vacation leave, sick leave, or other paid time off as a  
15.5 supplemental benefit payment.

15.6 (c) Nothing in this chapter requires an employee to receive supplemental benefit  
15.7 payments.

15.8 Subd. 40. **Taxable year.** "Taxable year" has the meaning given in section 290.01,  
15.9 subdivision 9.

15.10 Subd. 41. **Taxable wages.** "Taxable wages" means those wages paid to an employee in  
15.11 covered employment each calendar year up to an amount equal to the maximum wages  
15.12 subject to premium in a calendar year, which is equal to the maximum earnings in that year  
15.13 subject to the FICA Old-Age, Survivors, and Disability Insurance tax rounded to the nearest  
15.14 \$1,000.

15.15 Subd. 42. **Typical workweek hours.** "Typical workweek hours" means:

15.16 (1) for an hourly employee, the average number of hours worked per week by an  
15.17 employee within the high quarter during the base year; or

15.18 (2) 40 hours for a salaried employee, regardless of the number of hours the salaried  
15.19 employee typically works.

15.20 Subd. 43. **Wage credits.** "Wage credits" means the amount of wages paid within an  
15.21 applicant's base period for covered employment, as defined in subdivision 13.

15.22 Subd. 44. **Wage detail report.** "Wage detail report" means the report on each employee  
15.23 in covered employment required from an employer on a calendar quarter basis under section  
15.24 268B.12.

15.25 Subd. 45. **Wages.** (a) "Wages" means all compensation for employment, including  
15.26 commissions; bonuses, awards, and prizes; severance payments; standby pay; vacation and  
15.27 holiday pay; back pay as of the date of payment; tips and gratuities paid to an employee by  
15.28 a customer of an employer and accounted for by the employee to the employer; sickness  
15.29 and accident disability payments, except as otherwise provided in this subdivision; and the  
15.30 cash value of housing, utilities, meals, exchanges of services, and any other goods and  
15.31 services provided to compensate an employee, except:

16.1 (1) the amount of any payment made to, or on behalf of, an employee under a plan  
16.2 established by an employer that makes provision for employees generally or for a class or  
16.3 classes of employees, including any amount paid by an employer for insurance or annuities,  
16.4 or into a plan, to provide for a payment, on account of (i) retirement, (ii) medical and  
16.5 hospitalization expenses in connection with sickness or accident disability, or (iii) death;

16.6 (2) the payment by an employer of the tax imposed upon an employee under United  
16.7 States Code, title 26, section 3101 of the Federal Insurance Contribution Act, with respect  
16.8 to compensation paid to an employee for domestic employment in a private household of  
16.9 the employer or for agricultural employment;

16.10 (3) any payment made to, or on behalf of, an employee or beneficiary (i) from or to a  
16.11 trust described in United States Code, title 26, section 401(a) of the federal Internal Revenue  
16.12 Code, that is exempt from tax under section 501(a) at the time of the payment unless the  
16.13 payment is made to an employee of the trust as compensation for services as an employee  
16.14 and not as a beneficiary of the trust, or (ii) under or to an annuity plan that, at the time of  
16.15 the payment, is a plan described in section 403(a);

16.16 (4) the value of any special discount or markdown allowed to an employee on goods  
16.17 purchased from or services supplied by the employer where the purchases are optional and  
16.18 do not constitute regular or systematic payment for services;

16.19 (5) customary and reasonable directors' fees paid to individuals who are not otherwise  
16.20 employed by the corporation of which they are directors;

16.21 (6) the payment to employees for reimbursement of meal expenses when employees are  
16.22 required to perform work after their regular hours;

16.23 (7) the payment into a trust or plan for purposes of providing legal or dental services if  
16.24 provided for all employees generally or for a class or classes of employees;

16.25 (8) the value of parking facilities provided or paid for by an employer, in whole or in  
16.26 part, if provided for all employees generally or for a class or classes of employees;

16.27 (9) royalties to an owner of a franchise, license, copyright, patent, oil, mineral, or other  
16.28 right;

16.29 (10) advances or reimbursements for traveling or other ordinary and necessary expenses  
16.30 incurred or reasonably expected to be incurred in the business of the employer. Traveling  
16.31 and other reimbursed expenses must be identified either by making separate payments or  
16.32 by specifically indicating the separate amounts where both wages and expense allowances  
16.33 are combined in a single payment;



17.1 (11) residual payments to radio, television, and similar artists that accrue after the  
17.2 production of television commercials, musical jingles, spot announcements, radio  
17.3 transcriptions, film soundtracks, and similar activities;

17.4 (12) the income to a former employee resulting from the exercise of a nonqualified stock  
17.5 option;

17.6 (13) supplemental unemployment benefit payments under a plan established by an  
17.7 employer, if the payment is not wages under the Federal Unemployment Tax Act. The  
17.8 payments are wages unless made solely for the supplementing of weekly state or federal  
17.9 unemployment benefits. Supplemental unemployment benefit payments may not be assigned,  
17.10 nor may any consideration be required from the applicant, other than a release of claims in  
17.11 order to be excluded from wages;

17.12 (14) sickness or accident disability payments made by the employer after the expiration  
17.13 of six calendar months following the last calendar month that the individual worked for the  
17.14 employer;

17.15 (15) disability payments made under the provisions of any workers' compensation law;

17.16 (16) sickness or accident disability payments made by a third-party payer such as an  
17.17 insurance company; or

17.18 (17) payments made into a trust fund, or for the purchase of insurance or an annuity, to  
17.19 provide for sickness or accident disability payments to employees under a plan or system  
17.20 established by the employer that provides for the employer's employees generally or for a  
17.21 class or classes of employees.

17.22 (b) Nothing in this subdivision excludes from the term "wages" any payment made under  
17.23 any type of salary reduction agreement, including payments made under a cash or deferred  
17.24 arrangement and cafeteria plan, as defined in United States Code, title 26, sections 401(k)  
17.25 and 125 of the federal Internal Revenue Code, to the extent that the employee has the option  
17.26 to receive the payment in cash.

17.27 (c) Wages includes the total payment to the operator and supplier of a vehicle or other  
17.28 equipment where the payment combines compensation for personal services as well as  
17.29 compensation for the cost of operating and hiring the equipment in a single payment. This  
17.30 paragraph does not apply if:

17.31 (1) there is a preexisting written agreement providing for allocation of specific amounts;  
17.32 or

18.1 (2) at the time of each payment there is a written acknowledgment indicating the separate  
18.2 allocated amounts.

18.3 (d) Wages includes payments made for services as a caretaker. Unless there is a contract  
18.4 or other proof to the contrary, compensation is considered as being equally received by a  
18.5 married couple where the employer makes payment to only one spouse, or by all tenants of  
18.6 a household who perform services where two or more individuals share the same dwelling  
18.7 and the employer makes payment to only one individual.

18.8 (e) Wages includes payments made for services by a migrant family. Where services  
18.9 are performed by a married couple or a family and an employer makes payment to only one  
18.10 individual, each worker is considered as having received an equal share of the compensation  
18.11 unless there is a contract or other proof to the contrary.

18.12 (f) Wages includes advances or draws against future earnings, when paid, unless the  
18.13 payments are designated as a loan or return of capital on the books and records of the  
18.14 employer at the time of payment.

18.15 (g) Wages includes payments made by a subchapter "S" corporation, as organized under  
18.16 the Internal Revenue Code, to or on behalf of officers and shareholders that are reasonable  
18.17 compensation for services performed for the corporation.

18.18 For a subchapter "S" corporation, wages does not include:

18.19 (1) a loan for business purposes to an officer or shareholder evidenced by a promissory  
18.20 note signed by an officer before the payment of the loan proceeds and recorded on the books  
18.21 and records of the corporation as a loan to an officer or shareholder;

18.22 (2) a repayment of a loan or payment of interest on a loan made by an officer to the  
18.23 corporation and recorded on the books and records of the corporation as a liability;

18.24 (3) a reimbursement of reasonable corporation expenses incurred by an officer and  
18.25 documented by a written expense voucher and recorded on the books and records of the  
18.26 corporation as corporate expenses; and

18.27 (4) a reasonable lease or rental payment to an officer who owns property that is leased  
18.28 or rented to the corporation.

18.29 Subd. 46. **Wages paid.** (a) "Wages paid" means the amount of wages:

18.30 (1) that have been actually paid; or

18.31 (2) that have been credited to or set apart so that payment and disposition is under the  
18.32 control of the employee.

19.1 (b) Wage payments delayed beyond the regularly scheduled pay date are wages paid on  
19.2 the missed pay date. Back pay is wages paid on the date of actual payment. Any wages  
19.3 earned but not paid with no scheduled date of payment are wages paid on the last day of  
19.4 employment.

19.5 (c) Wages paid does not include wages earned but not paid except as provided for in  
19.6 this subdivision.

19.7 Subd. 47. **Week.** "Week" means calendar week ending at midnight Saturday.

19.8 Subd. 48. **Weekly benefit amount.** "Weekly benefit amount" means the amount of  
19.9 family and medical leave benefits computed under section 268B.04.

19.10 **EFFECTIVE DATE.** This section is effective July 1, 2023.

19.11 Sec. 6. **[268B.02] FAMILY AND MEDICAL BENEFIT INSURANCE PROGRAM**  
19.12 **CREATION.**

19.13 Subdivision 1. **Creation.** A family and medical benefit insurance program is created to  
19.14 be administered by the commissioner according to the terms of this chapter.

19.15 Subd. 2. **Creation of division.** A Family and Medical Benefit Insurance Division is  
19.16 created within the department under the authority of the commissioner. The commissioner  
19.17 shall appoint a director of the division. The division shall administer and operate the benefit  
19.18 program under this chapter.

19.19 Subd. 3. **Rulemaking.** The commissioner shall adopt rules to implement the provisions  
19.20 of this chapter. For the purposes of this chapter, the commissioner may use the expedited  
19.21 rulemaking process under section 14.389.

19.22 Subd. 4. **Account creation; appropriation.** The family and medical benefit insurance  
19.23 account is created in the special revenue fund in the state treasury. Money in this account  
19.24 is appropriated to the commissioner to pay benefits under and to administer this chapter,  
19.25 including outreach required under section 268B.18.

19.26 Subd. 5. **Information technology services and equipment.** The department is exempt  
19.27 from the provisions of section 16E.016 for the purposes of this chapter.

19.28 **EFFECTIVE DATE.** This section is effective July 1, 2023.

20.1 **Sec. 7. [268B.03] PAYMENT OF BENEFITS.**

20.2 Subdivision 1. **Requirements.** The commissioner must pay benefits from the family  
20.3 and medical benefit insurance account as provided under this chapter to an applicant who  
20.4 has met each of the following requirements:

20.5 (1) the applicant has filed an application for benefits and established a benefit account  
20.6 in accordance with section 268B.04;

20.7 (2) the applicant has met all of the ongoing eligibility requirements under section  
20.8 268B.06;

20.9 (3) the applicant does not have an outstanding overpayment of family or medical leave  
20.10 benefits, including any penalties or interest;

20.11 (4) the applicant has not been held ineligible for benefits under section 268.07, subdivision  
20.12 2; and

20.13 (5) the applicant is not employed exclusively by a private plan employer and has wage  
20.14 credits during the base year attributable to employers covered under the state family and  
20.15 medical leave program.

20.16 Subd. 2. **Benefits paid from state funds.** Benefits are paid from state funds and are not  
20.17 considered paid from any special insurance plan, nor as paid by an employer. An application  
20.18 for family or medical leave benefits is not considered a claim against an employer but is  
20.19 considered a request for benefits from the family and medical benefit insurance account.  
20.20 The commissioner has the responsibility for the proper payment of benefits regardless of  
20.21 the level of interest or participation by an applicant or an employer in any determination or  
20.22 appeal. An applicant's entitlement to benefits must be determined based upon that information  
20.23 available without regard to a burden of proof. Any agreement between an applicant and an  
20.24 employer is not binding on the commissioner in determining an applicant's entitlement.  
20.25 There is no presumption of entitlement or nonentitlement to benefits.

20.26 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
20.27 2025.

20.28 **Sec. 8. [268B.04] BENEFIT ACCOUNT; BENEFITS.**

20.29 Subdivision 1. **Application for benefits; determination of benefit account.** (a) An  
20.30 application for benefits may be filed in person, by mail, or by electronic transmission as the  
20.31 commissioner may require. The applicant must include certification supporting a request  
20.32 for leave under this chapter. The applicant must meet eligibility requirements at the time

21.1 the application is filed and must provide all requested information in the manner required.  
21.2 If the applicant does not meet eligibility at the time of the application or fails to provide all  
21.3 requested information, the communication is not an application for family and medical leave  
21.4 benefits.

21.5 (b) The commissioner must examine each application for benefits to determine the base  
21.6 period and the benefit year, and based upon all the covered employment in the base period  
21.7 the commissioner must determine the weekly benefit amount available, if any, and the  
21.8 maximum amount of benefits available, if any. The determination, which is a document  
21.9 separate and distinct from a document titled a determination of eligibility or determination  
21.10 of ineligibility, must be titled determination of benefit account. A determination of benefit  
21.11 account must be sent to the applicant and all base period employers, by mail or electronic  
21.12 transmission.

21.13 (c) If a base period employer did not provide wage detail information for the applicant  
21.14 as required under section 268B.12, the commissioner may accept an applicant certification  
21.15 of wage credits, based upon the applicant's records, and issue a determination of benefit  
21.16 account.

21.17 (d) The commissioner may, at any time within 24 months from the establishment of a  
21.18 benefit account, reconsider any determination of benefit account and make an amended  
21.19 determination if the commissioner finds that the wage credits listed in the determination  
21.20 were incorrect for any reason. An amended determination of benefit account must be  
21.21 promptly sent to the applicant and all base period employers, by mail or electronic  
21.22 transmission. This paragraph does not apply to documents titled determinations of eligibility  
21.23 or determinations of ineligibility issued.

21.24 (e) If an amended determination of benefit account reduces the weekly benefit amount  
21.25 or maximum amount of benefits available, any benefits that have been paid greater than the  
21.26 applicant was entitled is an overpayment of benefits. A determination or amended  
21.27 determination issued under this section that results in an overpayment of benefits must set  
21.28 out the amount of the overpayment and the requirement that the overpaid benefits must be  
21.29 repaid according to section 268B.185.

21.30 Subd. 2. **Benefit account requirements.** To establish a benefit account, an applicant  
21.31 must have wage credits of at least 5.3 percent of the state's average annual wage rounded  
21.32 down to the next lower \$100.

21.33 Subd. 3. **Weekly benefit amount; maximum amount of benefits available; prorated**  
21.34 **amount.** (a) Subject to the maximum weekly benefit amount, an applicant's weekly benefit

22.1 is calculated by adding the amounts obtained by applying the following percentage to an  
 22.2 applicant's average typical workweek and weekly wage during the high quarter of the base  
 22.3 period:

22.4 (1) 90 percent of wages that do not exceed 50 percent of the state's average weekly wage;  
 22.5 plus

22.6 (2) 66 percent of wages that exceed 50 percent of the state's average weekly wage but  
 22.7 not 100 percent; plus

22.8 (3) 55 percent of wages that exceed 100 percent of the state's average weekly wage.

22.9 (b) The state's average weekly wage is the average wage as calculated under section  
 22.10 268.035, subdivision 23, at the time a benefit amount is first determined.

22.11 (c) The maximum weekly benefit amount is the state's average weekly wage as calculated  
 22.12 under section 268.035, subdivision 23.

22.13 (d) The state's maximum weekly benefit amount, computed in accordance with section  
 22.14 268.035, subdivision 23, applies to a benefit account established effective on or after the  
 22.15 last Sunday in October. Once established, an applicant's weekly benefit amount is not  
 22.16 affected by the last Sunday in October change in the state's maximum weekly benefit amount.

22.17 (e) For an employee receiving family or medical leave, a weekly benefit amount is  
 22.18 prorated when:

22.19 (1) the employee works hours for wages; or

22.20 (2) the employee uses paid sick leave, paid vacation leave, or other paid time off that is  
 22.21 not considered a supplemental benefit payment as defined in section 268B.01, subdivision  
 22.22 37.

22.23 Subd. 4. **Timing of payment.** Except as otherwise provided for in this chapter, benefits  
 22.24 must be paid weekly.

22.25 Subd. 5. **Maximum length of benefits.** (a) Except as provided in paragraph (b), in a  
 22.26 single benefit year, an applicant may receive up to 12 weeks of benefits under this chapter  
 22.27 related to the applicant's serious health condition or pregnancy and up to 12 weeks of benefits  
 22.28 under this chapter for bonding, safety leave, or family care.

22.29 (b) An applicant may receive up to 12 weeks of benefits in a single benefit year for leave  
 22.30 related to one or more qualifying exigencies.

22.31 Subd. 6. **Minimum period for which benefits payable.** Except for a claim for benefits  
 22.32 for bonding leave, any claim for benefits must be based on a single qualifying event of at

23.1 least seven calendar days. Benefits may be paid for a minimum duration of eight consecutive  
23.2 hours in a week. If an applicant on leave claims eight hours at any point during a week, the  
23.3 minimum duration is satisfied.

23.4 Subd. 7. **Right of appeal.** (a) A determination or amended determination of benefit  
23.5 account is final unless an appeal is filed by the applicant within 60 calendar days after the  
23.6 sending of the determination or amended determination.

23.7 (b) Any applicant may appeal from a determination or amended determination of benefit  
23.8 account on the issue of whether services performed constitute employment, whether the  
23.9 employment is covered employment, and whether money paid constitutes wages.

23.10 Subd. 8. **Limitations on applications and benefit accounts.** (a) An application for  
23.11 family or medical leave benefits is effective the Sunday of the calendar week that the  
23.12 application was filed. An application for benefits may be backdated one calendar week  
23.13 before the Sunday of the week the application was actually filed if the applicant requests  
23.14 the backdating within seven calendar days of the date the application is filed. An application  
23.15 may be backdated only if the applicant was eligible for the benefit during the period of the  
23.16 backdating. If an individual attempted to file an application for benefits, but was prevented  
23.17 from filing an application by the department, the application is effective the Sunday of the  
23.18 calendar week the individual first attempted to file an application.

23.19 (b) A benefit account established under subdivision 2 is effective the date the application  
23.20 for benefits was effective.

23.21 (c) A benefit account, once established, may later be withdrawn if:

23.22 (1) the applicant has not been paid any benefits on that benefit account; and

23.23 (2) a new application for benefits is filed and a new benefit account is established at the  
23.24 time of the withdrawal.

23.25 (d) A benefit account may be withdrawn after the expiration of the benefit year if the  
23.26 applicant was not paid any benefits on the benefit account that is being withdrawn.

24.1 **Sec. 9. [268B.05] NOTIFICATION OF CHANGED CIRCUMSTANCES.**

24.2 An applicant shall promptly notify the department of changes that may affect eligibility  
24.3 under section 268B.06.

24.4 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
24.5 2025.

24.6 **Sec. 10. [268B.06] ELIGIBILITY REQUIREMENTS; PAYMENTS THAT AFFECT**  
24.7 **BENEFITS.**

24.8 Subdivision 1. **Eligibility conditions.** (a) An applicant may be eligible to receive family  
24.9 or medical leave benefits for any week if:

24.10 (1) the week for which benefits are requested is in the applicant's benefit year;

24.11 (2) the applicant was unable to perform regular work due to a serious health condition,  
24.12 a qualifying exigency, safety leave, family care, bonding, pregnancy, or recovery from  
24.13 pregnancy for the period required under subdivision 2. For bonding leave, eligibility ends  
24.14 12 months after birth or placement;

24.15 (3) the applicant has sufficient wage credits from an employer or employers as defined  
24.16 in section 268B.01, subdivision 41, to establish a benefit account under section 268B.04;  
24.17 and

24.18 (4) an applicant requesting benefits under this chapter must fulfill certification  
24.19 requirements under subdivision 3.

24.20 (b) A self-employed individual or independent contractor who has elected and been  
24.21 approved for coverage under section 268B.11 need not fulfill the requirement of paragraph  
24.22 (a), clause (4).

24.23 Subd. 2. **Seven-day qualifying event.** (a) The period for which an applicant is seeking  
24.24 benefits must be or have been based on a single event of at least seven calendar days' duration  
24.25 related to pregnancy, recovery from pregnancy, family care, a qualifying exigency, safety  
24.26 leave, or the applicant's serious health condition. The days need not be consecutive.

24.27 (b) Benefits related to bonding need not meet the seven-day qualifying event requirement.

24.28 (c) The commissioner shall use the rulemaking authority under section 268B.02,  
24.29 subdivision 3, to adopt rules regarding what serious health conditions and other events are

25.1 Subd. 3. Certification. (a) Certification for an applicant taking leave related to the  
25.2 applicant's serious health condition shall be sufficient if the certification states the date on  
25.3 which the serious health condition began, the probable duration of the condition, and the  
25.4 appropriate medical facts within the knowledge of the health care provider as required by  
25.5 the commissioner.

25.6 (b) Certification for an applicant taking leave to care for a family member with a serious  
25.7 health condition shall be sufficient if the certification states the date on which the serious  
25.8 health condition commenced, the probable duration of the condition, the appropriate medical  
25.9 facts within the knowledge of the health care provider as required by the commissioner, a  
25.10 statement that the family member requires care, and an estimate of the amount of time that

25.12 (c) Certification for an applicant taking leave related to pregnancy shall be sufficient if

25.14 on appropriate medical facts within the knowledge of the health care provider.

25.15 (d) Certification for an applicant taking bonding leave because of the birth of the  
25.16 applicant's child shall be sufficient if the certification includes either the child's birth  
25.17 certificate or a document issued by the health care provider of the child or the health care  
25.18 provider of the person who gave birth, stating the child's birth date.

25.19 (e) Certification for an applicant taking bonding leave because of the placement of a  
25.20 child with the applicant for adoption or foster care shall be sufficient if the applicant provides  
25.21 a document issued by the health care provider of the child, an adoption or foster care agency  
25.22 involved in the placement, or by other individuals as determined by the commissioner that

26.19 known as "PTO."

26.20 (b) Paragraph (a) does not apply:

26.21 (1) upon a permanent separation from employment;

26.22 (2) to payments from a vacation fund administered by a union or a third party not under  
26.23 the control of the employer; or

26.24 (3) to supplemental benefit payments, as defined in section 268B.01, subdivision 37.

26.25 (c) Payments under this subdivision are applied to the period immediately following the  
26.26 later of the date of separation from employment or the date the applicant first becomes  
26.27 aware that the employer will be making a payment. The date the payment is actually made  
26.28 or received, or that an applicant must agree to a release of claims, does not affect the  
26.29 application of this subdivision.

26.30 Subd. 6. **Workers' compensation and disability insurance offset.** (a) An applicant is  
26.31 not eligible to receive benefits for any portion of a week in which the applicant is receiving

27.1 or has received compensation for loss of wages equal to or in excess of the applicant's  
27.2 weekly family or medical leave benefit amount under:

27.3 (1) the workers' compensation law of this state;

27.4 (2) the workers' compensation law of any other state or similar federal law; or

27.5 (3) any insurance or trust fund paid in whole or in part by an employer.

27.6 (b) This subdivision does not apply to an applicant who has a claim pending for loss of  
27.7 wages under paragraph (a). If the applicant later receives compensation as a result of the  
27.8 pending claim, the applicant is subject to paragraph (a) and the family or medical leave  
27.9 benefits paid are overpaid benefits under section 268B.185.

27.10 (c) If the amount of compensation described under paragraph (a) for any week is less  
27.11 than the applicant's weekly family or medical leave benefit amount, benefits requested for  
27.12 that week are reduced by the amount of that compensation payment.

27.13 Subd. 7. Separation, severance, or bonus payments. (a) An applicant is not eligible  
27.14 to receive benefits for any week the applicant is receiving, has received, or will receive  
27.15 separation pay, severance pay, bonus pay, or any other payments paid by an employer  
27.16 because of, upon, or after separation from employment. This subdivision applies if the  
27.17 payment is:

27.18 (1) considered wages under section 268B.01, subdivision 43; or

27.19 (2) subject to the Federal Insurance Contributions Act (FICA) tax imposed to fund Social  
27.20 Security and Medicare.

27.21 (b) Payments under this subdivision are applied to the period immediately following the  
27.22 later of the date of separation from employment or the date the applicant first becomes  
27.23 aware that the employer will be making a payment. The date the payment is actually made  
27.24 or received, or that an applicant must agree to a release of claims, does not affect the  
27.25 application of this paragraph.

27.26 (c) This subdivision does not apply to vacation pay, sick pay, personal time off pay, or  
27.27 supplemental benefit payment under subdivision 4.

27.28 (d) This subdivision applies to all the weeks of payment.

27.29 (e) Under this subdivision, if the payment with respect to a week is equal to or more  
27.30 than the applicant's weekly benefit amount, the applicant is ineligible for benefits for that  
27.31 week. If the payment with respect to a week is less than the applicant's weekly benefit  
27.32 amount, benefits are reduced by the amount of the payment.

28.1 Subd. 8. Social Security disability benefits. (a) An applicant who is receiving, has  
28.2 received, or has filed for primary Social Security disability benefits for any week is ineligible  
28.3 for benefits for that week, unless:

28.4 (1) the Social Security Administration approved the collecting of primary Social Security  
28.5 disability benefits each month the applicant was employed during the base period; or

28.6 (2) the applicant provides a statement from an appropriate health care professional who  
28.7 is aware of the applicant's Social Security disability claim and the basis for that claim,

28.13 (c) Information from the Social Security Administration is conclusive, absent specific  
28.14 evidence showing that the information was erroneous.

28.15 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
28.16 2025.

28.17 **Sec. 11. [268B.07] DETERMINATION ON ISSUES OF ELIGIBILITY.**

28.18 Subdivision 1. Employer notification. (a) Upon a determination that an applicant is  
28.19 entitled to benefits, the commissioner must promptly send a notification to each current  
28.20 employer of the applicant, if any, in accordance with paragraph (b).

28.21 (b) The notification under paragraph (a) must include, at a minimum:

28.22 (1) the name of the applicant;

28.23 (2) that the applicant has applied for and received benefits;

28.24 (3) the week the benefits commence;

28.25 (4) the weekly benefit amount payable; and

28.26 (5) the maximum duration of benefits.

28.27 Subd. 2. Determination. (a) The commissioner must determine any issue of ineligibility  
28.28 raised by information required from an applicant and send to the applicant and any current  
28.29 base period employer, by mail or electronic transmission, a document titled a determination  
28.30 of eligibility or a determination of ineligibility, as is appropriate, within two weeks.

29.1 (b) If an applicant obtained benefits through misrepresentation, the department is  
29.2 authorized to issue a determination of ineligibility within 12 months of the establishment  
29.3 of the benefit account.

29.4 (c) If the department has filed an intervention in a worker's compensation matter under  
29.5 section 176.361, the department is authorized to issue a determination of ineligibility within  
29.6 48 months of the establishment of the benefit account.

29.7 (d) A determination of eligibility or determination of ineligibility is final unless an appeal  
29.8 is filed by the applicant within 60 calendar days after sending. The determination must  
29.9 contain a prominent statement indicating the consequences of not appealing. Proceedings  
29.10 on the appeal are conducted in accordance with section 268B.08.

29.11 (e) An issue of ineligibility required to be determined under this section includes any  
29.12 question regarding the denial or allowing of benefits under this chapter.

29.13 Subd. 3. **Amended determination.** Unless an appeal has been filed, the commissioner,  
29.14 on the commissioner's own motion, may reconsider a determination of eligibility or  
29.15 determination of ineligibility that has not become final and issue an amended determination.  
29.16 Any amended determination must be sent to the applicant and any employer in the current  
29.17 base period by mail or electronic transmission. Any amended determination is final unless  
29.18 an appeal is filed by the applicant within 60 calendar days after sending.

29.19 Subd. 4. **Benefit payment.** If a determination or amended determination allows benefits  
29.20 to an applicant, the family or medical leave benefits must be paid regardless of any appeal  
29.21 period or any appeal having been filed.

29.22 Subd. 5. **Overpayment.** A determination or amended determination that holds an  
29.23 applicant ineligible for benefits for periods an applicant has been paid benefits is an  
29.24 overpayment of those family or medical leave benefits. A determination or amended  
29.25 determination issued under this section that results in an overpayment of benefits must set  
29.26 out the amount of the overpayment and the requirement that the overpaid benefits must be  
29.27 repaid according to section 268B.185.

29.28 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
29.29 2025.

29.30 Sec. 12. **[268B.08] APPEAL PROCESS.**

29.31 Subdivision 1. **Hearing.** (a) The commissioner shall designate a chief benefit judge.

30.1 (b) Upon a timely appeal to a determination having been filed or upon a referral for  
30.2 direct hearing, the chief benefit judge must set a time and date for a de novo due-process  
30.3 hearing and send notice to an applicant and an employer, by mail or electronic transmission,  
30.4 not less than ten calendar days before the date of the hearing.

30.5 (c) The commissioner may adopt rules on procedures for hearings. The rules need not  
30.6 conform to common law or statutory rules of evidence and other technical rules of procedure.

30.7 (d) The chief benefit judge has discretion regarding the method by which the hearing is  
30.8 conducted.

30.9 Subd. 2. **Decision.** (a) After the conclusion of the hearing, upon the evidence obtained,  
30.10 the benefit judge must serve by mail or electronic transmission to all parties the decision,  
30.11 reasons for the decision, and written findings of fact.

30.12 (b) Decisions of a benefit judge are not precedential.

30.13 Subd. 3. **Request for reconsideration.** Any party, or the commissioner, may, within  
30.14 30 calendar days after service of the benefit judge's decision, file a request for reconsideration  
30.15 asking the judge to reconsider that decision.

30.16 Subd. 4. **Appeal to court of appeals.** Any final determination on a request for  
30.17 reconsideration may be appealed by any party directly to the Minnesota Court of Appeals.

30.18 Subd. 5. **Benefit judges.** (a) Only employees of the department who are attorneys licensed  
30.19 to practice law in Minnesota may serve as a chief benefit judge, senior benefit judges who  
30.20 are supervisors, or benefit judges.

30.21 (b) The chief benefit judge must assign a benefit judge to conduct a hearing and may  
30.22 transfer to another benefit judge any proceedings pending before another benefit judge.

30.23 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
30.24 2025.

30.25 Sec. 13. **[268B.085] LEAVE.**

30.26 Subdivision 1. **Right to leave.** Ninety calendar days from the date of hire, an employee  
30.27 has a right to leave from employment for any day, or portion of a day, for which the employee  
30.28 would be eligible for benefits under this chapter, regardless of whether the employee actually  
30.29 applied for benefits and regardless of whether the employee is covered under a private plan  
30.30 or the public program under this chapter.

30.31 Subd. 2. **Notice to employer.** (a) If the need for leave is foreseeable, an employee must  
30.32 provide the employer at least 30 days' advance notice before leave under this chapter is to

31.1 begin. If 30 days' notice is not practicable because of a lack of knowledge of approximately  
31.2 when leave will be required to begin, a change in circumstances, or a medical emergency,  
31.3 notice must be given as soon as practicable. Whether leave is to be continuous or is to be  
31.4 taken intermittently or on a reduced-schedule basis, notice need only be given one time, but  
31.5 the employee must advise the employer as soon as practicable if dates of scheduled leave  
31.6 change or are extended, or were initially unknown. In those cases where the employee is  
31.7 required to provide at least 30 days' notice of foreseeable leave and does not do so, the  
31.8 employee must explain the reasons why notice was not practicable upon request from the  
31.9 employer.

31.10 (b) "As soon as practicable" means as soon as both possible and practical, taking into  
31.11 account all of the facts and circumstances in the individual case. When an employee becomes  
31.12 aware of a need for leave under this chapter less than 30 days in advance, it should be  
31.13 practicable for the employee to provide notice of the need for leave either the same day or  
31.14 the next day, unless the need for leave is based on a medical emergency. In all cases,  
31.15 however, the determination of when an employee could practicably provide notice must  
31.16 take into account the individual facts and circumstances.

31.17 (c) An employee shall provide at least oral, telephone, or text message notice sufficient  
31.18 to make the employer aware that the employee needs leave allowed under this chapter and  
31.19 the anticipated timing and duration of the leave.

31.20 (d) An employer may require an employee to comply with the employer's usual and  
31.21 customary notice and procedural requirements for requesting leave, absent unusual  
31.22 circumstances or other circumstances caused by the reason for the employee's need for  
31.23 leave. Leave under this chapter must not be delayed or denied where an employer's usual  
31.24 and customary notice or procedural requirements require notice to be given sooner than set  
31.25 forth in this subdivision.

31.26 (e) If an employer has failed to provide notice to the employee as required under section  
31.27 268B.26, paragraph (a), (b), or (c), the employee is not required to comply with the notice  
31.28 requirements of this subdivision.

31.29 Subd. 3. **Bonding leave.** Bonding leave taken under this chapter begins at a time requested  
31.30 by the employee. Bonding leave must end within 12 months of the birth, adoption, or  
31.31 placement of a foster child, except that, in the case where the child must remain in the  
31.32 hospital longer than the mother, the leave must end within 12 months after the child leaves  
31.33 the hospital.

32.1 Subd. 4. **Intermittent or reduced-leave schedule.** (a) Leave under this chapter, based  
32.2 on a serious health condition, may be taken intermittently or on a reduced-leave schedule  
32.3 if such leave is reasonable and appropriate to the needs of the individual with the serious  
32.4 health condition. For all other leaves under this chapter, leave may be taken intermittently  
32.5 or on a reduced-leave schedule. Intermittent leave is leave taken in separate blocks of time  
32.6 due to a single, seven-day qualifying event. A reduced-leave schedule is a leave schedule  
32.7 that reduces an employee's usual number of working hours per workweek or hours per  
32.8 workday.

32.9 (b) Leave taken intermittently or on a reduced-schedule basis counts toward the  
32.10 maximums described in section 268B.04, subdivision 5.

32.11 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
32.12 2025.

32.13 Sec. 14. **[268B.09] EMPLOYMENT PROTECTIONS.**

32.14 Subdivision 1. **Retaliation prohibited.** An employer must not retaliate against an  
32.15 employee for requesting or obtaining benefits or leave, or for exercising any other right  
32.16 under this chapter.

32.17 Subd. 2. **Interference prohibited.** An employer must not obstruct or impede an  
32.18 application for leave or benefits or the exercise of any other right under this chapter.

32.19 Subd. 3. **Waiver of rights void.** Any agreement to waive, release, or commute rights  
32.20 to benefits or any other right under this chapter is void.

32.21 Subd. 4. **No assignment of benefits.** Any assignment, pledge, or encumbrance of benefits  
32.22 is void. Benefits are exempt from levy, execution, attachment, or any other remedy provided  
32.23 for the collection of debt. Any waiver of this subdivision is void.

32.24 Subd. 5. **Continued insurance.** During any leave for which an employee is entitled to  
32.25 benefits under this chapter, the employer must maintain coverage under any group insurance  
32.26 policy, group subscriber contract, or health care plan for the employee and any dependents  
32.27 as if the employee was not on leave, provided, however, that the employee must continue  
32.28 to pay any employee share of the cost of such benefits.

32.29 Subd. 6. **Employee right to reinstatement.** (a) On return from leave under this chapter,  
32.30 an employee is entitled to be returned to the same position the employee held when leave  
32.31 commenced or to an equivalent position with equivalent benefits, pay, and other terms and  
32.32 conditions of employment. An employee is entitled to reinstatement even if the employee



33.1 has been replaced or the employee's position has been restructured to accommodate the  
33.2 employee's absence.

33.3 (b)(1) An equivalent position is one that is virtually identical to the employee's former  
33.4 position in terms of pay, benefits, and working conditions, including privileges, prerequisites,  
33.5 and status. It must involve the same or substantially similar duties and responsibilities,  
33.6 which must entail substantially equivalent skill, effort, responsibility, and authority.

33.7 (2) If an employee is no longer qualified for the position because of the employee's  
33.8 inability to attend a necessary course, renew a license, fly a minimum number of hours, or  
33.9 similar condition, as a result of the leave, the employee must be given a reasonable  
33.10 opportunity to fulfill those conditions upon return from leave.

33.11 (c)(1) An employee is entitled to any unconditional pay increases which may have  
33.12 occurred during the leave period, such as cost of living increases. Pay increases conditioned  
33.13 upon seniority, length of service, or work performed must be granted in accordance with  
33.14 the employer's policy or practice with respect to other employees on an equivalent leave  
33.15 status for a reason that does not qualify for leave under this chapter. An employee is entitled  
33.16 to be restored to a position with the same or equivalent pay premiums, such as a shift  
33.17 differential. If an employee departed from a position averaging ten hours of overtime, and  
33.18 corresponding overtime pay, each week an employee is ordinarily entitled to such a position  
33.19 on return from leave under this chapter.

33.20 (2) Equivalent pay includes any bonus or payment, whether it is discretionary or  
33.21 nondiscretionary, made to employees consistent with clause (1). If a bonus or other payment  
33.22 is based on the achievement of a specified goal such as hours worked, products sold, or  
33.23 perfect attendance, and the employee has not met the goal due to leave under this chapter,  
33.24 the payment may be denied, unless otherwise paid to employees on an equivalent leave  
33.25 status for a reason that does not qualify for leave under this chapter.

33.26 (d) Benefits under this section include all benefits provided or made available to  
33.27 employees by an employer, including group life insurance, health insurance, disability  
33.28 insurance, sick leave, annual leave, educational benefits, and pensions, regardless of whether  
33.29 benefits are provided by a practice or written policy of an employer through an employee  
33.30 benefit plan as defined in section 3(3) of United States Code, title 29, section 1002(3).

33.31 (1) At the end of an employee's leave under this chapter, benefits must be resumed in  
33.32 the same manner and at the same levels as provided when the leave began, and subject to  
33.33 any changes in benefit levels that may have taken place during the period of leave affecting  
33.34 the entire workforce, unless otherwise elected by the employee. Upon return from a leave

34.1 under this chapter, an employee must not be required to requalify for any benefits the  
34.2 employee enjoyed before leave began, including family or dependent coverages.

34.3 (2) An employee may, but is not entitled to, accrue any additional benefits or seniority  
34.4 during a leave under this chapter. Benefits accrued at the time leave began must be available  
34.5 to an employee upon return from leave.

34.6 (3) With respect to pension and other retirement plans, leave under this chapter must  
34.7 not be treated as or counted toward a break in service for purposes of vesting and eligibility  
34.8 to participate. If the plan requires an employee to be employed on a specific date in order  
34.9 to be credited with a year of service for vesting, contributions, or participation purposes,  
34.10 an employee on leave under this chapter must be treated as employed on that date. Periods  
34.11 of leave under this chapter need not be treated as credited service for purposes of benefit  
34.12 accrual, vesting, and eligibility to participate.

34.13 (4) Employees on leave under this chapter must be treated as if they continued to work  
34.14 for purposes of changes to benefit plans. Employees on leave under this chapter are entitled  
34.15 to changes in benefit plans, except those which may be dependent upon seniority or accrual  
34.16 during the leave period, immediately upon return from leave or to the same extent they  
34.17 would have qualified if no leave had been taken.

34.18 (e) An equivalent position must have substantially similar duties, conditions,  
34.19 responsibilities, privileges, and status as the employee's original position.

34.20 (1) The employee must be reinstated to the same or a geographically proximate worksite  
34.21 from where the employee had previously been employed. If the employee's original worksite  
34.22 has been closed, the employee is entitled to the same rights as if the employee had not been  
34.23 on leave when the worksite closed.

34.24 (2) The employee is ordinarily entitled to return to the same shift or the same or an  
34.25 equivalent work schedule.

34.26 (3) The employee must have the same or an equivalent opportunity for bonuses,  
34.27 profit-sharing, and other similar discretionary and nondiscretionary payments.

34.28 (4) This chapter does not prohibit an employer from accommodating an employee's  
34.29 request to be restored to a different shift, schedule, or position which better suits the  
34.30 employee's personal needs on return from leave, or to offer a promotion to a better position.  
34.31 However, an employee must not be induced by the employer to accept a different position  
34.32 against the employee's wishes.

35.1 (f) The requirement that an employee be restored to the same or equivalent job with the  
35.2 same or equivalent pay, benefits, and terms and conditions of employment does not extend  
35.3 to de minimis, intangible, or unmeasurable aspects of the job.

35.4 Subd. 7. **Limitations on an employee's right to reinstatement.** An employee has no  
35.5 greater right to reinstatement or to other benefits and conditions of employment than if the  
35.6 employee had been continuously employed during the period of leave under this chapter.  
35.7 An employer must be able to show that an employee would not otherwise have been  
35.8 employed at the time reinstatement is requested in order to deny restoration to employment.

35.9 (1) If an employee is laid off during the course of taking a leave under this chapter and  
35.10 employment is terminated, the employer's responsibility to continue the leave, maintain  
35.11 group health plan benefits, and restore the employee cease at the time the employee is laid  
35.12 off, provided the employer has no continuing obligations under a collective bargaining  
35.13 agreement or otherwise. An employer has the burden of proving that an employee would  
35.14 have been laid off during the period of leave under this chapter and, therefore, would not  
35.15 be entitled to restoration to a job slated for layoff when the employee's original position  
35.16 would not meet the requirements of an equivalent position.

35.17 (2) If a shift has been eliminated or overtime has been decreased, an employee would  
35.18 not be entitled to return to work that shift or the original overtime hours upon restoration.  
35.19 However, if a position on, for example, a night shift has been filled by another employee,  
35.20 the employee is entitled to return to the same shift on which employed before taking leave  
35.21 under this chapter.

35.22 (3) If an employee was hired for a specific term or only to perform work on a discrete  
35.23 project, the employer has no obligation to restore the employee if the employment term or  
35.24 project is over and the employer would not otherwise have continued to employ the employee.

35.25 Subd. 8. **Remedies.** (a) In addition to any other remedies available to an employee in  
35.26 law or equity, an employer who violates the provisions of this section is liable to any  
35.27 employee affected for:

35.28 (1) damages equal to the amount of:

35.29 (i) any wages, salary, employment benefits, or other compensation denied or lost to such  
35.30 employee by reason of the violation, or, in cases in which wages, salary, employment  
35.31 benefits, or other compensation have not been denied or lost to the employee, any actual  
35.32 monetary losses sustained by the employee as a direct result of the violation;

35.33 (ii) reasonable interest on the amount described in item (i); and

36.1 (iii) an additional amount as liquidated damages equal to the sum of the amount described  
36.2 in item (i) and the interest described in item (ii), except that if an employer who has violated  
36.3 the provisions of this section proves to the satisfaction of the court that the act or omission  
36.4 which violated the provisions of this section was in good faith and that the employer had  
36.5 reasonable grounds for believing that the act or omission was not a violation of the provisions  
36.6 of this section, the court may, in the discretion of the court, reduce the amount of the liability  
36.7 to the amount and interest determined under items (i) and (ii), respectively; and

36.8 (2) such equitable relief as may be appropriate, including employment, reinstatement,  
36.9 and promotion.

36.10 (b) An action to recover damages or equitable relief prescribed in paragraph (a) may be  
36.11 maintained against any employer in any federal or state court of competent jurisdiction by  
36.12 any one or more employees for and on behalf of:

36.13 (1) the employees; or

36.14 (2) the employees and other employees similarly situated.

36.15 (c) The court in an action under this section must, in addition to any judgment awarded  
36.16 to the plaintiff or plaintiffs, allow reasonable attorney fees, reasonable expert witness fees,  
36.17 and other costs of the action to be paid by the defendant.

36.18 (d) Nothing in this section shall be construed to allow an employee to recover damages  
36.19 from an employer for the denial of benefits under this chapter by the department, unless the  
36.20 employer unlawfully interfered with the application for benefits under subdivision 2.

36.21 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
36.22 2025.

36.23 **Sec. 15. [268B.10] SUBSTITUTION OF A PRIVATE PLAN.**

36.24 Subdivision 1. **Application for substitution.** Employers may apply to the commissioner  
36.25 for approval to meet their obligations under this chapter through the substitution of a private  
36.26 plan that provides paid family, paid medical, or paid family and medical benefits. In order  
36.27 to be approved as meeting an employer's obligations under this chapter, a private plan must  
36.28 confer all of the same rights, protections, and benefits provided to employees under this  
36.29 chapter, including but not limited to benefits under section 268B.04 and employment  
36.30 protections under section 268B.09. An employee covered by a private plan under this section  
36.31 retains all applicable rights and remedies under section 268B.09.

37.1 Subd. 2. Private plan requirements; medical benefit program. The commissioner  
37.2 must approve an application for private provision of the medical benefit program if the  
37.3 commissioner determines:

37.4 (1) all of the employees of the employer are to be covered under the provisions of the  
37.5 employer plan;

37.6 (2) eligibility requirements for benefits and leave are no more restrictive than as provided  
37.7 under this chapter;

37.8 (3) the weekly benefits payable under the private plan for any week are at least equal to  
37.9 the weekly benefit amount payable under this chapter, taking into consideration any coverage  
37.10 with respect to concurrent employment by another employer;

37.11 (4) the total number of weeks for which benefits are payable under the private plan is  
37.12 at least equal to the total number of weeks for which benefits would have been payable  
37.13 under this chapter;

37.14 (5) no greater amount is required to be paid by employees toward the cost of benefits  
37.15 under the employer plan than by this chapter;

37.16 (6) wage replacement benefits are stated in the plan separately and distinctly from other  
37.17 benefits;

37.18 (7) the private plan will provide benefits and leave for any serious health condition or  
37.19 pregnancy for which benefits are payable, and leave provided, under this chapter;

37.20 (8) the private plan will impose no additional condition or restriction on the use of  
37.21 medical benefits beyond those explicitly authorized by this chapter or regulations  
37.22 promulgated pursuant to this chapter;

37.23 (9) the private plan will allow any employee covered under the private plan who is  
37.24 eligible to receive medical benefits under this chapter to receive medical benefits under the  
37.25 employer plan; and

37.26 (10) coverage will continue under the private plan while an employee remains employed  
37.27 by the employer.

37.28 Subd. 3. Private plan requirements; family benefit program. The commissioner must  
37.29 approve an application for private provision of the family benefit program if the  
37.30 commissioner determines:

37.31 (1) all of the employees of the employer are to be covered under the provisions of the  
37.32 employer plan;

38.1 (2) eligibility requirements for benefits and leave are no more restrictive than as provided  
38.2 under this chapter;

38.3 (3) the weekly benefits payable under the private plan for any week are at least equal to  
38.4 the weekly benefit amount payable under this chapter, taking into consideration any coverage  
38.5 with respect to concurrent employment by another employer;

38.6 (4) the total number of weeks for which benefits are payable under the private plan is  
38.7 at least equal to the total number of weeks for which benefits would have been payable  
38.8 under this chapter;

38.9 (5) no greater amount is required to be paid by employees toward the cost of benefits  
38.10 under the employer plan than by this chapter;

38.11 (6) wage replacement benefits are stated in the plan separately and distinctly from other  
38.12 benefits;

38.13 (7) the private plan will provide benefits and leave for any care for a family member  
38.14 with a serious health condition, bonding with a child, qualifying exigency, or safety leave  
38.15 event for which benefits are payable, and leave provided, under this chapter;

38.16 (8) the private plan will impose no additional condition or restriction on the use of family  
38.17 benefits beyond those explicitly authorized by this chapter or regulations promulgated  
38.18 pursuant to this chapter;

38.19 (9) the private plan will allow any employee covered under the private plan who is  
38.20 eligible to receive medical benefits under this chapter to receive medical benefits under the  
38.21 employer plan; and

38.22 (10) coverage will continue under the private plan while an employee remains employed  
38.23 by the employer.

38.24 Subd. 4. **Use of private insurance products.** Nothing in this section prohibits an  
38.25 employer from meeting the requirements of a private plan through a private insurance  
38.26 product. If the employer plan involves a private insurance product, that insurance product  
38.27 must conform to any applicable law or rule.

38.28 Subd. 5. **Private plan approval and oversight fee.** An employer with an approved  
38.29 private plan is not required to pay premiums established under section 268B.14. An employer  
38.30 with an approved private plan is responsible for a private plan approval and oversight fee  
38.31 equal to \$250 for employers with fewer than 50 employees, \$500 for employers with 50 to  
38.32 499 employees, and \$1,000 for employers with 500 or more employees. The employer must  
38.33 pay this fee (1) upon initial application for private plan approval, and (2) any time the

39.1 employer applies to amend the private plan. The commissioner must review and report on  
39.2 the adequacy of this fee to cover private plan administrative costs annually beginning July  
39.3 1, 2025, as part of the annual report established in section 268B.24.

39.4 Subd. 6. **Plan duration.** A private plan under this section must be in effect for a period  
39.5 of at least one year and, thereafter, continuously unless the commissioner finds that the  
39.6 employer has given notice of withdrawal from the plan in a manner specified by the  
39.7 commissioner in this section or rule. The plan may be withdrawn by the employer within  
39.8 30 days of the effective date of any law increasing the benefit amounts or within 30 days  
39.9 of the date of any change in the rate of premiums. If the plan is not withdrawn, it must be  
39.10 amended to conform to provide the increased benefit amount or change in the rate of the  
39.11 employee's premium on the date of the increase or change.

39.12 Subd. 7. **Appeals.** An employer may appeal any adverse action regarding that employer's  
39.13 private plan to the commissioner, in a manner specified by the commissioner. An employee  
39.14 covered under a private plan has the same right to appeal to the state under section 268B.04,  
39.15 subdivision 7, as any other employee.

39.16 Subd. 8. **Employees no longer covered.** (a) An employee is no longer covered by an  
39.17 approved private plan if a leave under this chapter occurs after the employment relationship  
39.18 with the private plan employer ends, or if the commissioner revokes the approval of the  
39.19 private plan.

39.20 (b) An employee no longer covered by an approved private plan is, if otherwise eligible,  
39.21 immediately entitled to benefits under this chapter to the same extent as though there had  
39.22 been no approval of the private plan.

39.23 Subd. 9. **Posting of notice regarding private plan.** An employer with a private plan  
39.24 must provide a notice prepared by or approved by the commissioner regarding the private  
39.25 plan consistent with section 268B.26.

39.26 Subd. 10. **Amendment.** (a) The commissioner must approve any amendment to a private  
39.27 plan adjusting the provisions thereof, if the commissioner determines:

39.28 (1) that the plan, as amended, will conform to the standards set forth in this chapter; and

39.29 (2) that notice of the amendment has been delivered to all affected employees at least  
39.30 ten days before the submission of the amendment.

39.31 (b) Any amendments approved under this subdivision are effective on the date of the  
39.32 commissioner's approval, unless the commissioner and the employer agree on a later date.

40.1 Subd. 11. **Successor employer.** A private plan in effect at the time a successor acquires  
40.2 the employer organization, trade, or business, or substantially all the assets thereof, or a  
40.3 distinct and severable portion of the organization, trade, or business, and continues its  
40.4 operation without substantial reduction of personnel resulting from the acquisition, must  
40.5 continue the approved private plan and must not withdraw the plan without a specific request  
40.6 for withdrawal in a manner and at a time specified by the commissioner. A successor may  
40.7 terminate a private plan with notice to the commissioner and within 90 days from the date  
40.8 of the acquisition.

40.9 Subd. 12. **Revocation of approval by commissioner.** (a) The commissioner may  
40.10 terminate any private plan if the commissioner determines the employer:

40.11 (1) failed to pay benefits;

40.12 (2) failed to pay benefits in a timely manner, consistent with the requirements of this  
40.13 chapter;

40.14 (3) failed to submit reports as required by this chapter or rule adopted under this chapter;  
40.15 or

40.16 (4) otherwise failed to comply with this chapter or rule adopted under this chapter.

40.17 (b) The commissioner must give notice of the intention to terminate a plan to the employer  
40.18 at least ten days before taking any final action. The notice must state the effective date and  
40.19 the reason for the termination.

40.20 (c) The employer may, within ten days from mailing or personal service of the notice,  
40.21 file an appeal to the commissioner in the time, manner, method, and procedure provided by  
40.22 the commissioner under subdivision 7.

40.23 (d) The payment of benefits must not be delayed during an employer's appeal of the  
40.24 revocation of approval of a private plan.

40.25 (e) If the commissioner revokes approval of an employer's private plan, that employer  
40.26 is ineligible to apply for approval of another private plan for a period of three years, beginning  
40.27 on the date of revocation.

40.28 Subd. 13. **Employer penalties.** (a) The commissioner may assess the following monetary  
40.29 penalties against an employer with an approved private plan found to have violated this  
40.30 chapter:

40.31 (1) \$1,000 for the first violation; and

40.32 (2) \$2,000 for the second, and each successive violation.



41.1 (b) The commissioner must waive collection of any penalty if the employer corrects the  
41.2 violation within 30 days of receiving a notice of the violation and the notice is for a first  
41.3 violation.

41.4 (c) The commissioner may waive collection of any penalty if the commissioner determines  
41.5 the violation to be an inadvertent error by the employer.

41.6 (d) Monetary penalties collected under this section shall be deposited in the family and  
41.7 medical benefit insurance account.

41.8 (e) Assessment of penalties under this subdivision may be appealed as provided by the  
41.9 commissioner under subdivision 7.

41.10 Subd. 14. **Reports, information, and records.** Employers with an approved private  
41.11 plan must maintain all reports, information, and records as relating to the private plan and  
41.12 claims for a period of six years from creation and provide to the commissioner upon request.

41.13 Subd. 15. **Audit and investigation.** The commissioner may investigate and audit plans  
41.14 approved under this section both before and after the plans are approved.

41.15 **EFFECTIVE DATE.** This section is effective January 1, 2024.

41.16 Sec. 16. **[268B.11] SELF-EMPLOYED AND INDEPENDENT CONTRACTOR**  
41.17 **ELECTION OF COVERAGE.**

41.18 Subdivision 1. **Election of coverage.** (a) A self-employed individual or independent  
41.19 contractor may file with the commissioner by electronic transmission in a format prescribed  
41.20 by the commissioner an application to be entitled to benefits under this chapter for a period  
41.21 not less than 104 consecutive calendar weeks. Upon the approval of the commissioner, sent  
41.22 by United States mail or electronic transmission, the individual is entitled to benefits under  
41.23 this chapter beginning the calendar quarter after the date of approval or beginning in a later  
41.24 calendar quarter if requested by the self-employed individual or independent contractor.  
41.25 The individual ceases to be entitled to benefits as of the first day of January of any calendar  
41.26 year only if, at least 30 calendar days before the first day of January, the individual has filed  
41.27 with the commissioner by electronic transmission in a format prescribed by the commissioner  
41.28 a notice to that effect.

41.29 (b) The commissioner may terminate any application approved under this section with  
41.30 30 calendar days' notice sent by United States mail or electronic transmission if the  
41.31 self-employed individual is delinquent on any premiums due under this chapter. If an  
41.32 approved application is terminated in this manner during the first 104 consecutive calendar

42.1 weeks of election, the self-employed individual remains obligated to pay the premium under  
42.2 subdivision 3 for the remainder of that 104-week period.

42.3 Subd. 2. **Application.** A self-employed individual who applies for coverage under this  
42.4 section must provide the commissioner with (1) the amount of the individual's net earnings  
42.5 from self-employment, if any, from the two most recent taxable years and all tax documents  
42.6 necessary to prove the accuracy of the amounts reported, and (2) any other documentation  
42.7 the commissioner requires. A self-employed individual who is covered under this chapter  
42.8 must annually provide the commissioner with the amount of the individual's net earnings  
42.9 from self-employment within 30 days of filing a federal income tax return.

42.10 Subd. 3. **Premium.** A self-employed individual who elects to receive coverage under  
42.11 this chapter must annually pay a premium equal to one-half the percentage in section  
42.12 268B.14, subdivision 5, clause (1), times the lesser of:

42.13 (1) the individual's self-employment premium base; or

42.14 (2) the maximum earnings subject to the FICA Old-Age, Survivors, and Disability  
42.15 Insurance tax.

42.16 Subd. 4. **Benefits.** Notwithstanding anything to the contrary, a self-employed individual  
42.17 who has applied to and been approved for coverage by the commissioner under this section  
42.18 is entitled to benefits on the same basis as an employee under this chapter, except that a  
42.19 self-employed individual's weekly benefit amount under section 268B.04, subdivision 1,  
42.20 must be calculated as a percentage of the self-employed individual's self-employment  
42.21 premium base, rather than wages.

42.22 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
42.23 2025.

42.24 Sec. 17. **[268B.12] WAGE REPORTING.**

42.25 Subdivision 1. **Wage detail report.** (a) Each employer must submit, under the employer  
42.26 premium account described in section 268B.13, a quarterly wage detail report by electronic  
42.27 transmission, in a format prescribed by the commissioner. The report must include for each  
42.28 employee in covered employment during the calendar quarter, the employee's name, the  
42.29 total wages paid to the employee, and total number of paid hours worked. For employees  
42.30 exempt from the definition of employee in section 177.23, subdivision 7, clause (6), the  
42.31 employer must report 40 hours worked for each week any duties were performed by a  
42.32 full-time employee and must report a reasonable estimate of the hours worked for each  
42.33 week duties were performed by a part-time employee. In addition, the wage detail report

43.1 must include the number of employees employed during the payroll period that includes  
43.2 the 12th day of each calendar month and, if required by the commissioner, the report must  
43.3 be broken down by business location and separate business unit. The report is due and must  
43.4 be received by the commissioner on or before the last day of the month following the end  
43.5 of the calendar quarter. The commissioner may delay the due date on a specific calendar  
43.6 quarter in the event the department is unable to accept wage detail reports electronically.

43.7 (b) The employer may report the wages paid to the next lower whole dollar amount.

43.8 (c) An employer need not include the name of the employee or other required information  
43.9 on the wage detail report if disclosure is specifically exempted from being reported by  
43.10 federal law.

43.11 (d) A wage detail report must be submitted for each calendar quarter even though no  
43.12 wages were paid, unless the business has been terminated.

43.13 Subd. 2. **Electronic transmission of report required.** Each employer must submit the  
43.14 quarterly wage detail report by electronic transmission in a format prescribed by the  
43.15 commissioner. The commissioner has the discretion to accept wage detail reports that are  
43.16 submitted by any other means or the commissioner may return the report submitted by other  
43.17 than electronic transmission to the employer, and reports returned are considered as not  
43.18 submitted and the late fees under subdivision 3 may be imposed.

43.19 Subd. 3. **Failure to timely file report; late fees.** (a) Any employer that fails to submit  
43.20 the quarterly wage detail report when due must pay a late fee of \$10 per employee, computed  
43.21 based upon the highest of:

43.22 (1) the number of employees reported on the last wage detail report submitted;

43.23 (2) the number of employees reported in the corresponding quarter of the prior calendar  
43.24 year; or

43.25 (3) if no wage detail report has ever been submitted, the number of employees listed at  
43.26 the time of employer registration.

43.27 The late fee is canceled if the wage detail report is received within 30 calendar days after  
43.28 a demand for the report is sent to the employer by mail or electronic transmission. A late  
43.29 fee assessed an employer may not be canceled more than twice each 12 months. The amount  
43.30 of the late fee assessed may not be less than \$250.

43.31 (b) If the wage detail report is not received in a manner and format prescribed by the  
43.32 commissioner within 30 calendar days after demand is sent under paragraph (a), the late

44.1 fee assessed under paragraph (a) doubles and a renewed demand notice and notice of the  
44.2 increased late fee will be sent to the employer by mail or electronic transmission.

44.3 (c) Late fees due under this subdivision may be canceled, in whole or in part, under  
44.4 section 268B.16.

44.5 Subd. 4. **Missing or erroneous information.** (a) Any employer that submits the wage  
44.6 detail report, but fails to include all required employee information or enters erroneous  
44.7 information, is subject to an administrative service fee of \$25 for each employee for whom  
44.8 the information is partially missing or erroneous.

44.9 (b) Any employer that submits the wage detail report, but fails to include an employee,  
44.10 is subject to an administrative service fee equal to two percent of the total wages for each  
44.11 employee for whom the information is completely missing.

44.12 Subd. 5. **Fees.** The fees provided for in subdivisions 3 and 4 are in addition to interest  
44.13 and other penalties imposed by this chapter and are collected in the same manner as  
44.14 delinquent taxes and credited to the family and medical benefit insurance account.

44.15 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
44.16 2025.

44.17 **Sec. 18. [268B.13] EMPLOYER PREMIUM ACCOUNTS.**

44.18 The commissioner must maintain a premium account for each employer. The  
44.19 commissioner must assess the premium account for all the premiums due under section  
44.20 268B.14, and credit the family and medical benefit insurance account with all premiums  
44.21 paid.

44.22 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
44.23 2025.

44.24 **Sec. 19. [268B.14] PREMIUMS.**

44.25 Subdivision 1. **Payments.** (a) Family and medical leave premiums accrue and become  
44.26 payable by each employer for each calendar year on the taxable wages that the employer  
44.27 paid to employees in covered employment.

44.28 Each employer must pay premiums quarterly, at the premium rate defined under this  
44.29 section, on the taxable wages paid to each employee. The commissioner must compute the  
44.30 premium due from the wage detail report required under section 268B.12 and notify the  
44.31 employer of the premium due. The premiums must be paid to the family and medical benefit

45.1 insurance account and must be received by the department on or before the last day of the  
45.2 month following the end of the calendar quarter.

45.3 (b) If for any reason the wages on the wage detail report under section 268B.12 are  
45.4 adjusted for any quarter, the commissioner must recompute the premiums due for that quarter  
45.5 and assess the employer for any amount due or credit the employer as appropriate.

45.6 Subd. 2. **Payments by electronic payment required.** (a) Every employer must make  
45.7 any payments due under this chapter by electronic payment.

45.8 (b) All third-party processors, paying on behalf of a client company, must make any  
45.9 payments due under this chapter by electronic payment.

45.10 (c) Regardless of paragraph (a) or (b), the commissioner has the discretion to accept  
45.11 payment by other means.

45.12 Subd. 3. **Employee charge back.** Notwithstanding section 177.24, subdivision 4, or  
45.13 181.06, subdivision 1, employers and covered business entities may deduct up to 50 percent  
45.14 of annual premiums paid under this section from employee wages. Such deductions for any  
45.15 given employee must be in equal proportion to the premiums paid based on the wages of  
45.16 that employee, and all employees of an employer must be subject to the same percentage  
45.17 deduction. Deductions under this section must not cause an employee's wage, after the  
45.18 deduction, to fall below the rate required to be paid to the worker by law, including any  
45.19 applicable statute, regulation, rule, ordinance, government resolution or policy, contract, or  
45.20 other legal authority, whichever rate of pay is greater.

45.21 Subd. 4. **Wages and payments subject to premium.** The maximum wages subject to  
45.22 premium in a calendar year is equal to the maximum earnings in that year subject to the  
45.23 FICA Old-Age, Survivors, and Disability Insurance tax.

45.24 Subd. 5. **Annual premium rates.** The employer premium rates beginning July 1, 2025,  
45.25 shall be as follows:

45.26 (1) for employers participating in both family and medical benefit programs, 0.7 percent;

45.27 (2) for an employer participating in only the medical benefit program and with an  
45.28 approved private plan for the family benefit program, 0.57 percent; and

45.29 (3) for an employer participating in only the family benefit program and with an approved  
45.30 private plan for the medical benefit program, 0.13 percent.

46.1 Subd. 6. Premium rate adjustments. (a) Beginning July 1, 2026, and each year  
46.2 thereafter, the commissioner must adjust the annual premium rates using the formula in  
46.3 paragraph (b).

46.4 (b) To calculate the employer rates for a calendar year, the commissioner must:

46.5 (1) multiply 1.45 times the amount disbursed from the family and medical benefit  
46.6 insurance account for the 52-week period ending September 30 of the prior year;

46.7 (2) subtract the amount in the family and medical benefit insurance account on that  
46.8 September 30 from the resulting figure;

46.9 (3) divide the resulting figure by the total wages in covered employment of employees  
46.10 of employers without approved private plans under section 268B.10 for either the family  
46.11 or medical benefit program. For employers with an approved private plan for either the  
46.12 medical benefit program or the family benefit program, but not both, count only the  
46.13 proportion of wages in covered employment associated with the program for which the  
46.14 employer does not have an approved private plan; and

46.15 (4) round the resulting figure down to the nearest one-hundredth of one percent.

46.16 (c) The commissioner must apportion the premium rate between the family and medical

46.19 Subd. 7. Deposit of premiums. All premiums collected under this section must be  
46.20 deposited into the family and medical benefit insurance account.

46.21 Subd. 8. Nonpayment of premiums by employer. The failure of an employer to pay  
46.22 premiums does not impact the right of an employee to benefits, or any other right, under  
46.23 this chapter.

46.24 EFFECTIVE DATE. Except as provided in section 38, this section is effective July 1,  
46.25 2025.

46.26 Sec. 20. [268B.145] INCOME TAX WITHHOLDING.

46.27 If the Internal Revenue Service determines that benefits are subject to federal income  
46.28 tax, and an applicant elects to have federal income tax deducted and withheld from the  
46.29 applicant's benefits, the commissioner must deduct and withhold the amount specified in  
46.30 the Internal Revenue Code in a manner consistent with state law.

46.31 EFFECTIVE DATE. Except as provided in section 38, this section is effective July 1,  
46.32 2025.

47.1 Sec. 21. [268B.15] COLLECTION OF PREMIUMS.

47.2 Subdivision 1. Amount computed presumed correct. Any amount due from an  
47.3 employer, as computed by the commissioner, is presumed to be correctly determined and  
47.4 assessed, and the burden is upon the employer to show its incorrectness. A statement by the  
47.5 commissioner of the amount due is admissible in evidence in any court or administrative  
47.6 proceeding and is prima facie evidence of the facts in the statement.

47.7 Subd. 2. Priority of payments. (a) Any payment received from an employer must be  
47.8 applied in the following order:

47.9 (1) family and medical leave premiums under this chapter; then

47.10 (2) interest on past due premiums; then

47.11 (3) penalties, late fees, administrative service fees, and costs.

47.12 (b) Paragraph (a) is the priority used for all payments received from an employer,  
47.13 regardless of how the employer may designate the payment to be applied, except when:

47.14 (1) there is an outstanding lien and the employer designates that the payment made  
47.15 should be applied to satisfy the lien;

47.16 (2) the payment is specifically designated by the employer to be applied to an outstanding

47.21 (5) the commissioner, under the compromise authority of section 268B.16, agrees to  
47.22 apply the payment to a different priority.

47.23 Subd. 3. Estimating the premium due. Only if an employer fails to make all necessary  
47.24 records available for an audit under section 268B.21 and the commissioner has reason to  
47.25 believe the employer has not reported all the required wages on the quarterly wage detail  
47.26 reports, may the commissioner then estimate the amount of premium due and assess the  
47.27 employer the estimated amount due.

47.28 Subd. 4. Costs. (a) Any employer and any applicant subject to section 268B.185,  
47.29 subdivision 2, that fails to pay any amount when due under this chapter is liable for any  
47.30 filing fees, recording fees, sheriff fees, costs incurred by referral to any public or private  
47.31 collection agency, or litigation costs, including attorney fees, incurred in the collection of  
47.32 the amounts due.

48.1 (b) If any tendered payment of any amount due is not honored when presented to a  
48.2 financial institution for payment, any costs assessed the department by the financial institution  
48.3 and a fee of \$25 must be assessed to the person.

48.4 (c) Costs and fees collected under this subdivision are credited to the enforcement account  
48.5 under section 268B.185, subdivision 3.

48.6 Subd. 5. **Interest on amounts past due.** If any amounts due from an employer under  
48.7 this chapter are not received on the date due, the commissioner must assess interest on any  
48.8 amount that remains unpaid. Interest is assessed at the rate of one percent per month or any  
48.9 part of a month. Interest is not assessed on unpaid interest. Interest collected under this  
48.10 subdivision is credited to the account.

48.11 Subd. 6. **Interest on judgments.** Regardless of section 549.09, if a judgment is entered  
48.12 upon any past due amounts from an employer under this chapter, the unpaid judgment bears  
48.13 interest at the rate specified in subdivision 5 until the date of payment.

48.14 Subd. 7. **Credit adjustments; refunds.** (a) If an employer makes an application for a  
48.15 credit adjustment of any amount paid under this chapter within four years of the date that  
48.16 the payment was due, in a manner and format prescribed by the commissioner, and the  
48.17 commissioner determines that the payment or any portion thereof was erroneous, the  
48.18 commissioner must make an adjustment and issue a credit without interest. If a credit cannot

49.2 proceeding, premiums then or thereafter due must be paid in full before all other claims  
49.3 except claims for wages of not more than \$1,000 per former employee, earned within six

49.9 **Sec. 22. [268B.155] CHILD SUPPORT DEDUCTION FROM BENEFITS.**

49.10 Subdivision 1. **Definitions.** As used in this section:

49.11 (1) "child support agency" means the public agency responsible for child support  
49.12 enforcement, including federally approved comprehensive Tribal IV-D programs; and

49.13 (2) "child support obligations" means obligations that are being enforced by a child  
49.14 support agency in accordance with a plan described in United States Code, title 42, sections  
49.15 454 and 455 of the Social Security Act that has been approved by the secretary of health  
49.16 and human services under part D of title IV of the Social Security Act. This does not include  
49.17 any type of spousal maintenance or foster care payments.

49.18 Subd. 2. **Notice upon application.** In an application for family or medical leave benefits,  
49.19 the applicant must disclose if child support obligations are owed and, if so, in what state  
49.20 and county. If child support obligations are owed, the commissioner must, if the applicant  
49.21 establishes a benefit account, notify the child support agency.

49.22 Subd. 3. **Withholding of benefit.** The commissioner must deduct and withhold from  
49.23 any family or medical leave benefits payable to an applicant who owes child support  
49.24 obligations:

49.25 (1) the amount required under a proper order of a court or administrative agency; or

49.26 (2) if clause (1) is not applicable, the amount determined under an agreement under  
49.27 United States Code, title 42, section 454 (20)(B)(i), of the Social Security Act; or

49.28 (3) if clause (1) or (2) is not applicable, the amount specified by the applicant.

49.29 Subd. 4. **Payment.** Any amount deducted and withheld must be paid to the child support  
49.30 agency, must for all purposes be treated as if it were paid to the applicant as family or  
49.31 medical leave benefits and paid by the applicant to the child support agency in satisfaction  
49.32 of the applicant's child support obligations.

50.1 Subd. 5. **Payment of costs.** The child support agency must pay the costs incurred by  
 50.2 the commissioner in the implementation and administration of this section and sections  
 50.3 518A.50 and 518A.53.

50.4 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
 50.5 2025.

50.6 Sec. 23. **[268B.16] COMPROMISE.**

50.7 (a) The commissioner may compromise in whole or in part any action, determination,  
 50.8 or decision that affects only an employer and not an applicant. This paragraph applies if it  
 50.9 is determined by a court of law, or a confession of judgment, that an applicant, while  
 50.10 employed, wrongfully took from the employer \$500 or more in money or property.

50.11 (b) The commissioner may at any time compromise any premium or reimbursement due  
 50.12 from an employer under this chapter.

50.13 (c) Any compromise involving an amount over \$10,000 must be authorized by an attorney  
 50.14 licensed to practice law in Minnesota who is an employee of the department designated by  
 50.15 the commissioner for that purpose.

50.16 (d) Any compromise must be in the best interest of the state of Minnesota.

50.17 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
 50.18 2025.

50.19 Sec. 24. **[268B.17] ADMINISTRATIVE COSTS.**

50.20 From July 1, 2025, through December 31, 2025, the commissioner may spend up to  
 50.21 seven percent of projected benefit payments during the period for the administration of this  
 50.22 chapter. Beginning January 1, 2026, and each calendar year thereafter, the commissioner  
 50.23 may spend up to seven percent of projected benefit payments for that calendar year for the  
 50.24 administration of this chapter. The department may enter into interagency agreements with  
 50.25 the Department of Labor and Industry, including agreements to transfer funds, subject to  
 50.26 the limit in this section, for the Department of Labor and Industry to fulfill its enforcement

51.1 Sec. 25. **[268B.18] PUBLIC OUTREACH.**

51.2 Beginning in fiscal year 2025, the commissioner must use at least 0.5 percent of projected  
51.3 benefit payments under section 268B.17 for the purpose of outreach, education, and technical  
51.4 assistance for employees, employers, and self-employed individuals eligible to elect coverage  
51.5 under section 268B.11. The department may enter into interagency agreements with the  
51.6 Department of Labor and Industry, including agreements to transfer funds, subject to the  
51.7 limit in section 268B.17, to accomplish the requirements of this section. At least one-half  
51.8 of the amount spent under this section must be used for grants to community-based groups.

51.9 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
51.10 2025.

51.11 Sec. 26. **[268B.185] BENEFIT OVERPAYMENTS.**

51.12 **Subdivision 1. Repaying an overpayment.** (a) Any applicant who (1) because of a  
51.13 determination or amended determination issued under this chapter, or (2) because of a  
51.14 benefit law judge's decision under section 268B.08, has received any family or medical  
51.15 leave benefits that the applicant was held not entitled to, is overpaid the benefits and must  
51.16 promptly repay the benefits to the family and medical benefit insurance account.

51.17 (b) If the applicant fails to repay the benefits overpaid, including any penalty and interest  
51.18 assessed under subdivisions 2 and 4, the total due may be collected by the methods allowed  
51.19 under state and federal law.

51.20 **Subd. 2. Overpayment because of misrepresentation.** (a) An applicant has committed  
51.21 misrepresentation if the applicant is overpaid benefits by making an intentional false  
51.22 statement or representation in an effort to fraudulently collect benefits. Overpayment because  
51.23 of misrepresentation does not occur where there is unintentional mistake without a good  
51.24 faith belief as to the eligibility or correctness of the statement or representation.

51.25 (b) A determination of overpayment penalty must state the methods of collection the  
51.26 commissioner may use to recover the overpayment, penalty, and interest assessed. Money  
51.27 received in repayment of overpaid benefits, penalties, and interest is first applied to the

52.1 Any penalties and interest collected under this section shall be deposited into the account  
52.2 under this subdivision and shall be used only for the purposes of administering and enforcing

52.5 Subd. 4. **Interest.** For any family and medical leave benefits obtained by

52.12 Subd. 5. **Offset of benefits.** An employee may offset from any future family and medical  
52.13 leave benefits otherwise payable the amount of an overpayment. No single offset may exceed  
52.14 20 percent of the amount of the payment from which the offset is made.

52.15 Subd. 6. **Cancellation of overpayments.** (a) If family and medical leave benefits  
52.16 overpayments are not repaid or offset from subsequent benefits within three years after the  
52.17 date of the determination or decision holding the applicant overpaid, the commissioner must  
52.18 cancel the overpayment balance, and no administrative or legal proceedings may be used  
52.19 to enforce collection of those amounts.

52.20 (b) The commissioner may cancel at any time any overpayment, including penalties and  
52.21 interest that the commissioner determines is uncollectible because of death or bankruptcy.

52.22 Subd. 7. **Collection of overpayments.** (a) The commissioner has discretion regarding  
52.23 the recovery of any overpayment for reasons other than misrepresentation. Regardless of  
52.24 any law to the contrary, the commissioner is not required to refer any overpayment for  
52.25 reasons other than misrepresentation to a public or private collection agency, including

52.27 (b) Amounts overpaid for reasons other than misrepresentation are not considered a  
52.28 "debt" to the state of Minnesota for purposes of any reporting requirements to the

52.30 (c) A pending appeal under section 268B.08 does not suspend the assessment of interest,  
52.31 penalties, or collection of an overpayment.

52.32 (d) Section 16A.626 applies to the repayment by an applicant of any overpayment,  
52.33 penalty, or interest.

53.1 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
53.2 2025.

53.3 Sec. 27. **[268B.19] EMPLOYER MISCONDUCT; PENALTY.**

53.4 (a) The commissioner must penalize an employer if that employer or any employee,  
53.5 officer, or agent of that employer is in collusion with any applicant for the purpose of  
53.6 assisting the applicant in receiving benefits fraudulently. The penalty is \$500 or the amount  
53.7 of benefits determined to be overpaid, whichever is greater.

53.8 (b) The commissioner must penalize an employer if that employer or any employee,  
53.9 officer, or agent of that employer:

53.10 (1) made a false statement or representation knowing it to be false;

53.11 (2) made a false statement or representation without a good-faith belief as to the  
53.12 correctness of the statement or representation; or

53.13 (3) knowingly failed to disclose a material fact.

53.14 (c) The penalty is the greater of \$500 or 50 percent of the following resulting from the  
53.15 employer's action:

53.16 (1) the amount of any overpaid benefits to an applicant;

53.17 (2) the amount of benefits not paid to an applicant that would otherwise have been paid;  
53.18 or

53.19 (3) the amount of any payment required from the employer under this chapter that was  
53.20 not paid.

53.21 (d) Penalties must be paid within 30 calendar days of issuance of the determination of  
53.22 penalty and credited to the family and medical benefit insurance account.

53.23 (e) The determination of penalty is final unless the employer files an appeal within 30  
53.24 calendar days after the sending of the determination of penalty to the employer by United  
53.25 States mail or electronic transmission.

53.26 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
53.27 2025.

53.28 Sec. 28. **[268B.21] RECORDS; AUDITS.**

53.29 Subdivision 1. **Employer records; audits.** (a) Each employer must keep true and accurate  
53.30 records on individuals performing services for the employer, containing the information

54.1 the commissioner may require under this chapter. The records must be kept for a period of  
54.2 not less than four years in addition to the current calendar year.

54.3 (b) For the purpose of administering this chapter, the commissioner has the power to  
54.4 audit, examine, or cause to be supplied or copied, any books, correspondence, papers,  
54.5 records, or memoranda that are the property of, or in the possession of, an employer or any  
54.6 other person at any reasonable time and as often as may be necessary. Subpoenas may be  
54.7 issued under section 268B.22 as necessary, for an audit.

54.8 (c) An employer or other person that refuses to allow an audit of its records by the  
54.9 department or that fails to make all necessary records available for audit in the state upon  
54.10 request of the commissioner may be assessed an administrative penalty of \$500. The penalty  
54.11 collected is credited to the family and medical benefit insurance account.

54.12 (d) An employer, or other person, that fails to provide a weekly breakdown of money  
54.13 earned by an applicant upon request of the commissioner, information necessary for the  
54.14 detection of applicant misrepresentation under section 268B.185, subdivision 2, may be  
54.15 assessed an administrative penalty of \$100. Any notice requesting a weekly breakdown  
54.16 must clearly state that a \$100 penalty may be assessed for failure to provide the information.  
54.17 The penalty collected is credited to the family and medical benefit insurance account.

54.18 Subd. 2. **Department records; destruction.** (a) The commissioner may make summaries,  
54.19 compilations, duplications, or reproductions of any records pertaining to this chapter that  
54.20 the commissioner considers advisable for the preservation of the information.

54.21 (b) Regardless of any law to the contrary, the commissioner may destroy any records  
54.22 that are no longer necessary for the administration of this chapter. In addition, the  
54.23 commissioner may destroy any record from which the information has been electronically  
54.24 captured and stored.

54.25 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
54.26 2025.

54.27 Sec. 29. **[268B.22] SUBPOENAS; OATHS.**

54.28 (a) The commissioner or benefit judge has authority to administer oaths and affirmations,  
54.29 take depositions, certify to official acts, and issue subpoenas to compel the attendance of  
54.30 individuals and the production of documents and other personal property necessary in  
54.31 connection with the administration of this chapter.

55.1 (b) Individuals subpoenaed, other than applicants or officers and employees of an  
55.2 employer that is the subject of the inquiry, are paid witness fees the same as witness fees  
55.3 in civil actions in district court. The fees need not be paid in advance.

55.4 (c) The subpoena is enforceable through the district court in Ramsey County.

55.5 **EFFECTIVE DATE.** Except as provided in section 38, this section is effective July 1,  
55.6 2025.

55.7 **Sec. 30. [268B.23] LIEN; LEVY; SETOFF; AND CIVIL ACTION.**

55.8 Subdivision 1. **Lien.** (a) Any amount due under this chapter, from an applicant or an  
55.9 employer, becomes a lien upon all the property, within this state, both real and personal, of  
55.10 the person liable, from the date of assessment. For the purposes of this section, "date of  
55.11 assessment" means the date the obligation was due.

55.12 (b) The lien is not enforceable against any purchaser, mortgagee, pledgee, holder of a  
55.13 Uniform Commercial Code security interest, mechanic's lien, or judgment lien creditor,  
55.14 until a notice of lien has been filed with the county recorder of the county where the property  
55.15 is situated, or in the case of personal property belonging to a nonresident person in the Office  
55.16 of the Secretary of State. When the notice of lien is filed with the county recorder, the fee  
55.17 for filing and indexing is as provided in sections 272.483 and 272.484.

55.18 (c) Notices of liens, lien renewals, and lien releases, in a form prescribed by the  
55.19 commissioner, may be filed with the county recorder or the secretary of state by mail,  
55.20 personal delivery, or electronic transmission into the computerized filing system of the  
55.21 secretary of state. The secretary of state must, on any notice filed with that office, transmit  
55.22 the notice electronically to the appropriate county recorder. The filing officer, whether the  
55.23 county recorder or the secretary of state, must endorse and index a printout of the notice as  
55.24 if the notice had been mailed or delivered.

55.25 (d) County recorders and the secretary of state must enter information on lien notices,  
55.26 renewals, and releases into the central database of the secretary of state. For notices filed  
55.27 electronically with the county recorders, the date and time of receipt of the notice and county  
55.28 recorder's file number, and for notices filed electronically with the secretary of state, the  
55.29 secretary of state's recording information, must be entered into the central database before  
55.30 the close of the working day following the day of the original data entry by the commissioner.

55.31 (e) The lien imposed on personal property, even though properly filed, is not enforceable  
55.32 against a purchaser of tangible personal property purchased at retail or personal property  
55.33 listed as exempt in sections 550.37, 550.38, and 550.39.

56.1 (f) A notice of lien filed has priority over any security interest arising under chapter 336,  
56.2 article 9, that is perfected prior in time to the lien imposed by this subdivision, but only if:

56.3 (1) the perfected security interest secures property not in existence at the time the notice  
56.4 of lien is filed; and

56.5 (2) the property comes into existence after the 45th calendar day following the day the  
56.6 notice of lien is filed, or after the secured party has actual notice or knowledge of the lien  
56.7 filing, whichever is earlier.

56.8 (g) The lien is enforceable from the time the lien arises and for ten years from the date  
56.9 of filing the notice of lien. A notice of lien may be renewed before expiration for an additional  
56.10 ten years.

56.11 (h) The lien is enforceable by levy under subdivision 2 or by judgment lien foreclosure  
56.12 under chapter 550.

56.13 (i) The lien may be imposed upon property defined as homestead property in chapter  
56.14 510 but may be enforced only upon the sale, transfer, or conveyance of the homestead  
56.15 property.

56.16 (j) The commissioner may sell and assign to a third party the commissioner's right of  
56.17 redemption in specific real property for liens filed under this subdivision. The assignee is  
56.18 limited to the same rights of redemption as the commissioner, except that in a bankruptcy  
56.19 proceeding, the assignee does not obtain the commissioner's priority. Any proceeds from  
56.20 the sale of the right of redemption are credited to the family and medical benefit insurance  
56.21 account.

56.22 Subd. 2. Levy. (a) If any amount due under this chapter, from an applicant or an employer,  
56.23 is not paid when due, the amount may be collected by the commissioner by direct levy upon  
56.24 all property and rights of property of the person liable for the amount due except property  
56.25 exempt from execution under section 550.37. For the purposes of this section, "levy" includes  
56.26 the power of distraint and seizure by any means.

56.27 (b) In addition to a direct levy, the commissioner may issue a warrant to the sheriff of  
56.28 any county who must proceed within 60 calendar days to levy upon the property or rights  
56.29 to property of the delinquent person within the county, except property exempt under section  
56.30 550.37. The sheriff must sell that property necessary to satisfy the total amount due, together  
56.31 with the commissioner's and sheriff's costs. The sales are governed by the law applicable  
56.32 to sales of like property on execution of a judgment.



57.1 (c) Notice and demand for payment of the total amount due must be mailed to the  
57.2 delinquent person at least ten calendar days before action being taken under paragraphs (a)  
57.3 and (b).

57.4 (d) If the commissioner has reason to believe that collection of the amount due is in  
57.5 jeopardy, notice and demand for immediate payment may be made. If the total amount due  
57.6 is not paid, the commissioner may proceed to collect by direct levy or issue a warrant without  
57.7 regard to the ten calendar day period.

57.8 (e) In executing the levy, the commissioner must have all of the powers provided in  
57.9 chapter 550 or any other law that provides for execution against property in this state. The  
57.10 sale of property levied upon and the time and manner of redemption is as provided in chapter  
57.11 550. The seal of the court is not required. The levy may be made whether or not the  
57.12 commissioner has commenced a legal action for collection.

57.13 (f) Where any assessment has been made by the commissioner, the property seized for  
57.14 collection of the total amount due must not be sold until any determination of liability has  
57.15 become final. No sale may be made unless a portion of the amount due remains unpaid for  
57.16 a period of more than 30 calendar days after the determination of liability becomes final.  
57.17 Seized property may be sold at any time if:

57.18 (1) the delinquent person consents in writing to the sale; or

57.19 (2) the commissioner determines that the property is perishable or may become greatly  
57.20 reduced in price or value by keeping, or that the property cannot be kept without great  
57.21 expense.

57.22 (g) Where a levy has been made to collect the amount due and the property seized is


