1.3 "Section 1. **[116J.015] EXPIRATION OF REPORT MANDATES.**

1.4 (a) If the submission of a report by the commissioner of employment and economic
1.5 development to the legislature is mandated by statute and the enabling legislation does not
1.6 include a date for the submission of a final report, the mandate to submit the report expires
1.7 according to this section.

1.8 (b) If the mandate requires the submission of an annual report and the mandate was
1.9 enacted before January 1, 2022, the mandate expires January 1, 2024. If the mandate requires
1.10 the submission of a biennial or less frequent report and the mandate was enacted before
1.11 January 1, 2022, the mandate expires January 1, 2025.

1.12 (c) Any reporting mandate enacted on or after January 1, 2022, expires three years after
1.13 the date of enactment if the mandate requires the submission of an annual report and expires
1.14 five years after the date of enactment if the mandate requires the submission of a biennial
1.15 or less frequent report unless the enacting legislation provides for a different expiration
1.16 date.

1.17 (d) The commissioner shall submit to the chairs and ranking minority members of the
1.18 legislative committees with jurisdiction over employment and economic development by
1.19 February 15 of each year, beginning February 15, 2023, a list of all reports set to expire
1.20 during the following calendar year according to this section.

2.2 Subd. 1a. **Pathways program.** The pathways program may provide grants-in-aid for
2.3 developing programs which assist in the transition of persons from welfare to work and
2.4 assist individuals at or below 200 percent of the federal poverty guidelines. The program
2.5 is to be operated by the board. The board shall consult and coordinate with program
2.6 administrators at the Department of Employment and Economic Development to design
2.7 and provide services for temporary assistance for needy families recipients.

2.8 Pathways grants-in-aid may be awarded to educational or other nonprofit training
2.9 institutions or to workforce development intermediaries for education and training programs
2.10 and services supporting education and training programs that serve eligible recipients.

2.11 Preference shall be given to projects that:

2.12 (1) provide employment with benefits paid to employees;

2.25 Subdivision 1. **Definitions.** (a) For the purposes of this section, the following terms have

2.27 (b) "Commissioner" means the commissioner of employment and economic development.

2.28 (c) "Dislocated worker" means an individual who is a resident of Minnesota at the time
2.29 employment ceased or was working in the state at the time employment ceased and:

3.1 (1) has been permanently separated or has received a notice of permanent separation
3.2 from public or private sector employment and is eligible for or has exhausted entitlement
3.3 to unemployment benefits, and is unlikely to return to the previous industry or occupation;

3.4 (2) has been long-term unemployed and has limited opportunities for employment or
3.5 reemployment in the same or a similar occupation in the area in which the individual resides,
3.6 including older individuals who may have substantial barriers to employment by reason of
3.7 age;

3.8 (3) has been terminated or has received a notice of termination of employment as a result
3.9 of a plant closing or a substantial layoff at a plant, facility, or enterprise;

3.10 (4) has been self-employed, including farmers and ranchers, and is unemployed as a
3.11 result of general economic conditions in the community in which the individual resides or
3.12 because of natural disasters;

3.13 (5) is a veteran as defined by section 197.447, has been discharged or released from
3.14 active duty under honorable conditions within the last 36 months, and (i) is unemployed or
3.15 (ii) is employed in a job verified to be below the skill level and earning capacity of the
3.16 veteran;

3.17 (6) is an individual determined by the United States Department of Labor to be covered
3.18 by trade adjustment assistance under United States Code, title 19, sections 2271 to 2331,
3.19 as amended; or

3.20 (7) is a displaced homemaker. A "displaced homemaker" is an individual who has spent
3.21 a substantial number of years in the home providing homemaking service and (i) has been
3.22 dependent upon the financial support of another; and ~~now~~ due to divorce, separation, death,
3.23 or disability of that person, must now find employment to self support; or (ii) derived the
3.24 substantial share of support from public assistance on account of dependents in the home
3.25 and no longer receives such support. To be eligible under this clause, the support must have
3.26 ceased while the worker resided in Minnesota.

4.13 (2) ~~eleven~~ fourteen representatives of statewide associations representing bed and

6.3 (a) The commissioner, upon the commissioner's own motion or upon application of a
6.4 person, must determine if that person is an employer or whether services performed for it
6.5 constitute employment and covered employment, or whether any compensation constitutes
6.6 wages, and notify the person of the determination. The determination is final unless the
6.7 person files an appeal within ~~20~~ 45 calendar days after the commissioner sends the
6.8 determination by mail or electronic transmission. Proceedings on the appeal are conducted
6.9 in accordance with section 268.105.

6.10 (b) No person may be initially determined an employer, or that services performed for
6.11 it were in employment or covered employment, for periods more than four years before the
