Dear Chair Latz and Members of the Judiciary Committee:

I write in strong and unequivocal support of the confirmation of Rebecca Lucero as the Commissioner of Human Rights. I have had the honor to work closely with Commissioner Lucero as a subject matter expert in the Minnesota Human Rights Commissions' investigation of, and negotiations with, the Minneapolis Police Department. Commissioner Lucero has demonstrated every quality of an exceptional Commissioner of Human Rights.

Deep and abiding commitment to human and civil rights: Commissioner Lucero has a deep knowledge of the impact of discrimination and a passionate commitment to its elimination. Her entire career has prepared her for this role. From her work in Legal Aid, as an employment attorney in private practice, and a leader in the social services provider community, she has played an important role in fighting to make rights meaningful and to ensure the equality of opportunity.

Visionary leadership: Commissioner Lucero has a clear vision for the role of the Minnesota Department of Human Rights as an enforcement agency.
