- Serve as a cabinet member and top advisor on civil rights for Governor Tim Walz and Lt. Governor Peggy Flanagan.
- Oversee the Minnesota Department of Human Rights, its staff, and its \$12 million biennium budget.
- Transformed the Agency into a strategic civil rights enforcement agency instead of a claims processing department.
- Led the Agency to utilize never or rarely used tools from the MN Human Rights Act such as implementing a temporary restraining order to require immediate policy change where irreparable harm was occurring to Black, Indigenous, and other people of color.
- Launched a high-profile civil rights investigation into the City of Minneapolis and the Minneapolis Police Department immediately following the murder of George Floyd that resulted in early and unprecedented public safety changes. Issued comprehensive findings that detailed a 10-year pattern or practice of race discrimination. Now in productive negotiations for a court-enforceable agreement to address this pattern of race-based policing with a sustained and coordinated approach.
- Lead the Agency's strategic litigation and settlement work to support a state free from sexual harassment and assault by reaching agreements with schools and workplaces that require them to put in place robust policies and to enforce those policies.
- Led the Agency's work to advance LGBTQ+ rights in Minnesota, including making schools safer and more welcoming at a time when transgender, non-binary, and genderqueer youth are being criminalized across the country by joining a lawsuit that resulted in a landmark decision when the Minnesota Court of Appeals ruled that all Minnesota schools must allow students to use locker rooms and bathrooms that align with their gender identity so that they can fully participate in school.
- Serve as spokesperson to the press on Minnesota's key civil rights issues and the Agency's impactful work highlighted in the media throughout the state, country, and internationally. Participate in press conferences with the Governor and Lt. Governor.
- Lead the agency's efforts on budget negotiations and public policy changes including testifying in front of the state legislature and leading engagement efforts with local and national civil rights partners and community groups.
- Co-chaired with Lt. Gov. Flanagan and directed Governor Walz's Community Resiliency and Recovery Work Group to respond to COVID-19 with a racial equity lens to proactively address racial opportunity gaps in the state's recovery efforts. Minnesota was recognized as a leader in publicly tracking the intersectionality of race/ethnicity and COVID to help identify targeted responses.
- Launched the discrimination helpline to begin the work to better track and respond to incidents of hate, bias, and discrimination.
- Formalized the mediation program to allow parties, where appropriate, to reach a voluntary, mutually beneficial resolution.

- Served on senior leadership team. Serve on policy board sub-committees for Independent Sector, National Council of Nonprofits, and MN Council of Foundations. Co-chair MCN Board sub-committee on Inclusion and Equity.

- Advanced tax conformity bills to protect nonprofits which were included in the final bill presented to the governor.

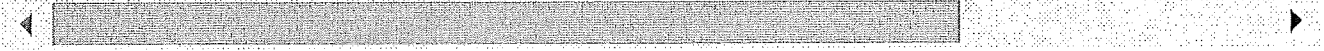
