1.5 secure for persons in this state, freedom from discrimination:

1.6 (1) in employment because of race, color, creed, religion, national origin, sex, marital  
1.7 status, disability, status with regard to public assistance, gender identity, sexual orientation,  
1.8 familial status, and age;

1.9 (2) in housing and real property because of race, color, creed, religion, national origin,  
1.10 sex, marital status, disability, status with regard to public assistance, gender identity, sexual  
1.11 orientation, and familial status;

1.12 (3) in public accommodations because of race, color, creed, religion, national origin,
