1.13 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
1.14 contain the same information unless otherwise provided by law. A voter registration
1.15 application must contain spaces for the following required information: voter's first name,
1.16 middle name, and last name; voter's previous name, if any; voter's current address; voter's
1.17 previous address, if any; voter's date of birth; voter's municipality and county of residence;
1.18 voter's telephone number, if provided by the voter; date of registration; current and valid
1.19 Minnesota driver's license number or Minnesota state identification number, or if the voter
1.20 has no current and valid Minnesota driver's license or Minnesota state identification, the
1.21 last four digits of the voter's Social Security number; and voter's signature. The paper
1.22 registration application may include the voter's email address, if provided by the voter. The
1.23 electronic voter registration application must include the voter's email address. The
1.24 registration application may include the voter's interest in serving as an election judge, if
1.25 indicated by the voter. The application must also contain the following certification of voter
1.26 eligibility:

1.29 that I must be at least 18 years old to be eligible to vote;

1.30 (2) am a citizen of the United States;

1.31 (3) will have resided in Minnesota for 20 days immediately preceding election day;

- 2.1 (4) maintain residence at the address given on the registration form;
- 2.2 (5) am not under court-ordered guardianship in which the court order revokes my right
2.3 to vote;
- 2.4 (6) have not been found by a court to be legally incompetent to vote;
- 2.5 (7) am not currently incarcerated for a conviction of a felony offense; and
- 2.6 (8) have read and understand the following statement: that giving false information is a
2.7 felony punishable by not more than five years imprisonment or a fine of not more than
2.8 \$10,000, or both."

2.9 The certification must include boxes for the voter to respond to the following questions:

2.10 "(1) Are you a citizen of the United States?" and

2.11 "~~(2) Will you be 18 years old on or before election day?~~ Are you at least 16 years old
2.12 and will you be at least 18 years old on or before the day of the election in which you intend
2.13 to vote?"

2.14 And the instruction:

2.15 "If you checked 'no' to either of these questions, do not complete this form."

2.16 The form of the voter registration application and the certification of voter eligibility
2.17 must be as provided in this subdivision and approved by the secretary of state. Voter
2.18 registration forms authorized by the National Voter Registration Act must also be accepted
2.19 as valid. The federal postcard application form must also be accepted as valid if it is not
2.20 deficient and the voter is eligible to register in Minnesota.

2.21 An individual may use a voter registration application to apply to register to vote in

4.12 website where the materials are made available in the ten most common languages for which
4.13 translation is needed by voters."

4.29 date of any modification required by this act or by Laws 2023, chapter 12. Beginning on

5.1 the effective date of a modification required by this act or by Laws 2023, chapter 12, an
5.2 election official must not print, copy, or publicly distribute a blank voter registration
5.3 application that does not include the required modification.
