

1.1 Senator moves to amend S.F. No. 2251 as follows:

1.2 Page 2, after line 16, insert:

1.3 "Sec. 2. Minnesota Statutes 2022, section 626.91, subdivision 2, is amended to read:

1.4 Subd. 2. **Law enforcement agency.** (a) The community has the powers of a law
1.5 enforcement agency, as defined in section 626.84, subdivision 1, paragraph (f), if all of the
1.6 requirements of clauses (1) to (4) are met:

1.7 (1) the community agrees to be subject to liability for its torts and those of its officers,
1.8 employees, and agents acting within the scope of their employment or duties arising out of
1.9 the law enforcement agency powers conferred by this section to the same extent as a
1.10 municipality under chapter 466, and the community further agrees, notwithstanding section
1.11 16C.05, subdivision 7, to waive its sovereign immunity with respect to claims arising from
1.12 this liability;

1.13 (2) the community files with the Board of Peace Officer Standards and Training a bond
1.14 or certificate of insurance for liability coverage with the maximum single occurrence amounts
1.15 set forth in section 466.04 and an annual cap for all occurrences within a year of three times
1.16 the single occurrence amount;

1.17 (3) the community files with the Board of Peace Officer Standards and Training a
1.18 certificate of insurance for liability of its law enforcement officers, employees, and agents
1.19 for lawsuits under the United States Constitution; and

1.20 (4) the community agrees to be subject to section 13.82 and any other laws of the state
1.21 relating to data practices of law enforcement agencies.

1.22 (b) The community ~~shall~~ may enter into an agreement under section 471.59 with the
1.23 Redwood County sheriff to define and regulate the provision of law enforcement services
1.24 under this section and to provide for mutual aid and cooperation. If entered, the agreement
1.25 must identify and describe the trust property involved in the agreement. For purposes of
1.26 entering into this agreement, the community shall be considered a "governmental unit" as
1.27 that term is defined in section 471.59, subdivision 1.

1.28 Sec. 3. Minnesota Statutes 2022, section 626.91, subdivision 4, is amended to read:

1.29 Subd. 4. **Peace officers.** If the community complies with the requirements set forth in
1.30 subdivision 2, paragraph (a), the community is authorized to appoint peace officers, as
1.31 defined in section 626.84, subdivision 1, paragraph (c), who have the same powers as peace

- 2.1 officers employed by the Redwood County sheriff over the persons and the geographic
- 2.2 areas described in subdivision 3."
