

1.1 Senator moves to amend S.F. No. 2380 as follows:

1.2 Delete everything after the enacting clause and insert:

1.3 "Section 1. Minnesota Statutes 2022, section 243.05, subdivision 1, is amended to read:

1.4 Subdivision 1. **Conditional release.** (a) The commissioner of corrections may parole
1.5 any person sentenced to confinement in any state correctional facility for adults under the
1.6 control of the commissioner of corrections, provided that:

1.7 (1) no inmate serving a life sentence for committing murder before May 1, 1980, other
1.8 than murder committed in violation of clause (1) of section 609.185 who has not been
1.9 previously convicted of a felony shall be paroled without having served 20 years, less the
1.10 diminution that would have been allowed for good conduct had the sentence been for 20
1.11 years;

1.12 (2) no inmate serving a life sentence for committing murder before May 1, 1980, who
1.13 has been previously convicted of a felony or though not previously convicted of a felony
1.14 is serving a life sentence for murder in the first degree committed in violation of clause (1)
1.15 of section 609.185 shall be paroled without having served 25 years, less the diminution
1.16 which would have been allowed for good conduct had the sentence been for 25 years;

1.17 (3) any inmate sentenced prior to September 1, 1963, who would be eligible for parole
1.18 had the inmate been sentenced after September 1, 1963, shall be eligible for parole; and

1.19 (4) any new rule or policy or change of rule or policy adopted by the commissioner of
1.20 corrections which has the effect of postponing eligibility for parole has prospective effect
1.21 only and applies only with respect to persons committing offenses after the effective date
1.22 of the new rule or policy or change.

2.5 to prevent escape or enforce discipline, any state parole and probation agent or state

22.2 (8) fails to report contact with a law enforcement agency, unless the person was charged
22.3 with a misdemeanor, gross misdemeanor, or felony; or

22.4 (9) commits any offense for which the penalty is a petty misdemeanor.

22.5 (b) A violation by a person described in paragraph (a) does not warrant the imposition
22.6 or execution of sentence and the court may not direct that the person be taken into immediate
22.7 custody unless the court receives a written report, signed under penalty of perjury pursuant
22.8 to section 358.116, showing probable cause to believe the person violated probation and
22.9 establishing by a preponderance of the evidence that the continued presence of the person
22.10 in the community would present a risk to public safety. If the court does not direct that the
22.11 person be taken into custody, the court may request a supplemental report from the
22.12 supervising agent containing:

22.13 (1) the specific nature of the violation;

22.14 (2) the response of the person under supervision to the violation, if any; and

22.15 (3) the actions the supervising agent has taken or will take to address the violation.

22.30 individuals on correctional supervision, one appointed by the Department of Human Services
22.31 and one appointed by the Minnesota Association of County Social Service Administrators;

- 23.1 (5) two representatives appointed by the Minnesota Indian Affairs Council;
- 23.2 (6) the commissioner of corrections or designee and one additional representative of the
- 23.3 department appointed by the commissioner;
- 23.4 (7) the chair of the statewide Evidence-Based Practice Advisory Committee;
- 23.5 (8) three persons who have served time on community supervision in each of the state's
- 23.6 three community supervision delivery systems appointed by the commissioner of corrections
- 23.7 in consultation with the Minnesota Association of County Probation Officers and the
- 23.8 Minnesota Association of Community Corrections Act Counties. The committee members
- 23.9 appointed under this clause must individually or collectively have been supervised under
- 23.10 each of the three community supervision delivery systems; and
- 23.11 (9) an advocate for victims of crime appointed by the commissioner of corrections.
- 23.12 (b) When an appointing authority selects an individual for membership on the committee,
- 23.13 the authority shall make reasonable efforts to reflect geographic diversity and to appoint
- 23.14 qualified members of protected groups, as defined in Minnesota Statutes, section 43A.02,
- 23.15 subdivision 33.
- 23.16 (c) The commissioner shall convene the first meeting of the committee on or before July
- 23.17 15, 2024.
- 23.18 **Subd. 2. Terms; removal; reimbursement.** (a) In the case of a vacancy on the
- 23.19 committee, the appointing authority shall appoint a person to fill the vacancy. The members
- 23.20 of the committee shall elect any officers and create any subcommittees necessary for the
- 23.21 efficient discharge of committee duties.
- 23.22 (b) A member may be removed by the appointing authority at any time at the pleasure
- 23.23 of the appointing authority.
- 23.24 (c) A member of the committee shall be reimbursed for all reasonable expenses actually
- 23.25 paid or incurred by that member in the performance of official duties in the same manner
- 23.26 as other employees of the state. The public members of the committee shall be compensated
- 23.27 at the rate of \$55 for each day or part thereof spent on committee activities.
- 23.28 **Subd. 3. Duties; committee.** (a) The committee shall comply with the requirements of
- 23.29 Minnesota Statutes, section 401.10.
- 23.30 (b) By June 30, 2024, the committee shall provide written advice and recommendations
- 23.31 to the commissioner of corrections for the development of administrative rules and policy
- 23.32 regarding:

24.1 (1) developing statewide supervision standards and definitions to be applied to community
24.2 supervision provided by CPO counties, CCA counties, the Department of Corrections, and
24.3 Tribal governments;

24.4 (2) requiring community supervision agencies to use the same agreed-upon risk screener
24.5 and risk and needs assessment tools as the main supervision assessment methods or a
24.6 universal five-level matrix allowing for consistent supervision levels and that all tools in
24.7 use be validated on Minnesota's community supervision population and revalidated every
24.8 five years;

24.9 (3) requiring the use of assessment-driven, formalized collaborative case planning to
24.10 focus case planning goals on identified criminogenic and behavioral health need areas for
24.11 moderate- and high-risk individuals;

24.12 (4) limiting standard conditions required for all people on supervision across all
24.13 supervision systems and judicial districts, ensuring that conditions of supervision are directly
24.14 related to the offense of the person on supervision, and tailoring special conditions to people
24.15 on supervision identified as high risk and need;

24.16 (5) providing gender-responsive, culturally appropriate services and trauma-informed
24.17 approaches;

24.18 (6) developing a statewide incentives and sanctions grid to guide responses to client
24.19 behavior while under supervision to be reviewed and updated every five years to maintain
24.20 alignment with national best practices;

24.21 (7) developing performance indicators for supervision success as well as recidivism;

24.22 (8) developing a statewide training, coaching, and quality assurance system overseen
24.23 by an evidence-based practices coordinator;

24.24 (9) devising a plan, by December 1, 2024, to eliminate the financial penalty incurred by
24.25 a jurisdiction that successfully discharges an offender from supervision before the offender's
24.26 term of supervision concludes; and

24.27 (10) developing a process by which the commissioner holds supervision providers
24.28 accountable for complying with their comprehensive plans required under section 401.06.

24.29 (c) By December 1, 2024, and every six years thereafter, the committee shall review
24.30 and reassess the existing workload study published by the commissioner and make
24.31 recommendations to the commissioner based on the committee's review.

25.1 (d) By June 30, 2024, the committee shall submit a report on supervision fees to the
25.2 commissioner of corrections and the chairs and ranking minority members of the legislative
25.3 committees with jurisdiction over corrections policy and funding. The committee must
25.4 collect data on supervision fees and include the data in the report. The report must provide
25.5 a plan for phasing out local correctional fees prior to the repeal of section 244.18 on August
25.6 1, 2025.

25.7 Subd. 4. **Duties; commissioner.** The commissioner, in consultation with the committee,
25.8 must complete a workload study by December 1, 2024, to develop a capitated rate for
25.9 equitably funding community supervision throughout the state. The study must be updated
25.10 every six years after completion of the initial study.

25.11 Subd. 5. **Data collection; report.** (a) By June 1, 2024, the advisory committee, in
25.12 consultation with the Minnesota Counties Computer Cooperative, must create a method to
25.13 (1) standardize data classifications across the three delivery systems, and (2) collect data
25.14 for the commissioner to publish in an annual report.

25.15 (b) The advisory committee's method, at a minimum, must provide for the collection of
25.16 the following data:

25.17 (1) the number of offenders placed on probation each year;

25.18 (2) the offense levels and offense types for which offenders are placed on probation;

25.19 (3) violation and revocation rates and the identified grounds for the violations and

26.3 office equipment and services.

26.4 Subd. 8. Report. (a) On January 15, 2025, the committee shall submit a report to the
26.5 chairs and ranking minority members of the legislative committees with jurisdiction over
26.6 public safety and finance on progress regarding the development of standards and
26.7 recommendations under subdivision 3.

26.8 (b) On January 15, 2026, the committee shall submit a final report to the chairs and
26.9 ranking minority members of the legislative committees with jurisdiction over public safety
26.10 and finance on the standards and recommendations developed according to subdivision 3.
26.11 The recommendations must include at a minimum a proposed state-level Community
26.12 Supervision Advisory Board with a governance structure and duties for the board.

26.13 Sec. 23. COMMUNITY SUPERVISION TARGETED INNOVATION GRANTS;
26.14 SPECIAL REVENUE ACCOUNT; APPROPRIATION.

26.15 (a) The community supervision targeted innovation account is created in the special
26.16 revenue fund consisting of money deposited, donated, allotted, transferred, or otherwise
26.17 provided to the account. Of the amount in the account, up to \$..... each year is appropriated
26.18 to the commissioner of corrections for grants to be awarded to local and Tribal community
26.19 supervision agencies and nonprofits that provide services to persons on community
26.20 supervision.

26.21 (b) The commissioner shall award grants to applicants that operate, or intend to operate,
26.22 innovative programs that target specific aspects of community supervision such as:

26.23 (1) access to community options including, but not limited to, inpatient substance use

26.32 (c) Grant recipients must provide an annual report to the commissioner that includes:

27.1 (1) the services provided by the grant recipient;

27.2 (2) the number of individuals served in the previous year;

27.3 (3) measurable outcomes of the recipient's program; and

27.4 (4) any other information required by the commissioner.

27.5 (d) By January 15, 2025, the commissioner shall report to the chairs and ranking minority
 27.6 members of the legislative committees with jurisdiction over criminal justice policy and
 27.7 finance on how the appropriations in this section were used. The report must detail the
 27.8 impact the appropriations had on improving community supervision practices and outcomes.

27.9 (e) The commissioner may use up to 2.5 percent of the annual appropriation to administer
 27.10 the grants.

27.11 **Sec. 24. COMMUNITY SUPERVISION TARGETED INNOVATION ACCOUNT;**
 27.12 **TRANSFER.**

27.13 \$..... in fiscal year 2024 is transferred from the general fund to the community
 27.14 supervision targeted innovation account in the special revenue fund.

27.15 **Sec. 25. ACCOUNT ESTABLISHED; TRANSFER; APPROPRIATION.**

27.16 (a) A community supervision account is established as a special revenue account in the
 27.17 state treasury.

27.18 (b) \$99,761,000 in fiscal year 2024 is transferred from the base appropriation to the
 27.19 Department of Corrections to the community supervision account in the special revenue
 27.20 fund.

27.21 (c) \$83,178,000 in fiscal year 2024 is transferred from the general fund to the community
 27.22 supervision account in the special revenue fund. This appropriation is added to the base.

27.23 (d) For fiscal year 2025 and each year thereafter, the amount deposited in the community
 27.24 supervision account pursuant to paragraph (b) and paragraph (c) shall be the sum of the
 27.25 fiscal year 2024 appropriation multiplied by the ratio of the annual implicit price deflator
 27.26 for government consumption expenditures and gross investment for state and local
 27.27 governments as prepared by the United States Department of Commerce, for the most
 27.28 recently available year to the 2022 implicit price deflator for state and local government
 27.29 purchases.

28.1 Sec. 26. **REPEALER.**

28.2 (a) Minnesota Statutes 2022, sections 244.19, subdivisions 6, 7, and 8; 244.22; 244.24;
28.3 and 244.30, are repealed.

28.4 (b) Minnesota Statutes 2022, section 244.18, is repealed.

28.5 **EFFECTIVE DATE.** This section is effective August 1, 2023, and paragraph (b) is
28.6 effective August 1, 2025."
