Members of the Senate Judiciary and Public Safety Committee:

The Minnesota Sheriffs' Association (MSA) is committed to keeping our residents and law enforcement officers safe from the threat of gun violence. At the same time, we also value, uphold and promote the rights of responsible gun owners to lawfully possess firearms, to protect themselves and their families.

The Minnesota Sheriffs' Association supports Senate File 1116. We appreciate being able to provide input to Senator Latz.

Senate Fill 1116 provides greater discretion to Chief Law Enforcement Officers (CLEO) when issuing permits to acquire. We support broader discretion for CLEO's to deny a transfer or a permit request to an individual who is deemed dangerous to themselves or others. I believe we can all agree that certain individuals should not have access to firearms.

SF 1116 also closes the gap of individuals purchasing handguns or semiautomatic military-style assault weapons without completing a background investigation.

The MSA will continue to work with the author as it relates to the retention of paperwork after a completed sale involving private parties. Again, the MSA appreciates the continued dialogue, and we look forward to working with the author to improve the language.

The MSA remains neutral on SF 1117. We acknowledge the efforts of the authors and advocates actively engaging the MSA in the conversation and listening to our concerns with portions of the proposed bill.

The language expanding the venue that the petitioner may file and ERPO potentially creates confusion regarding which law enforcement agency is responsible for securing and executing the court order.

MSA is concerned over allowing family and household members to petition directly to the court. We see potential for misrepresentation, putting the court and eventually law enforcement in a difficult and possible dangerous situation. We have expressed our unease with the storage of "turned in" or seized firearms. Not all sheriff's offices have the capacity to store and manage the number of potential firearms.

Again, the Minnesota Sheriffs' Association appreciates the author's willingness to include us in the conversation and listen to our recommendations for change.

Members of the Judiciary and Public Safety Committee,

On behalf of the nearly 1,000 members of the Minnesota Chapter of the American Academy of Pediatrics (MNAAP), I am writing in support of SF1116.

According to the Centers for Disease Control, firearms are the leading cause of death for children in the United States. Every day on average, 78 children are killed or injured by firearms in the United States. This is a public health crisis. There's no other way to put it.

SF1116 is an important tool to help ensure that guns do not fall into the hands of those who should not possess them. People such as convicted felons, domestic abusers, and individuals with certain mental health conditions, should not have access to firearms. These checks can help to keep guns out of the hands of those who are at high risk of harming themselves or others.

Expanded background checks are supported by a range of experts and organizations, including medical experts, mental health professionals, law enforcement officials, and gun safety advocates. It is important to note that these proposals would not infringe upon the rights of responsible gun owners. Rather, this bill would serve to protect our communities by keeping firearms out of the hands of those who should not have them.

As pediatricians, we work to ensure the health and wellness of our patients – Minnesota's children. Expanded background checks is a necessary tool to protect the youngest in our communities from firearm-related death and injury. I ask that you support SF1116.

Testimony of Ramya Swami, Manager, State Policy, Brady Support for Senate File 1116 Before the House Public Safety Finance and Policy Committee March 23, 2023

Chair Latz, Vice-Chair Verbeten, and Distinguished Members of the Minnesota Senate Judiciary and Public Safety Committee,

Founded in 1974, Brady works across Congress, courts, and communities, uniting gun owners and non-gun owners alike to end America's gun violence epidemic. The epidemic of gun violence reaches communities in Minnesota every day. Every 19 hours, someone in Minnesota is killed by gun violence, with more than 460 Minnesotans dying yearly from gun violence. Minnesota leaders must prioritize the safety and well-being of the people of Minnesota by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. One firearm death is one too many and Minnesota can do more – like pass Senate File 1116 – to save the lives of its citizens.

Support for SF 1116: Universal Background Checks

One of the pillars of Brady's legacy is the critically important role that Jim and Sarah had in creating the federal background check system which, to date, has stopped more than 3 million prohibited purchases.² But we also know that the system has loopholes which enable about every 1 in 5 guns to be sold today without any background check through private transactions, gun shows, and websites that facilitate gun sales online.³ These loopholes allow convicted felons, domestic abusers, and others who wish to do harm to obtain guns without any oversight. It is past time to expand lifesaving Brady background checks to *every* gun sale, and the public agrees: 97 percent of Americans, including over 90 percent of gun owners, support expanding Brady background checks.⁴

Surely we cannot expect to keep guns out of the hands of individuals that are not legally allowed to possess a firearm without ensuring a background check is required universally for public and private gun transfers throughout Minnesota. Brady supports the effort of the House Public Safety Finance and Policy Committee to pass SF 1116, a strong and comprehensive universal background check bill that closes Minnesota's private sale loophole to ensure that firearms don't fall into the hands of individuals who are currently prohibited from purchasing and possessing firearms under state and/or federal law.

Conclusion

In a time when gun violence in the United States is steadily increasing, Minnesota has the opportunity to lead by example by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. For the reasons described above, Brady urges the House Public Safety Finance and Policy Committee to support the passage of SF 1116.

Dear Chairman Latz:

I am writing to you regarding Senate File 1116 (SF 1116) and the National Rifle Association's (NRA) position on this piece of legislation. I would like to express our strong opposition to SF 1116.

The NRA has a number of concerns regarding some of the policies set forth in the bill. The NRA believes that no one should have unreasonable burdens placed on them to own or possess a firearm.

SF 1116 sets up new ways law enforcement can deny a transferee permit. It essentially attempts to incorporate a "red flag" standard into a denial of a transferee permit based on what a law enforcement agent perceives an individual's risk is to themselves or others without due process. Even worse is that the denial can potentially be indefinite.

SF 1116 makes it difficult to loan a firearm to many types of relatives and friends. Minnesota has a strong tradition of hunting and it is common to introduce people into the sport by loaning firearms for hunting purposes. HF1116 requires an onerous process before one could loan such a firearm for that purpose.

HF 1116 adds a requirement for recording serial numbers and other firearms identification information upon each transfer. This sets up a form of government firearm registration. Additionally it sets up unreasonable requirements for retention of paperwork and unreasonable criminal penalties for violations.

For these reasons, and several others, the NRA is opposed to the passage of SF 1116.
