If the letter is submitted on behalf of an organization, that must be disclosed in the file's name as well.

Documents which fail to meet the above criteria or are submitted after the deadline will not be included.

No handouts will be accepted or duplicated by staff during the hearing.

S.F. 2827: Senator Latz: Machine guns regulation modifications.

Oral amendment to A-2: 9.27 delete "624.7144" and insert "624.7174" - Latz moves, adopted by voice

Senator Latz moved that S.F. 1117, as amended, recommended to pass and re-referred to the Finance Committee. - **MOTION PREVAILED**.
