

1.1 **Senator Latz from the Committee on Judiciary and Public Safety, to which was**  
 1.2 **referred**

1.3 **S.F. No. 1959:** A bill for an act relating to labor; modifying peace officer duty disability  
 1.4 provisions; requiring a report; appropriating money; amending Minnesota Statutes 2022,  
 1.5 sections 299A.465, subdivision 4; 352B.10, subdivisions 2a, 4; 352B.101; 353.031,  
 1.6 subdivision 1; proposing coding for new law in Minnesota Statutes, chapters 352B; 353;  
 1.7 626.

1.8 Reports the same back with the recommendation that the bill be amended as follows:

1.9 Delete everything after the enacting clause and insert:

1.10 "Section 1. Minnesota Statutes 2022, section 299A.42, is amended to read:

1.11 **299A.42 PUBLIC SAFETY OFFICER'S BENEFIT ACCOUNT.**

1.12 Subdivision 1. **Public safety officer's benefit account.** The public safety officer's benefit  
 1.13 account is created in the state treasury. Money in the account consists of money transferred  
 1.14 and appropriated to that account. Money in the account that is not expended in the fiscal  
 1.15 year in which it is transferred or appropriated does not revert to the general fund until claims  
 1.16 for reimbursement under section 299A.465 that are submitted in that fiscal year are either  
 1.17 paid or denied.

1.18 Subd. 2. **Annual report.** The commissioner of public safety must annually report, no  
 1.19 later than 30 days after the end of each fiscal year, to the chairs and ranking minority  
 1.20 members of the legislative committees with jurisdiction over public safety and pensions  
 1.21 regarding the financial status of the public safety officer's benefit account and the  
 1.22 reimbursements paid by the commissioner during the preceding fiscal year under sections  
 1.23 299A.465, 352B.102, and 353.032, and payments, if any, made during the preceding fiscal  
 1.24 year under sections 352B.103 and 353.033. If the commissioner anticipates, based on  
 1.25 historical averages, that the public safety officer's benefit account will not have enough  
 1.26 funds to fund all reimbursements the commissioner reasonably anticipates will be requested  
 1.27 under sections 299A.465, 352B.102, and 353.032, and payments for which invoices will  
 1.28 be received under sections 352B.103 and 353.033 for the current and next fiscal year, the  
 1.29 commissioner must include in the report the amounts the commissioner believes are necessary  
 1.30 to fund the anticipated reimbursements and payments.

1.31 Sec. 2. Minnesota Statutes 2022, section 299A.465, subdivision 4, is amended to read:

1.32 Subd. 4. **Public employer reimbursement.** (a) A public employer ~~subject to this section~~  
 1.33 may annually apply by August 1 for the preceding fiscal year to the commissioner of public  
 1.34 safety for reimbursement to help defray a portion of its costs of complying with this section,

2.1 section 352B.102, and section 353.032. Except as provided for in paragraph (b), the  
2.2 commissioner shall provide ~~an equal pro-rata share~~ reimbursement to the public employer  
2.3 out of the public safety officer's benefit account.

2.4 (b) Beginning on January 1, 2024, a public employer is not eligible for reimbursement  
2.5 under paragraph (a) unless the employer provides at least one of the following:

2.6 (1) annual wellness training to peace officers and firefighters who either are employed  
2.7 or volunteer for the employer; or

2.8 (2) an employee assistance program or peer support program.

2.9 (c) Wellness training for peace officers under paragraph (b), clause (1), must incorporate  
2.10 the learning objectives established by the Peace Officer Standards and Training Board under  
2.11 section 626.8478. No later than February 1, 2024, the Minnesota Fire Initiative must create  
2.12 a wellness training program for public employers to offer to firefighters to satisfy the  
2.13 requirements of paragraph (b). Training programs established in the Hometown Heroes  
2.14 Assistance Program under section 299A.477, subdivision 2, clause (4), satisfy the  
2.15 requirements of paragraph (b).

2.16 **EFFECTIVE DATE.** This section is effective July 1, 2023.

2.17 Sec. 3. Minnesota Statutes 2022, section 352B.10, subdivision 1, is amended to read:

2.18 Subdivision 1. **Duty disability.** (a) A member who is determined to qualify for duty  
2.19 disability as defined in section 352B.011, subdivision 7, is entitled to receive a duty disability  
2.20 benefit while disabled. The benefits must be paid monthly. The duty disability benefit is an  
2.21 amount equal to the member's average monthly salary multiplied by 60 percent, plus an  
2.22 additional 3.0 percent for each year and pro rata for completed months of service in excess  
2.23 of 20 years, if any.

2.24 (b) Notwithstanding paragraph (a), if the member has applied for a duty disability based  
2.25 on a psychological condition, the application must be supported by evidence that the applicant  
2.26 is unable to perform the duties of the position held by the applicant on the date of the injury  
2.27 or event or the onset of the mental illness or of another position with the employer which  
2.28 provides salary and employer-provided benefits, including pension benefits, that are equal  
2.29 to or greater than those for the position held by the employee on the date of the injury, event,  
2.30 or onset of the mental illness.

2.31 **EFFECTIVE DATE.** This section is effective July 1, 2023.

3.1 Sec. 4. Minnesota Statutes 2022, section 352B.10, subdivision 2a, is amended to read:

3.2 Subd. 2a. **Applying for benefits; accrual.** No application for disability benefits shall  
3.3 be made until after the last day physically on the job. The disability benefit begins to accrue  
3.4 the day following the last day for which the employee is paid sick leave or annual leave but  
3.5 not earlier than 180 days before the date the application is filed. A member who is terminated  
3.6 must file a written application in an office of the system or with a person authorized by the  
3.7 executive director. Except as otherwise specified under section 352B.102, applications must  
3.8 comply with section 352.113, subdivision 2, paragraph (b).

3.9 **EFFECTIVE DATE.** This section is effective July 1, 2023.

3.10 Sec. 5. Minnesota Statutes 2022, section 352B.10, subdivision 4, is amended to read:

3.11 Subd. 4. **Proof of disability.** (a) No disability benefits may be paid unless the member  
3.12 provides adequate proof to the executive director of the existence of the disability.

3.13 (b) Adequate proof of a disability must include a written expert report by a licensed  
3.14 physician, an APRN, or a licensed chiropractor, or with respect to a mental impairment, by  
3.15 a licensed psychologist. Adequate proof of a disability based on a psychological condition,  
3.16 as defined under section 352B.102, subdivision 1, clause (6), must include the medical  
3.17 reports and assessments required under section 352B.102.

3.18 (c) Following the commencement of benefit payments, the executive director has the  
3.19 right, at reasonable times, to require the disability benefit recipient to submit proof of the  
3.20 continuance of the disability claimed.

3.21 **EFFECTIVE DATE.** This section is effective July 1, 2023.

3.22 Sec. 6. Minnesota Statutes 2022, section 352B.101, is amended to read:

3.23 **352B.101 APPLICATION FOR DISABILITY BENEFIT.**

3.24 (a) Except as otherwise specified under section 352B.102 and paragraph (b), a member  
3.25 claiming a disability benefit must file a written application for benefits in the office of the  
3.26 system in a form and manner prescribed by the executive director. The member shall provide  
3.27 medical or psychological evidence to support the application. The benefit begins to accrue  
3.28 the day following the start of disability or the day following the last day for which the  
3.29 member was paid, whichever is later, but not earlier than 180 days before the date the  
3.30 application is filed with the executive director.

4.1 (b) Notwithstanding any law to the contrary, an employee, as defined in section 352B.102,  
4.2 subdivision 1, clause (2), who applies for a duty disability benefit based on a psychological  
4.3 condition, as defined in section 352B.102, subdivision 1, clause (6), is not eligible for duty  
4.4 disability benefits under this chapter until the employee has satisfied the additional procedure,  
4.5 including all completion of treatment requirements under section 352B.102.

4.6 **EFFECTIVE DATE.** This section is effective July 1, 2023.

4.7 **Sec. 7. [352B.102] APPLICATION FOR PSYCHOLOGICAL CONDITION**  
4.8 **TREATMENT.**

4.9 Subdivision 1. **Definitions.** For the purposes of this section, the following terms have  
4.10 the meanings given:

4.11 (1) "mental illness" means the diagnosis of a mental illness by a mental health  
4.12 professional, by meeting the criteria for a condition or conditions included in the most recent  
4.13 edition of the Diagnostic and Statistical Manual of Mental Disorders published by the  
4.14 American Psychiatric Association;

4.15 (2) "employee" means an individual diagnosed with a mental illness who is a:

4.16 (i) current member under section 352B.011, subdivision 10; or

4.17 (ii) former member under section 352B.011, subdivision 10, within 18 months of  
4.18 termination of employment;

4.19 (3) "employing entity" means the entity that pays a state employee's salary and remits  
4.20 retirement contributions;

4.21 (4) "mental health professional" has the meaning given in section 245I.02, subdivision  
4.22 27;

4.23 (5) "peace officer" has the meaning given in section 299A.465, subdivision 5, paragraph  
4.24 (a);

4.25 (6) "psychological condition" means a mental illness as defined in clause (1); and

4.26 (7) "treatment" includes but is not limited to active participation in psychological,  
4.27 psychopharmaceutical, and functional neurological approaches and active participation in  
4.28 the International Association of Fire Fighters Center of Excellence for Behavioral Health  
4.29 Treatment and Recovery. Treatment includes utilization of multiple treatment modalities,  
4.30 including chemical dependency treatment when indicated, and evidence-based trauma  
4.31 treatment.

5.1 Subd. 2. **Application; dual diagnosis.** (a) Notwithstanding any law to the contrary, and  
5.2 except as provided in paragraph (b), the procedure in this section applies to an application  
5.3 for a duty disability by an employee based on the employee's psychological condition.

5.4 (b) The additional procedure in this section does not apply to a duty disability application  
5.5 under paragraph (a) that is also based on a dual diagnosis of a physical condition. An  
5.6 employee with a dual diagnosis may, but is not required to, seek treatment under subdivisions  
5.7 4 and 7, subject to the procedure in this section.

5.8 Subd. 3. **Approval.** (a) An employee who applies for treatment of a psychological  
5.9 condition that was a result of the performance of duties related to the employee's occupation  
5.10 must receive approval for psychological treatment as provided under this subdivision.

5.11 (b) The executive director shall grant approval to an employee who submits, in the form  
5.12 and manner specified by the executive director:

5.13 (1) a report by a mental health professional diagnosing the employee with a mental  
5.14 illness and finding that the employee is currently unable to perform the normal duties of  
5.15 the position held by the employee on the date of the injury, event, or onset of the mental  
5.16 illness on a full- or part-time basis; and

5.17 (2) documentation from the employer certifying the dates the employee was on duty in  
5.18 a position covered under the State Patrol plan.

5.19 (c) An employee who receives approval under this subdivision is not considered disabled  
5.20 for the purposes of a duty disability under section 352B.10, unless the employee completes  
5.21 the additional requirements under this section, receives final confirmation under subdivision  
5.22 6, and applies for disability benefits under section 352B.101 before receiving duty disability  
5.23 benefits or related benefits.

5.24 (d) Within six business days after the application has been received by the executive  
5.25 director, the executive director must notify an employing entity electronically and by mail  
5.26 that an application for treatment of a psychological condition has been submitted by an  
5.27 employee and request the certification required under paragraph (b), clause (2), from the  
5.28 employing entity.

5.29 (e) An employer shall submit the certification required under paragraph (b), clause (2),  
5.30 within five business days of an employee's application, and the employee shall receive  
5.31 approval no later than 14 business days after the employee's application is received by the  
5.32 executive director, whether or not the employer's certification has been submitted. Nothing  
5.33 in this paragraph shall delay the treatment of the psychological condition of the employee.

6.1 Subd. 4. Treatment required. (a) Except as provided in paragraph (f), an employee  
6.2 who receives approval under subdivision 3 shall complete up to 24 consecutive weeks of  
6.3 active treatment modalities for the employee's diagnosed mental illness, as provided under  
6.4 this subdivision, before a final confirmation can be made under subdivision 6, paragraph  
6.5 (a). An employee's treatment shall be at the direction of a mental health professional using  
6.6 treatment modalities indicated for the treatment of the diagnosed mental illness. An employee  
6.7 shall not be penalized for an interruption in active, consecutive treatment that is not initiated  
6.8 by or resulting from an intentional action of the employee. Subject to the limit under  
6.9 subdivision 9, the employing entity shall pay for the treatment costs and may seek  
6.10 reimbursement from the commissioner of public safety.

6.11 (b) The employee's mental health professional must assess the employee's progress in  
6.12 treatment monthly and at the end of the 24 weeks or earlier, including any change to the  
6.13 employee's ability to return to the position held by the employee on the date of the injury,  
6.14 event, or onset of the mental illness, or to another position with the employing entity which  
6.15 provides salary and employing entity-provided benefits, including pension benefits, that  
6.16 are equal to or greater than those for the position held by the employee on the date of the  
6.17 injury, event, or onset of the mental illness. A final confirmation under subdivision 6 must  
6.18 be supported by a report from the employee's mental health provider containing an opinion  
6.19 about the employee's prognosis, the duration of the disability, and the expectations for  
6.20 improvement following the treatment. A report that does not contain and support a finding  
6.21 that the employee's disability as a result of a psychological condition will last for at least  
6.22 12 months must not be relied upon to support approval of duty disability benefits.

6.23 (c) The employee may return to full- or part-time work prior to the completion of the  
6.24 24 weeks of treatment if the employee's mental health professional determines that the  
6.25 employee is medically able to do so.

6.26 (d) The employee may return to light duty assignments, subject to availability of a  
6.27 position, prior to the completion of the 24 weeks of treatment, if deemed medically  
6.28 appropriate by the employee's mental health professional and with the employing entity's  
6.29 approval.

6.30 (e) A fitness for duty presumption shall apply to an employee who is cleared to return  
6.31 to work or light duty under paragraph (c) or (d), except as provided under subdivision 10.

6.32 (f) No employee shall be required to complete treatment under this subdivision more  
6.33 than three times in ten years.

7.1 Subd. 5. Continuation of salary and benefits. (a) Subject to subdivision 9, for the  
7.2 period that an employee is seeking psychological condition treatment approval under  
7.3 subdivision 3 or 6, appealing a determination thereof, or receiving treatment under  
7.4 subdivision 4 or 7, the employing entity shall continue:

7.5 (1) to pay, for a current employee only, the employee's full salary and employing  
7.6 entity-provided benefits, including any employing entity contribution to health care and  
7.7 retirement benefits. The employing entity must proportionally reduce the salary paid to an  
7.8 employee who is otherwise receiving benefits for the disability that provide compensation  
7.9 for all or a portion of the employee's salary for the same time period. Nothing in this  
7.10 paragraph requires an employing entity to pay more than 100 percent of the employee's  
7.11 salary;

7.12 (2) to provide health insurance benefits to the employee and to the employee's dependents,  
7.13 if the employee was receiving dependent coverage at the time of the injury, event, or onset  
7.14 of the mental illness under the employing entity's group health plan; and

7.15 (3) to provide any other employment benefits provided to the employee under the  
7.16 employee's currently applicable collective bargaining agreement.

7.17 (b) The treatment period required under subdivision 4 or 7 is allowable service under  
7.18 section 352B.011, subdivision 3.

7.19 (c) Nothing in this section prevents an employing entity from providing benefits in  
7.20 addition to those required by this section or otherwise affects an employee's rights with  
7.21 respect to any other employment benefit.

7.22 (d) If an employee is unable to receive treatment through the prescribed treatment  
7.23 program due to circumstances beyond the employee's control, which includes but is not  
7.24 limited to a lack of availability of a mental health facility or a mental health professional,  
7.25 the employee shall continue to receive their regular compensation, benefits, and retirement  
7.26 service credits until such mental health facility or mental health professional becomes  
7.27 available to the employee for their treatment program. The continuation of salary and benefits  
7.28 allowed under this paragraph must not exceed 30 days beyond the day treatment is prescribed,  
7.29 except that the continuation of benefits and salary may be extended beyond 30 days if written  
7.30 documentation from the mental health facility or mental health professional providing the  
7.31 treatment start date is submitted by the employee to the executive director and the employer.

7.32 Subd. 6. Termination or continuation of psychological condition treatment. (a)  
7.33 Following completion of treatment under subdivision 4, the executive director shall confirm  
7.34 the treatment requirements are satisfied and make one of the following determinations:

8.1 (1) continue the approval for an additional eight weeks for the employee to complete  
8.2 additional treatment, as provided under subdivision 7;

8.3 (2) terminate the psychological condition treatment because the employee is:

8.4 (i) able to return to full-time work in the position held by the employee on the date of  
8.5 the injury, event, or onset of the mental illness; or

8.6 (ii) able to return to another vacant full-time position with the employer which provides  
8.7 salary and employer-provided benefits, including pension benefits, that are equal to or  
8.8 greater than those for the position held by the employee on the date of the injury, event, or  
8.9 onset of the mental illness, as certified by the employer in the form and manner specified  
8.10 by the executive director; or

8.11 (3) confirm the employee has met the requirements under this section, after which the  
8.12 employee may apply for a duty disability benefit under section 352B.10.

8.13 (b) After confirmation and application under paragraph (a), clause (3), the executive  
8.14 director must approve the employee's application for disability benefits if the employee is  
8.15 eligible under sections 352B.10 and 352B.101, at which time the employee is entitled to  
8.16 receive disability benefits as provided under section 352B.10 and any related benefits. The  
8.17 disability benefit begins to accrue the day following the day on which the employer ceases  
8.18 to continue salary and benefits under subdivision 5 or the date permitted under section  
8.19 352B.10, subdivision 2a, whichever is later.

8.20 (c) Following completion of the additional treatment requirements under subdivision 7,  
8.21 if applicable, the executive director must confirm the additional treatment requirements are  
8.22 satisfied, after which, the employee may apply for disability benefits. The executive director  
8.23 must approve the employee's application for disability benefits if because the employee is  
8.24 eligible under sections 352B.10 and 352B.101, at which time the employee is entitled to  
8.25 receive disability benefits as provided under section 352B.10 and any related benefits. The  
8.26 disability benefit begins to accrue the day following the day on which the employer ceases  
8.27 to continue salary and benefits under subdivision 5 or the date permitted under section  
8.28 352B.10, subdivision 2a, whichever is later.

8.29 (d) A fitness for duty presumption shall apply to an employee who is determined able  
8.30 to return to work as provided under paragraph (a), clause (2), except as provided under  
8.31 subdivision 10.

8.32 Subd. 7. **Additional treatment.** (a) Except as provided in paragraph (g), if, after  
8.33 completing the treatment required under subdivision 4, the mental health professional's



9.1 report determines that the employee is making progress in treatment, and the employee's  
9.2 prognosis is expected to further improve with additional treatment, the executive director  
9.3 shall continue the employee's initial approval under subdivision 6, paragraph (a), clause  
9.4 (1), and the employee shall complete up to an additional eight consecutive weeks of active  
9.5 treatment modalities as provided under this subdivision.

9.6 (b) Treatment shall be at the direction of a mental health professional using treatment  
9.7 modalities indicated for the treatment of the employee's diagnosed mental illness. An  
9.8 employee shall not be penalized for an interruption in active, consecutive treatment that is  
9.9 not initiated by or resulting from an intentional action of the employee. Subject to subdivision  
9.10 9, the employing entity shall pay for the treatment costs and may seek reimbursement from  
9.11 the commissioner of public safety.

9.12 (c) The employee's mental health professional must assess the employee's progress in  
9.13 treatment at the end of eight weeks, including any change to the employee's ability to return  
9.14 to the position held by the employee on the date of the injury, event, or onset of the mental  
9.15 illness, or to another position with the employing entity which provides salary and employing  
9.16 entity-provided benefits, including pension benefits, that are equal to or greater than those  
9.17 for the position held by the employee on the date of the injury, event, or onset of the mental  
9.18 illness. A final confirmation under subdivision 6, paragraph (c), must be supported by an  
9.19 updated report from the employee's mental health provider containing an opinion about the  
9.20 employee's prognosis, the duration of the disability, and the expectations for improvement  
9.21 following the additional treatment. An updated report that does not contain and support a  
9.22 finding that the employee's disability as a result of a psychological condition will last for  
9.23 at least 12 months must not be relied upon to support approval of duty disability benefits.

9.24 (d) The employee may return to full- or part-time work prior to the completion of the  
9.25 eight weeks of treatment if the employee's mental health professional determines that they  
9.26 are medically able to do so.

9.27 (e) The employee may return to light duty assignments, subject to availability of a  
9.28 position, prior to the completion of the eight weeks of treatment, if deemed medically  
9.29 appropriate by the employee's mental health professional and with the employing entity's  
9.30 approval.

9.31 (f) A fitness for duty presumption shall apply to an employee who is cleared to return  
9.32 to work or light duty under paragraph (d) or (e), except as provided under subdivision 10.

9.33 (g) No employee shall be required to complete treatment under this subdivision more  
9.34 than three times in ten years.

10.1 Subd. 8. **Treatment data.** A "health record," as defined by section 144.291, subdivision  
10.2 2, paragraph (c), arising from treatment sought under this section is classified as private  
10.3 data on individuals, as defined by section 13.02, subdivision 12, and must not be accessed  
10.4 by, shared with, or disclosed or disseminated to any individual, private entity, or government  
10.5 entity, including through discovery, search warrant, or subpoena, in any type of investigation  
10.6 or legal action.

10.7 Subd. 9. **Employing entity reimbursement; limit.** (a) Except as provided in paragraph  
10.8 (c), an employing entity subject to this section may annually apply by August 1 for the  
10.9 preceding fiscal year to the commissioner of public safety for reimbursement of:

10.10 (1) the treatment costs incurred by the employing entity under subdivision 4 or 7; and

10.11 (2) the costs incurred to continue salary and benefits as required under subdivision 5.

10.12 (b) An employing entity must apply for the reimbursement in the form and manner  
10.13 specified by the commissioner of public safety.

10.14 (c) No employing entity shall be required to pay for the salary, benefits, and treatment  
10.15 costs required under subdivisions 4, 5, and 7 for a single employee more than three times  
10.16 in ten years.

10.17 Subd. 10. **Fitness for duty presumption.** (a) An employee who is cleared or determined  
10.18 able to return to work or light duty under subdivision 4, paragraph (e); 6, paragraph (c); or  
10.19 7, paragraph (f), is presumed fit for duty, except as follows:

10.20 (1) an employing entity may request a fitness for duty exam by an independent medical  
10.21 provider if the exam is completed within six weeks of the employing entity receiving the  
10.22 determination from the treating mental health professional, and the independent medical  
10.23 provider's report is completed no more than six weeks later;

10.24 (2) an employee found unfit for duty by an independent medical provider under clause  
10.25 (1):

10.26 (i) is presumed eligible for a duty disability, as provided under subdivision 6, paragraph  
10.27 (a), clause (3); or

10.28 (ii) may appeal the independent medical provider's determination by requesting an  
10.29 examination under paragraph (c); and

10.30 (3) the fitness-for-duty timeline under this paragraph may be modified by mutual  
10.31 agreement of the employing entity and employee.

11.1 (b) Nothing in this section shall be deemed to affect the Americans with Disabilities  
 11.2 Act, United States Code, title 42, chapter 126; the Family Medical Leave Act, United States  
 11.3 Code, title 29, chapter 28; or the Minnesota Human Rights Act, chapter 363A.

11.4 (c) An employee who wishes to appeal the independent medical provider's determination  
 11.5 under paragraph (a), clause (2), item (ii), may request an examination by a qualified  
 11.6 professional selected by the employee from a panel established by mutual agreement among  
 11.7 the League of Minnesota Cities, the Association of Minnesota Counties, the Minnesota  
 11.8 Peace and Police Officers Association, the Minnesota Professional Fire Fighters Association,  
 11.9 the Minnesota Chiefs of Police Association, and the Minnesota Law Enforcement  
 11.10 Association. The panel shall consist of five licensed psychiatrists or psychologists who have  
 11.11 expertise regarding psychological or emotional disorders and who are qualified to opine as  
 11.12 to the employee's fitness to engage in police or firefighting duties. The agreed upon panel  
 11.13 of qualified professionals must be submitted to the executive director and made available  
 11.14 for use in the appeal process. If the employee fails to select a qualified professional from  
 11.15 the panel within ten days of any notice of appeal, the employing entity may select the  
 11.16 qualified professional from the panel. A determination made by a qualified professional  
 11.17 under this item is binding and not subject to appeal. The panel may be the same panel as  
 11.18 the panel established under section 353.032, subdivision 10.

11.19 Subd. 11. **Report.** No later than four years after the day following final enactment of  
 11.20 this act, the executive director, in coordination with employing entities, employees, and  
 11.21 mental health professionals, shall submit a report to the chairs and ranking minority members  
 11.22 of the legislative committees with jurisdiction over labor and pensions regarding the impact


