

1.1 A bill for an act
1.2 relating to capital investment; authorizing spending to acquire and better land and
1.3 buildings and for other improvements of a capital nature with certain conditions;
1.4 canceling prior appropriations; appropriating money; creates a grant program;
1.5 proposing coding for new law in Minnesota Statutes, chapter 138.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 **ARTICLE 1**
1.8 **APPROPRIATIONS**

1.9 Section 1. **CAPITAL IMPROVEMENT APPROPRIATIONS.**

1.10 (a) The sums shown in the column under "Appropriations" are appropriated from the
1.11 general fund in fiscal year 2024 to the state agencies or officials indicated, to be spent for
1.12 public purposes. These are onetime appropriations. Money appropriated in this act is available
1.13 until the project is completed or abandoned, subject to Minnesota Statutes, section 16A.642.

1.14 (b) For any project funded in whole or in part by this act, workers on the project must
1.15 be paid at least the prevailing wage rate as defined in Minnesota Statutes, section 177.42,
1.16 subdivision 6, and the requirements of Minnesota Statutes, sections 177.27, 177.30, 177.32,
1.17 and 177.41 to 177.45 apply. For the purposes of this act, "project" means the acquisition of
1.18 property, predesign, design, erection, construction, remodeling, or repairing of a building,
1.19 facility, or other capital project financed in whole or part by state funds.

1.20 (c) Money appropriated in this act is available for a grant after the commissioner of
1.21 management and budget determines that an amount sufficient to complete the project as
1.22 described in this act has been committed to the project, as required by Minnesota Statutes,
1.23 section 16A.502.

3.14 recreation area.

3.15 (d) \$50,000 of this appropriation is for
3.16 predesign, design, and construction of capital
3.17 improvements to the Quad Cities all-terrain
3.18 vehicle trail to repair erosion damage, improve
3.19 storm water management, and widen the trail.

3.20 (e) Any unexpended amount for a project
3.21 described in paragraph (b), (c), or (d) that has
3.22 been substantially completed may be applied
3.23 to any other project described in this
3.24 subdivision.

3.25 **Subd. 5. Nett Lake Dam** 3,000,000
3.26 For design, engineering, and construction to
3.27 repair and reconstruct the Nett Lake dam in
3.28 Koochiching County.

3.29 **Subd. 6. Canisteo Legacy Mine Pit Complex** 8,875,000
3.30 (a) For the acquisition of land or interests in
3.31 land and for construction of publicly owned
3.32 infrastructure to mitigate the imminent threat
3.33 to public safety, property, and regional water

4.1 quality from the rising water at the Canisteo
4.2 legacy mine pit complex.

4.3 (b) Upon substantial completion of the project
4.4 authorized in this subdivision and after written
4.5 notice to the commissioner of management
4.6 and budget, the commissioner of natural
4.7 resources may use any money remaining in
4.8 this appropriation to design, engineer, and
4.9 construct publicly owned water mitigation
4.10 infrastructure at the Hill annex open pit mining
4.11 complex.

4.12 (c) Notwithstanding Minnesota Statutes,
4.13 sections 92.50 and 282.04, or other law to the
4.14 contrary, the commissioner and the county
4.15 may enter into leases for this project for a term
4.16 that is consistent with meeting project needs.

4.17 A lease entered into under this subdivision
4.18 must include a provision that provides for the
4.19 amendment or termination of the lease when
4.20 (1) the commissioner of natural resources
4.21 determines that the project is no longer needed
4.22 to serve the intended purpose or identifies a
4.23 more effective alternative to the constructed
4.24 project; or (2) mining operations are fully
4.25 permitted to resume in all or part of the
4.26 property acquired or improved with this
4.27 appropriation.

29.23 **Section 1. [138.935] MINNESOTA HISTORICAL SOCIETY; HISTORIC BUILDING**
29.24 **FACADE GRANT PROGRAM.**

29.25 Subdivision 1. Establishment. The Minnesota Historical Society shall establish a
29.26 statewide historic building facade grant program to provide grants to municipalities that
29.27 meet the eligibility criteria provided under subdivision 3. The initial pilot program shall
29.28 provide one or more grants to the city of Litchfield.

29.29 Subd. 2. Definition. For the purposes of this section, "municipality" means a home rule
29.30 charter or statutory city or a town.

29.31 Subd. 3. Eligibility. Eligible municipalities must have:

30.1 (1) for cities, a population of less than 15,000; or

30.2 (2) for towns, a population of less than 10,000; and

30.3 (3) a commercial historic district listed on the National Register of Historic Places.

30.4 Subd. 4. **Grant agreements.** (a) A municipality awarded a grant under this section must
30.5 enter into grant agreements with owners of properties in the municipality that:

30.6 (1) are located within the boundaries of the commercial historic district; and

30.7 (2) have facades that are historic in nature.

30.8 (b) A property owner grantee under paragraph (a) must use the money to rehabilitate
30.9 the building facade of a property that meets the criteria in paragraph (a). The rehabilitation
30.10 must be consistent with the standards for rehabilitation under Code of Federal Regulations,
30.11 title 36, section 67.7, and guidance from the Minnesota Historical Society. The rehabilitation
30.12 must be completed within two years from the date the property owner grantee received the
30.13 grant. Any unused money must be returned to the Minnesota Historical Society for deposit
30.14 in the general fund.

30.15 (c) The Minnesota Historical Society shall prescribe the form of the grant agreement in
