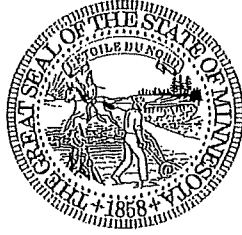

I write to express my interest in the Tax Court Judge position posted via the Secretary of State, Boards and Commissions website. I am a 1993 graduate of the University of Minnesota Law School, and am currently employed as an Assistant Attorney General in the Tax Division of the Office of the Attorney General.

If selected for this appointment, I would bring extensive, sophisticated litigation experience, management expertise, judicial temperament, and many years of proven commitment to public service to the Minnesota Tax Court. Service on the Tax Court also would afford me the opportunity to continue my career in public service for the benefit of the State of Minnesota, on a Court known for its challenging array of substantive legal issues.

Broad Experience:

For most of my career, I have worked in public service, principally focusing on litigation matters. Since returning to Minnesota in 2016, I have represented various State agencies as an Assistant Attorney General, principally providing representation in tax, bankruptcy, and commercial litigation matters. Before working for the Attorney General, I served as a line attorney at the Civil Division of the Department of Justice in Washington, DC from 2000 to 2007 and then as a Deputy Assistant Director in DOJ's Executive Office for United States Trustees from 2008 through 2016. I also have represented private clients as both a partner and an associate handling complex bankruptcy and commercial litigation matters. As a result of my expertise in such financial litigation matters, I have served on the annual faculty of the Cambridge International Symposium on Economic Crime since 2003 at the University of Cambridge.

As a Deputy at DOJ, I managed up to fifteen people, including attorneys, financial analysts, and clerical staff. I also managed a rolling docket of administrative cases, numbering in the hundreds at all times, as well as a docket of enforcement proceedings. These required me to prioritize effectively and to exercise appropriate judgment and discretion when allocating limited financial and human resources.

Commitment to Public Service:

As stated above, I have devoted over twenty years of my career to public service, in both state and federal government. My public service experience dates to an internship with the Resolution Trust Corporation following my first year of law school, and continues through today. I believe the State and its taxpayers deserve the highest quality service from judges who display fairness and respect for litigants, and who espouse equal access to the law and the integrity of legal process and institutions. This is particularly important at the trial court level, which will be the only encounter with the court system for most members of the public. I believe in safeguarding public confidence in the court system, and our government, through building trust in the integrity of the trial courts.

Judicial Temperament:

Over the past two decades in both public and private practice, I have developed the temperament and judicious disposition essential for service on the bench. Experience in both public and private practice has given me the necessary perspective and pragmatism to consider all sides of a dispute. My professional responsibilities require me to exercise good judgment, to be decisive in difficult situations and in the face of competing interests, and to communicate effectively in court, with clients and opponents, and with colleagues.

My responsibilities as an attorney for the government have required me to consider the best interests of the public as a whole when enforcing the law, and not only the immediate representation of my client agencies. Accordingly, I have consistently endeavored to apply judicial principles of fairness, reasonableness, and equal access to legal institutions and procedures in making litigation decisions and regulatory determinations. During my last year as Deputy at DOJ, I co-led a nationwide working group to address practice and ethical challenges resulting from underperforming consumer bankruptcy attorneys (typically serving lower-income clients), and to develop nationwide litigation standards before the bankruptcy courts for cases involving those attorneys. I also served for several years as the US Trustee Program's Representative on the DOJ Language Access Working Group, which develops and implements policies to ensure equal access to DOJ programs and the court system for individuals with limited English proficiency.
