

1.1 **Senator Putnam from the Committee on Agriculture, Broadband, and Rural**  
1.2 **Development, to which was referred**

1.3 **S.F. No. 3458:** A bill for an act relating to state government; amending the classification  
1.4 of commercial dog and cat breeder data collected and maintained by the Board of Animal  
1.5 Health; modifying kennel and dealer advertising requirements; requiring the Board of Animal  
1.6 Health to post certain kennel, dealer, and commercial breeder information; amending  
1.7 Minnesota Statutes 2022, sections 347.36; 347.58, subdivisions 2, 5; Minnesota Statutes  
1.8 2023 Supplement, section 13.643, subdivision 6; proposing coding for new law in Minnesota  
1.9 Statutes, chapter 347.

1.10 Reports the same back with the recommendation that the bill be amended as follows:

1.11 Page 2, line 8, delete "POSTING OF" and insert "SHARING"

1.12 Page 2, delete line 9 and insert:

1.13 "Upon request from a member of the public, the board must share the following  
1.14 information:"

1.15 Page 2, line 10, delete everything before "licensed" and insert "(1) whether a kennel or  
1.16 dealer is"

1.17 Page 2, line 12, delete everything after "confined" and insert "on the date of the last  
1.18 inspection;"

1.19 Page 2, delete lines 13 and 14

1.20 Page 2, line 15, delete everything before "copies" and insert "(2)"

1.21 Page 2, line 16, delete the period and insert "; and"

1.22 Page 2, delete line 17

1.23 Page 2, line 18, delete everything before "expired" and insert "(3) whether a kennel's or  
1.24 dealer's license has" and delete "have"

1.25 Page 2, line 20, delete "in" and insert "on the date of the last inspection."

1.26 Page 2, delete line 21

1.27 Page 2, line 31, delete "and the address and name of the facility" and insert "the name  
1.28 of the facility and the city or township in which the facility is located"

1.29 Page 3, delete section 5 and insert:

2.1 "Sec. 5. Minnesota Statutes 2022, section 347.58, subdivision 5, is amended to read:

2.2 Subd. 5. ~~Posting of~~ **Sharing information.** (a) The board must maintain and post in a  
2.3 timely manner on ~~its~~ the board's public website a list of commercial breeders licensed and  
2.4 in good standing under this section.

2.5 (b) Upon request from a member of the public, the board must share the following  
2.6 information:

2.7 (1) any business names that a commercial breeder uses in connection with the sale of  
2.8 dogs or cats and the total number of animals produced and sold in the previous year;

2.9 (2) copies of the three most recent inspection report forms submitted to the board under  
2.10 subdivision 2; and

2.11 (3) whether a commercial breeder's license has expired or been revoked by the board  
2.12 during the last three years, including all business names that the commercial breeder used  
2.13 in connection with the sale of dogs or cats and any reasons for revocation."

2.14 And when so amended the bill do pass and be re-referred to the Committee on Judiciary  
2.15 and Public Safety. Amendments adopted. Report adopted.
