# Reinvest in Minnesota (RIM): \$10M



\$10M in bonding is requested to acquire conservation easements from landowners.

Purposes:

- to preserve, restore, create, and enhance wetlands and associated uplands of prairie and grasslands
- restore and enhance rivers and streams, riparian lands, and associated uplands to protect soil and water quality, support fish and wildlife habitat, reduce flood damage, increase climate resiliency, and provide other public benefits.

An agreement remains allowing an opportunity for a federal match.



# Local Government Roads Wetland Replacement Program: \$4.5M



\$2.5M in GO Bonds and \$2M in GF is requested in 2024 to address BWSR statutory requirements to replace wetlands and wetland areas of public waters drained or filled by public transportation projects on existing roads.



These funds will restore and permanently protect wetlands and generate wetland replacement (mitigation) credits for the Local Government Roads Wetland Replacement Program (LGRWRP) to meet requirements.

**Average annual demand is 170 credits.**

# Local Government Roads Wetland Replacement Program: \$4.5M



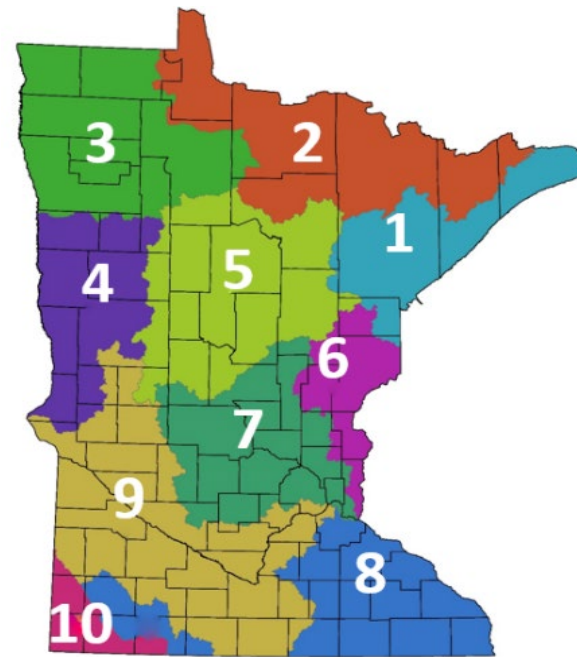
- Larger, higher-quality wetland mitigation
- More cost-efficient
- Expedited permitting





# The Need

- When available credits in an area are insufficient, credits are taken from the closest area with a positive balance at an extra cost.
- Credit needs are driven by road construction activity (exacerbated by federal funding).
- It typically takes at least 7 years from when funds become available until all credits are deposited.
