1.12	(1) must be paid in order to purchase the goods or services being advertised;
1.13	(2) is not reasonably avoidable by the consumer; or
1.14	(3) a reasonable consumer would expect to be included in the purchase of the goods or

1.16	(c) For the purposes of this subdivision, mandatory fee does not include:
1.17	(1) taxes imposed by a government entity on the sale, use, purchase, receipt, or delivery

1.19	(2) fees related to the purchase or lease of a motor vehicle which are authorized by
1.20	Minnesota Statutes.
1.21	(d) A delivery platform must comply with the following requirements:
1.22	(1) at the point when a consumer views and selects either a vendor or items for purchase,
1.23	a delivery platform must display in a clear and conspicuous manner that an additional flat
1.24	fee or percentage will be charged. The disclosure must include the additional fee or
1.25	percentage amount; and
1.26	(2) after a consumer selects items for purchase, but prior to checkout, a delivery platform
1.27	must display a subtotal page that itemizes the price of the menu items and the additional
1.28	fee that will be included in the total cost.
1.29	(d) A person may charge a reasonable postage or shipping fee that will be actually
1.30	incurred by a consumer who has purchased a good that requires shipping.
