2.9 means cigarettes, cigars, chewing or pipe tobacco, or any other item that contains tobacco.  
2.10 For purposes of this subdivision, "taxable cannabis product" has the meaning given in section  
2.11 295.81, subdivision 1, paragraph (†), ~~"medical cannabis flower" has the meaning given in~~  
2.12 ~~section 342.01, subdivision 54, and "medical cannabinoid product" has the meaning given~~  
2.13 ~~in section 342.01, subdivision 52 (o)~~. For purposes of this subdivision, "dietary supplements"  
2.14 means any product, other than tobacco, intended to supplement the diet that:

2.15 (1) contains one or more of the following dietary ingredients:

2.16 (i) a vitamin;

2.17 (ii) a mineral;

2.18 (iii) an herb or other botanical;

2.19 (iv) an amino acid;

2.20 (v) a dietary substance for use by humans to supplement the diet by increasing the total  
2.21 dietary intake; and

2.22 (vi) a concentrate, metabolite, constituent, extract, or combination of any ingredient  
2.23 described in items (i) to (v);

2.24 (2) is intended for ingestion in tablet, capsule, powder, softgel, gelcap, or liquid form,  
2.25 or if not intended for ingestion in such form, is not represented as conventional food and is  
2.26 not represented for use as a sole item of a meal or of the diet; and

2.27 (3) is required to be labeled as a dietary supplement, identifiable by the supplement facts  
2.28 box found on the label and as required pursuant to Code of Federal Regulations, title 21,
