

Senator ..... moves to amend the delete-everything amendment (SCH4757A-1) to H.F. No. 4757 as follows:

Page 7, line 23, delete everything after "be" and insert "consumed through oral administration or intended to be consumed in combination with food products including beverages."

Page 7, delete line 24

Page 10, line 2, after the period, insert "If it is not possible to indicate a single serving by scoring or use of another indicator that appears on the product, the edible cannabinoid product may not be packaged in a manner that includes more than a single serving in each container, except that a calibrated dropper, measuring spoon, or similar device for measuring a single serving, when sold with the product, may be used for any tincture, or other edible cannabinoid products that are intended to be combined with food products, to include beverages, prior to consumption."

Page 35, after line 18, insert:

"Sec. 44. Minnesota Statutes 2023 Supplement, section 342.01, is amended by adding a subdivision to read:

Subd. 69a. **Tincture.** "Tincture" means a solution of hemp extract, derived either directly from a hemp plant or from a manufactured hemp extract, dissolved in glycerin, food-grade oils, or other food-grade solvents and that is intended to be consumed through oral administration or intended to be consumed in combination with food products, including beverages."

Page 75, after line 24, insert:

"Sec. 86. Minnesota Statutes 2023 Supplement, section 342.46, subdivision 6, is amended to read:

Subd. 6. **Compliant products.** (a) A lower-potency hemp edible retailer shall ensure that all lower-potency hemp edibles offered for sale comply with the limits on the amount and types of cannabinoids that a lower-potency hemp edible can contain, including but not limited to the requirement that lower-potency hemp edibles:

(1) consist of servings that contain no more than five milligrams of delta-9 tetrahydrocannabinol, no more than 25 milligrams of cannabidiol, no more than 25 milligrams of cannabigerol, or any combination of those cannabinoids that does not exceed the identified amounts;

2.1 (2) do not contain more than a combined total of 0.5 milligrams of all other cannabinoids  
2.2 per serving; and

2.3 (3) do not contain an artificially derived cannabinoid other than delta-9  
2.4 tetrahydrocannabinol.

2.5 (b) If a lower-potency hemp edible is packaged in a manner that includes more than a  
2.6 single serving, the lower-potency hemp edible must indicate each serving by scoring,  
2.7 wrapping, or other indicators that appear on the lower-potency hemp edible designating the  
2.8 individual serving size. If it is not possible to indicate a single serving by scoring or use of  
2.9 another indicator that appears on the product, the lower-potency hemp edible may not be  
2.10 packaged in a manner that includes more than a single serving in each container, except  
2.11 that a calibrated dropper, measuring spoon, or similar device for measuring a single serving  
2.12 may be used for any tincture, or other edible cannabinoid products that are intended to be  
2.13 combined with food products, including beverages, prior to consumption. If the lower-potency  
2.14 hemp edible is meant to be consumed as a beverage, the beverage container may not contain  
2.15 more than two servings per container.

2.16 (c) A single package containing multiple servings of a lower-potency hemp edible must  
2.17 contain no more than 50 milligrams of delta-9 tetrahydrocannabinol, 250 milligrams of  
2.18 cannabidiol, 250 milligrams of cannabigerol, or any combination of those cannabinoids that  
2.19 does not exceed the identified amounts."
