The maximum total refund per calendar year for 2.18 an individual must not exceed \$75 and for a married couple, filing jointly, must not exceed 2.19 \$150. The commissioner must not issue a refund, whether in one payment or in aggregate, 2.20 to a taxpayer that exceeds the maximum refund amounts specified in this subdivision. A 2.21 refund of a contribution is allowed only if the taxpayer files a form required by the 2.22 commissioner and attaches to the form a copy of an official refund receipt form issued by 2.23 the candidate or party and signed by the candidate, the treasurer of the candidate's principal 2.24 campaign committee, or the chair or treasurer of the party unit, after the contribution was 2.25 received. 3.10 (3) has designated a principal campaign committee.
