

1.1 **Senator Carlson from the Committee on Elections, to which was referred**

1.2 **S.F. No. 4260:** A bill for an act relating to elections; transferring money to the voting
1.3 operations, technology, and election resources account.

1.4 Reports the same back with the recommendation that the bill be amended as follows:

1.5 Delete everything after the enacting clause and insert:

1.6 "Section 1. Laws 2021, First Special Session chapter 12, article 1, section 6, is amended
1.7 to read:

1.8 Sec. 6. **SECRETARY OF STATE** \$ 9,684,000 \$ 9,152,000

1.9 \$750,000 each year is for transfer to the voting
1.10 equipment grant account under Minnesota
1.11 Statutes, section 206.95. These are onetime
1.12 transfers.

1.13 \$1,000,000 each year is for grants to local
1.14 units of government to implement the
1.15 provisions of Minnesota Statutes, section
1.16 203B.082. These are onetime appropriations.

1.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.

1.24 \$500,000 the first year is for the secretary of
1.25 state to make grants to counties and
1.26 municipalities to improve access to polling
1.27 places for individuals with disabilities and to
1.28 provide the same opportunity for access and
1.29 participation in the electoral process, including
1.30 privacy and independence, to voters with
1.31 disabilities as that which exists for voters with
1.32 no disabilities. Funds may be used to purchase

2.1 equipment or to make capital improvements
2.2 to government-owned facilities. This is a
2.3 onetime appropriation and is available until
2.4 June 30, 2027.

2.5 \$200,000 the first year is to develop and
2.6 implement an educational campaign relating
2.7 to the restoration of the right to vote to
2.8 formerly incarcerated individuals, including
2.9 voter education materials and outreach to
2.10 affected individuals.

2.11 \$2,250,000 the first year and \$3,450,000 the
2.12 second year are for transfer to the voting
2.13 operations, technology, and election resources
2.14 account established under Minnesota Statutes,
2.15 section 5.305. The base for this transfer in
2.16 fiscal years 2026 and 2027 is \$3,100,000.

2.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.26 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.27 Sec. 4. **CAMPAIGN FINANCE BOARD; APPROPRIATION.**

2.28 \$50,000 in fiscal year 2025 is appropriated from the general fund to the Campaign
2.29 Finance and Public Disclosure Board to develop online training capabilities for campaign
2.30 treasurers. This is a onetime appropriation."


