A consumer-owned 5.23 utility may elect to carry forward energy savings in excess of 1.5 percent for a year to the 5.24 next three years, except that energy savings from electric utility infrastructure projects may 5.25 be carried forward for five years. A particular energy savings can only be used to meet one 5.26

5.27 year's goal.

(c) A consumer-owned utility subject to this section is not required to make energy
conservation improvements that are not cost-effective, even if the improvement is necessary
to attain the energy-savings goal. A consumer-owned utility subject to this section must
make reasonable efforts to implement energy conservation improvements that exceed the
minimum level established under this subdivision if cost-effective opportunities and funding

are available, considering other potential investments the consumer-owned utility intends
to make to benefit customers during the term of the plan filed under subdivision 3.

6.3 (d) Notwithstanding any provision to the contrary, until July 1, 2026, spending by a
6.4 consumer-owned utility subject to this section on efficient fuel-switching improvements

  6.32 commissioner may make recommendations to a consumer-owned utility regarding ways to

increase the effectiveness of the consumer-owned utility's energy conservation activities
and programs under this subdivision. The commissioner may recommend that a
consumer-owned utility implement a cost-effective energy conservation or efficient
<u>fuel-switching program, including an energy conservation program suggested by an outside</u>
source such as a political subdivision, nonprofit corporation, or community organization.
(e) Beginning June 1, 2023, and every June 1 thereafter, each consumer-owned utility

must file: (1) an annual update identifying the status of the plan filed under this subdivision,
including: (i) total expenditures and investments made to date under the plan; and (ii) any
intended changes to the plan; and (2) a summary of the annual energy-savings achievements
under a plan. An annual filing made in the last year of a plan must contain a new plan that
complies with this section.

(f) When evaluating the cost-effectiveness of a consumer-owned utility's energy
conservation programs, the consumer-owned utility and the commissioner must consider
the costs and benefits to ratepayers, the utility, participants, and society. The commissioner
must also consider the rate at which the consumer-owned utility is increasing energy savings
and expenditures on energy conservation, and lifetime energy savings and cumulative energy
savings.

(g) A consumer-owned utility may annually spend and invest up to ten percent of the
 total amount spent and invested on energy conservation, efficient fuel-switching, or load
 <u>management</u> improvements on research and development projects that meet the <u>applicable</u>
 definition of energy conservation, efficient fuel-switching, or load management improvement.

(h) A generation and transmission cooperative electric association or municipal power
agency that provides energy services to consumer-owned utilities may file a plan under this
subdivision on behalf of the consumer-owned utilities to which the association or agency
provides energy services and may make investments, offer conservation programs, and
otherwise fulfill the energy-savings goals and reporting requirements of this subdivision
for those consumer-owned utilities on an aggregate basis.

(i) A consumer-owned utility is prohibited from spending for or investing in energy
conservation improvements that directly benefit a large energy facility or a large electric
customer facility the commissioner has exempted under section 216B.241, subdivision 1a.

(j) The energy conservation and optimization plan of a consumer-owned utility may
include activities to improve energy efficiency in the public schools served by the utility.
These activities may include programs to:

The requirement under this 9.11 paragraph applies to each generation and transmission cooperative association's aggregate 9.12

9.13 gross operating revenue from the sale of electricity to residential customers in Minnesota9.14 by all of the association's member distribution cooperatives.

(b) To meet all or part of the spending requirements of paragraph (a), a consumer-owned 9.15 utility may contribute money to the energy and conservation account established in section 9.16 216B.241, subdivision 2a. An energy conservation optimization plan must state the amount 9.17 of contributions the consumer-owned utility plans to make to the energy and conservation 9.18 account. Contributions to the account must be used for energy conservation programs serving 9.19 low-income households, including renters, located in the service area of the consumer-owned 9.20 utility making the contribution. Contributions must be remitted to the commissioner by 9.21 February 1 each year. 9.22

(c) The commissioner must establish energy conservation programs for low-income 9.23 households funded through contributions to the energy and conservation account under 9.24 paragraph (b). When establishing energy conservation programs for low-income households, 9.25 the commissioner must consult political subdivisions, utilities, and nonprofit and community 9.26 organizations, including organizations providing energy and weatherization assistance to 9.27 low-income households. The commissioner must record and report expenditures and energy 9.28 9.29 savings achieved as a result of energy conservation programs for low-income households funded through the energy and conservation account in the report required under section 9.30 216B.241, subdivision 1c, paragraph (f). The commissioner may contract with a political 9.31 subdivision, nonprofit or community organization, public utility, municipality, or 9.32 consumer-owned utility to implement low-income programs funded through the energy and 9.33 conservation account. 9.34

(d) A consumer-owned utility may petition the commissioner to modify the required
 spending under this subdivision if the consumer-owned utility and the commissioner were
 unable to expend the amount required for three consecutive years.

(e) The commissioner must develop and establish guidelines for determining the eligibility 10.4 of multifamily buildings to participate in energy conservation programs provided to 10.5 low-income households. Notwithstanding the definition of low-income household in section 10.6 10.7 216B.2402, a consumer-owned utility or association may apply the most recent guidelines 10.8 published by the department for purposes of determining the eligibility of multifamily buildings to participate in low-income programs. The commissioner must convene a 10.9 stakeholder group to review and update these guidelines by August 1, 2021, and at least 10.10 once every five years thereafter. The stakeholder group must include but is not limited to 10.11 representatives of public utilities; municipal electric or gas utilities; electric cooperative 10.12 associations; multifamily housing owners and developers; and low-income advocates. 10.13

(f) Up to 15 percent of a consumer-owned utility's spending on low-income energy
conservation programs may be spent on preweatherization measures. A consumer-owned
utility is prohibited from claiming energy savings from preweatherization measures toward
the consumer-owned utility's energy savings goal.

(g) The commissioner must, by order, establish a list of preweatherization measures
eligible for inclusion in low-income energy conservation programs no later than March 15,
2022.

(h) A Healthy AIR (Asbestos Insulation Removal) account is established as a separate 10.21 account in the special revenue fund in the state treasury. A consumer-owned utility may 10.22 elect to contribute money to the Healthy AIR account to provide preweatherization measures 10.23 for households eligible for weatherization assistance from the state weatherization assistance 10.24 program in section 216C.264. Remediation activities must be executed in conjunction with 10.25 10.26 federal weatherization assistance program services. Money contributed to the account by a consumer-owned utility counts toward: (1) the minimum low-income spending requirement 10.27 under paragraph (a); and (2) the cap on preweatherization measures under paragraph (f). 10.28 Money in the account is annually appropriated to the commissioner of commerce to pay for 10.29 Healthy AIR-related activities. 10.30

(i) Where a low-income household receives the household's primary heating fuel from
 an entity other than a utility subject to section 216B.241, the consumer-owned utility
 providing electric service to the household may meet all or part of the consumer-owned
