Subdivision 1. **Leases.** The commissioner may issue leases to prospect for, mine, and remove <u>or extract gas</u>, <u>oil</u>, <u>and minerals other than iron ore <del>upon from from the fr</u></del>

Sec. 2. Minnesota Statutes 2022, section 93.25, subdivision 2, is amended to read:

Subd. 2. **Lease requirements.** All leases for nonferrous metallic minerals or petroleum, gas, or oil must be approved by the Executive Council, and any other mineral lease issued pursuant to this section that covers 160 or more acres must be approved by the Executive Council. The rents, royalties, terms, conditions, and covenants of all such leases shall must be fixed by the commissioner according to rules adopted by the commissioner, but no lease shall be for a longer term than 50 years, and all rents, royalties, terms, conditions, and covenants shall must be fully set forth in each lease issued. No nonferrous metallic mineral lease shall be canceled by the state for failure to meet production requirements prior to the 36th year of the lease. The report must identify geologic carbon sequestration opportunities and include recommendations on statutory and policy changes that govern any geologic carbon sequestration activity while benefiting the people of Minnesota and adequately protecting the state's natural resources.
- (b) The commissioner of natural resources must appoint a Geologic Carbon Sequestration

  Technical Advisory Committee to advise on the preparation of the report required by

  paragraph (a). The commissioner may appoint representatives from the following entities

  to the technical advisory committee:
