1.5 Section 1. Laws 2022, chapter 42, section 2, is amended to read:

1.6 Sec. 2. **APPROPRIATION; ALS RESEARCH.**

1.7 (a) ~~\$20,000,000~~ \$396,000 in fiscal year 2023 is appropriated from the general fund to
1.8 the commissioner of the Office of Higher Education to award competitive grants to applicants
1.9 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with
1.10 the Minnesota Department of Health to administer the grant program, including identifying
1.11 clinical and translational research and innovations, developing outcomes and objectives
1.12 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,
1.13 and application review and grant recipient selection. Not more than \$400,000 may be used
1.14 by the commissioner to administer the grant program. This is a onetime appropriation.
1.15 Notwithstanding Minnesota Statutes, section 16A.28, unencumbered balances under this
1.16 section do not cancel until June 30, 2026.

1.17 (b) \$19,604,000 in fiscal year 2024 is appropriated from the general fund to the
1.18 commissioner of the Office of Higher Education to award competitive grants to applicants
1.19 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with
1.20 the Minnesota Department of Health to administer the grant program, including identifying
1.21 clinical and translational research and innovations, developing outcomes and objectives
1.22 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,
1.23 and application review and grant recipient selection. Up to \$15,000,000 may be used by the
1.24 commissioner for grants to the Amyotrophic Lateral Sclerosis Association, Never Surrender,
1.25 or other similar organizations to award and administer a competitive grant to applicants for
1.26 research into ALS under this section. This is a onetime appropriation. Notwithstanding
1.27 Minnesota Statutes, section 16A.28, unencumbered balances under this section do not cancel

1.30 ALS. Research topics may include but are not limited to environmental factors, disease

2.1 (e) (d) Eligible applicants for the grants are research facilities, universities, and health
 2.2 systems located in Minnesota. Applicants must submit proposals to the commissioner in
 2.3 the time, form, and manner established by the commissioner. Applicants may coordinate
 2.4 research endeavors and submit a joint application. When reviewing the proposals, the
 2.5 commissioner shall make an effort to avoid approving a grant for an applicant whose research
 2.6 is duplicative of an existing grantee's research.

2.17 (a) \$15,000,000 in fiscal year 2024 and
 2.18 \$15,000,000 in fiscal year 2025 are to: (1)
 2.19 increase the medical school's research
 2.20 capacity; (2) improve the medical school's
 2.21 ranking in National Institutes of Health
 2.22 funding; (3) ensure the medical school's
 2.23 national prominence by attracting and
 2.24 retaining world-class faculty, staff, and
 2.25 students; (4) invest in physician training
 2.26 programs in rural and underserved

3.17 (e) \$5,000,000 in fiscal year 2024 and

4.24 Sec. 3. **APPROPRIATION; KIDS ON CAMPUS INITIATIVE.**

4.25 \$500,000 in fiscal year 2025 is appropriated from the general fund to the Board of
 4.26 Trustees of the Minnesota State Colleges and Universities to participate in the Kids on
 4.27 Campus initiative with the National Head Start Association and the Association of
 4.28 Community College Trustees. This appropriation may be used for a temporary statewide
 4.29 project coordinator, stipends to parenting students, engaging with local Head Start programs,
 4.30 and for other costs associated with creating campus Head Start partnerships. The duties of
 4.31 the temporary statewide project coordinator include assessing the feasibility of partnerships
 4.32 between Minnesota State Colleges and Universities campuses and Head Start programs
 4.33 across the state, consulting with the Minnesota Head Start Association and existing Head
 4.34 Start partnership programs to develop best practices, working with campus-based navigators

5.8 Section 1. [135A.062] CONSIDERATION OF CRIMINAL RECORDS LIMITED.

5.9 Subdivision 1. **Applicability.** This section applies to postsecondary institutions under
5.10 section 136A.155, except the Board of Regents of the University of Minnesota is requested
5.11 to comply with this section.

5.12 Subd. 2. **Definition.** As used in this section "a violent felony or sexual assault" includes
5.13 a felony-level violation or attempted violation of section 609.185; 609.19; 609.195; 609.20;
5.14 609.221; 609.2242, subdivision 4; 609.2247; 609.245, subdivision 1; 609.247, subdivision
5.15 2; 609.282; 609.322; 609.342; 609.343; 609.344; 609.345; 609.3451; 609.3458; 609.561,
5.16 subdivision 1 or 2; 609.582, subdivision 1; 609.66, subdivision 1e; or 609.749.

5.17 Subd. 3. **Consideration of criminal records limited.** A postsecondary institution may
5.18 not inquire into, consider, or require disclosure of the criminal record or criminal history
5.19 of an applicant for admission. After a postsecondary institution has made an offer of
5.20 admission, the postsecondary institution may inquire into, consider, or require disclosure
5.21 of a conviction that occurred within the previous five years for a violent felony or sexual
5.22 assault. The postsecondary institution must provide the applicant with an opportunity to
5.23 submit an explanatory statement, letters of recommendation, evidence of rehabilitation, and
5.24 any other supporting documents. The institution must provide clear and detailed instructions
5.25 and guidance to applicants related to what criminal history requires disclosure. The institution
5.26 must not require the applicant to provide official records of criminal history. A postsecondary
5.27 institution that rescinds an offer of admission must:

5.28 (1) provide an explanation of the basis for the decision to rescind the offer of admission;
5.29 and

5.30 (2) provide the applicant with an opportunity to appeal the decision to rescind.

5.31 Subd. 4. **Other information.** This section shall not prohibit or limit a postsecondary
5.32 institution from inquiring about student conduct records at the applicant's prior postsecondary
5.33 institution after making an offer of admission. This section shall not prohibit or limit a

6.1 postsecondary institution from inquiring about a student's ability to meet licensure
6.2 requirements in a professional program after making an offer of admission.

6.3 Subd. 5. **Limitation on admissibility.** (a) A postsecondary institution that complies
6.4 with this section is immune from liability in a civil action arising out of the institution's
6.5 decision to admit a student with a criminal history or the institution's failure to conduct a
6.6 criminal background check.

6.7 (b) Nothing in this section creates or establishes a legal duty upon a postsecondary
6.8 institution to inquire into or require disclosure of the criminal history or criminal convictions
6.9 of a student or an applicant for admission.

6.10 Sec. 2. Minnesota Statutes 2022, section 136A.69, subdivision 1, is amended to read:

6.11 Subdivision 1. **Registration fees.** (a) The office shall collect reasonable registration fees
6.12 that are sufficient to recover, but do not exceed, its costs of administering the registration
6.13 program. The office shall charge the fees listed in paragraphs (b) ~~and (c)~~ to (d) for new
6.14 registrations.

6.15 (b) A new school offering no more than one degree at each level during its first year
6.16 must pay registration fees for each applicable level in the following amounts:

7.21 persons who have self-identified as federal student aid borrowers. The commissioner of

7.23 commissioner of corrections, in consultation with the commissioner of higher education,
7.24 shall develop a plan by December 1, 2024, to assist incarcerated persons in enrolling in a
7.25 federal income-driven repayment plan in which there are no monthly payments or accrual

8.18 Subd. 2. **Renewal licensure fee; late fee.** (a) The office processing fee for a renewal
8.19 licensure application is:

8.20 (1) for a private career school that offers one program, the license renewal fee is \$1,150;

8.21 (2) for a private career school that offers more than one program, the license renewal
8.22 fee is \$1,150, plus \$200 for each additional program with a maximum renewal licensing
8.23 fee of \$2,000;

8.24 (3) for a private career school licensed exclusively due to the use of the term "college,"
8.25 "university," "academy," or "institute" in its name, the license renewal fee is \$750; and

8.26 (4) for a private career school licensed by another state agency and also licensed with
8.27 the office exclusively in order to participate in state student aid programs, the license renewal
8.28 fee is \$750.

8.29 (b) If a license renewal application is not received by the office by the close of business
8.30 at least 60 days before the expiration of the current license, a late fee of \$100 per business
8.31 day, not to exceed \$3,000, shall be assessed.

9.13 The commissioner may not enter into an agreement or establish a prison education
9.14 partnership with a higher education institution that:

9.15 (1) is organized as a private for-profit postsecondary institution as described in section
9.16 136A.62, subdivision 3, clause (2), item (ii); or

9.17 (2) charges incarcerated students a higher per-credit rate than the rate for nonincarcerated
9.18 students.

9.19 **Sec. 7. [244.60] SUPERVISED RELEASE EMPLOYMENT REQUIREMENT;**
9.20 **POSTSECONDARY EDUCATION.**

9.21 If the commissioner of corrections imposes a requirement on a person placed on
9.22 supervised release that the person work or be employed, the commissioner shall provide
9.23 that enrollment and participation in postsecondary education satisfies this requirement.
