Bill Description

Article 1, sections 1-2 make conforming changes to M.S. 144E.001 to define the Office of Emergency Medical Services (Office) and the director of the office.

Section 3 establishes the Office, effective January 1, 2025, specifies the governor must appoint a director for the Office with the advice and consent of the Senate, enumerates the powers and duties of the Office, stipulates the director may employ personnel as necessary, and provides the director must prepare a work plan to guide the office.

Section 4 establishes a Medical Services Division within the Office. This division shall be under the supervision of a deputy director appointed by the director. The deputy director of this division must be a physician licensed under chapter 147. This section is effective January 1, 2025.

Section 5 establishes an Ambulance Services Division within the Office. This division shall be under the supervision of a deputy director appointed by the director. This section is effective January 1, 2025.

Section 6 establishes the Emergency Medical Services Providers Division within the Office. This division shall be under the supervision of a deputy director appointed by the director. This section is effective January 1, 2025.

Section 7 establishes the Emergency Medical Services Advisory Council, defines membership, appointing bodies, terms, compensation, election of officers, meeting frequency requirements, and duties. This section is effective January 1, 2025.

Section 8 establishes the Emergency Medical Services Physician Advisory Council, defines membership, appointing bodies, terms, compensation, election of officers, meeting frequency requirements, and duties. This section is effective January 1, 2025.

Section 9 establishes the Labor and Emergency Medical Service Providers Advisory Council, defines membership, appointing bodies, terms, compensation, election of officers, meeting frequency requirements, and duties. This section is effective January 1, 2025.

Section 10 establishes an Alternative EMS Response Model Pilot Program, effective August 1, 2024. The program transfers from the Emergency Medical Services Regulatory Board (Board) to the office effective January 1, 2025.

Sections 11-18 make conforming changes to M.S. 144E to replace references to the Board with references to the Office. These sections are effective January 1, 2025.

Sections 19-21 provide initial terms and first meeting dates for the Councils specified in sections 7-9.

Section 22 directs the transfer of responsibilities from the Board to the Office and provides for the initial appointment of the office director.

Section 23 appropriates \$6,000,000 in fiscal year 2025 from the general fund to the Board for the pilot program established in section 10. This one-time appropriation is available until June 30, 2026.

Section 24 instructs the revisor of statutes to make certain conforming changes.

Section 25 repeals the Board as established in M.S. 144E.

Article 2 makes conforming statute changes.

Assumptions

It is assumed that all of the duties and responsibilities of the Emergency Medical Services Regulatory Board (Board) will be transferred to the Office of Emergency Medical Services (Office) on January 1, 2025.

It is assumed that pursuant to M.S. 15.039, all classified and unclassified positions associated with the responsibilities being transferred are transferred with their incumbents to the new Office effective January 1, 2025. Because the current executive director position is compensated similarly to Group I agency heads, it is assumed that the governor-appointed Office director will be compensated at the same rate as the current Board-appointed executive director.

It is assumed that the governor will appoint a director-designee by October 1, 2024 and the appointment will become effective January 1, 2025.

It is assumed that the Board will cease to meet after January 1, 2025, and that all board member-related costs such as travel expenses and per diems will no longer be incurred. This cost reduction is offset by per diems and reimbursements for the EMS Advisory Council and EMS Physician Advisory Council (discussed further below).

Per diems and reimbursements are assumed for the Labor and Emergency Medical Service Providers Advisory Council. It is assumed this council meets quarterly and is comprised of 13 public members.

It is assumed the proposed councils will use the meeting space that is currently used by the Board.

It is assumed that council members will be compensated as provided in Minnesota Statutes 15.059 (Advisory Councils and Committees).

It is assumed that two existing staff performing duties similar to those outlined for the Deputy Director of the Ambulance Services Division and Deputy Director of the EMS Providers Division will be reclassified as deputy directors, while the deputy director of the Medical Services Division would be a new hire. Office and IT equipment, supplies, training, and travel costs are assumed for the new deputy director hire. It is assumed that there is sufficient existing office space and furniture to accommodate the new hire.

It is assumed that the new deputy director hire will begin employment on April 1, 2025.

It is assumed that the reclassification of two existing staff to deputy directors will be effective February 1, 2025.

Costs for the first six months of the pilot program described in article 1, section 10 are shown on the Board fiscal note; costs for the second half of fiscal year 2025 and fiscal year 2026 are shown on this fiscal note. It is estimated that the appropriation specified in article 1, section 23 would fund 3-5 pilot programs depending on geography and participants.

Expenditure and/or Revenue Formula

Advisory Councils

Current Board member costs and proposed EMS Advisory Council and EMS Physician Advisory Council member costs are assumed to offset based on a four-year average of member costs provided by Board staff and an estimate of

Council/Committee member costs based on M.S. 15.059 developed by Legislative Budget Office (LBO) staff. Depending on Council/Committee compensation and reimbursement claim rates, there may be a slight cost or savings difference between the current Board and proposed councils.

Per diem and reimbursement costs for the Labor and Emergency Medical Service Providers Advisory Council are estimated below, based on M.S. 15.059.

Bill Description

This bill would create a new state Office of Emergency Medical Services. It would transfer all existing duties and responsibilities from the existing Emergency Medical Services Regulatory Board to the newly created Office of Emergency Medical Services to be effective on January 1, 2025. This office would be operated under an office director as appointed by the Governor. As amended in this engrossment the bill calls for the appointment of three deputy directors, to be appointed by the Director. A Deputy Director of the established Medical Services Division, whom must be a Minnesota licensed physician under chapter 147, A Deputy Director of the established Ambulance Services Division, and a Deputy Director of the established Emergency Medical Service Providers Division.

The bill also creates an alternate EMS response model, that would allow an advanced life support ambulance service to partner with one or more basic life support ambulances to provide higher levels of care while also providing staffing support to BLS ambulances that may be facing staffing challenges and assist ALS ambulance services in expanding their call volume. The pilot seeks to determine if such a model leads to a more sustainable EMS system in portions of rural Minnesota. An appropriation of \$6,000,000 is included. The pilot program expires on June 30, 2026.

Assumptions

This analysis assumes that the agency transfer would take place in accordance with the provisions of M.S.15.039 as highlighted in the bill and that all assets funding and personnel would be transferred to the newly created Office as would all existing obligations including existing grants, contracts and obligations.

It is beyond the scope of the EMSRB to project potential costs of the newly established office.

The assumption for this fiscal analysis for the pilot projects is limited to the first six months of the program. A minimum of 60 days would be required to solicit grant proposals in accordance with procurement rules. There is the potential for variation to expenses depending on how many proposals are received and how many areas of the state wish to and have the capacity to participate.

EMSRB estimates 200 hours of staff time to generate, disseminate, and review initial project proposals in accordance with state procurement policy. This figure could increase in the event of multiple competitive proposals for the same geographic area.

It is assumed that for days 90-180 that up to 4 pilot models could be in operation. Estimates for the initial year cost would be a \$400,000 - \$500,000 grant for each unit placed into service. For the purposes of this analysis a yearly cost of \$500,000 is identified.

Expenditure and/or Revenue Formula

The bill identifies that all responsibilities will be transferred as of 01/01/2025. This would be the exact halfway point through FY25. Transfer outs were calculated at 50% of the FY25 appropriations to the Board.

The base general fund (1000) appropriation for EMSRB for FY25 is \$6,176,000, 50% is \$3,088,000.

For fund 2000 that comprises seatbelt relief pass through funding to the EMS regions, this funding could fluctuate based on calculations from the Department of Public Safety. The FY24 budgeted figures of \$141,750 was used as a base, 50% of this amount, or \$70,875 was accounted for and transferred. Fees for fulfilling data collection is also included in fund 2000, the full existing cash balance of \$131,705 is transferred.

Fund 2043 is a restricted gifts fund, the full cash balance of \$10,548 is transferred.

Fund 3000 refers to the Emergency Medical Services for Children Grant which is passed through to grantees. Estimated amounts for EMSC funding are at \$80,000 for FY2025 due to budget uncertainties with the federal government, 50% or \$40,000 is transferred.

Total amount transferred out in FY25 is \$3,341,128, this would be in addition to any funding carried forward from FY24 to FY25 in accordance with state biennium budgeting procedures.

With the appropriation identified in section 23 up to a maximum of \$600,000 is available for FY25 for grants administration and oversight pursuant to Minnesota Statute 16B.98 subdivision 14. Any unexpended balance would be transferred to the new office subject to M.S. 15.039.

These amounts reference transfers to the new entity and do not reflect actual costs to state government and are provided for informational purposes.

Costs associated with procurement and grant review-- \$12,000 200 hours at \$60.00 per hour.

Related to the pilot program

Up to 4 project pilot ALS grants for 90 days of coverage-- \$500,000

The number of staffed vehicles provided for under each pilot project could vary, and some projects could come online sooner based on established interest. An estimated additional \$188,000 in costs could be incurred based on timing of project implementation.

Long-Term Fiscal Considerations

This program is slated to sunset on June 30, 2026. If the pilot achieves its desired objectives, there may be a desire to continue it. It is possible that those long-term costs could go up or go down, funding from other sources such as local government units is a possibility. It is unlikely that participating ambulance services would be able to continue to provide these services with out dedicated funding.

Bill Description

The bill establishes, in part, an Office of Emergency Medical Services effective Jan 1, 2025. The governor will appoint the director of the office with the advice and consent of the senate. The Emergency Medical Services Regulatory Board is repealed.

The bill also establishes an Emergency Medical Services Advisory Council which includes one representative and one senator as council members. The bill states that legislative members may receive per diem and reimbursement of expenses according to their body's adopted rules. The advisory council's first meeting must convene by Feb 1, 2025, and must meet at least guarterly thereafter. The council does not expire.

Assumptions

- The cost of the establishment and ongoing operations of the Office of Emergency Medical Services and the nonlegislative member meeting participation cost of the Emergency Medical Services Advisory Council and the Emergency Medical Services Physician Advisory Committee will be addressed in the fiscal note for "Emergency Medical Services Office Proposed".
- 2. The Senate will confirm the governor's appointment of the director of the Office of Emergency Medical Services during one of its floor sessions held during a regular legislative session. No additional funds will be needed.
- The Emergency Medical Services Regulatory Board is to be repealed under the bill. The current board does have two ex officio non-voting legislative members. Typically, ex officio members serve without compensation or reimbursement of their expenses.
- 4. The Emergency Medical Services Advisory Council will meet quarterly starting Feb 1, 2025. Two meetings will occur in FY25 with neither of the meetings being held during legislative interim. Four meetings will occur in FY26 with three meetings being held during legislative interim. Four meetings will be held in FY27 with two meetings being held during legislative interim. For this note we assume that all meetings will be held within the Capitol campus.
- 5. The bill states that legislative members (one representative, one senator) may receive payment of per diems and reimbursement of expenses for their participation in the council meetings, New funds will be needed for the House and Senate.
- 6. Legislative member meeting participation costs includes the following per member, per legislative interim meeting: per diem (\$86 senators, \$86 representatives), and \$102 round trip mileage (152 round trip mile average). Half of the legislative members will be reimbursed for lodging expenses (\$150/night senators, \$175/night representatives).
